Further to minute 38 dated 12 March 2013, Louise Graham, Voluntary and Community Sector Grants Team Programme Manager, presented the item which included a brief PowerPoint presentation, which was submitted to the online agenda following the meeting.

The Area Based Grants scheme is due to commence on 1 July 2013 and is intended to run for two years and nine months. It was proposed that the Area Committee monitor the progress and operation of Lead Organisations (The Renewal Trust) at twice yearly intervals, starting from the next meeting of the Committee.

9 AREA CAPITAL FUND -2013-2015

Fi Cusick, Neighbourhood Development Officer, presented the report and circulated a revised appendix which was which was submitted to the online agenda following the meeting

Greg Foister, Neighbourhood Development Officer responded to a concern about the removal of speed bumps on Greenwood Road despite the planned renewal of the playground there He Informed the Committee that a meeting is being held on 29 May which will look at this and other issues, and that the outcome could be fed back to the Committee.

Inspector Allardice commented that the Police are undertaking anti-speeding operations in the area, and that he would discuss the issue with Superintendent Hunter and feed back to Greg regarding any Police action which could be held near to the site.

Citizens were concerned that £30,000 of St Ann's Public Realm funding is to be allocated to the regeneration of the Forest Recreation Ground. Colleagues responded that this is because the park borders on the Ward and surveys of people using the park had provided evidence that significant numbers of St Ann's' residents use the Forest Recreation Ground.

11 WARD PERFORMANCE - QUARTER 4

The report included a brief summary of the performance information on each of the following key themes:

- Ward Priorities
- o Community Engagement
- o Finance
- o Safer
- Neighbourhood

Greg Foister, Neighbourhood Development Officer (NDO) for Dales Ward, highlighted the following points:

- a) performance was generally doing well across all areas in the ward but there were still improvements to be made;
- b) partners plan to meet in advance of the summer holidays to try and predict potential issues so that, where feasible, action can be taken to prevent problems arising;
- c) an increase in environmental issues such as dog fouling, needle hot spots and antisocial behaviour (ASB). He had requested base line data to enable a like-for like comparison;
- d) a dip in the cleanliness figures which was attributed to staffing levels and failed machinery which are both being addressed;
- e) an environmental week of action is planned for 9 September 2013 and further information will be distributed nearer the time;
- f) further work is to be done with the Police to help identify local policing priorities.

Fi Cusick, NDO for Mapperley Ward, highlighted the following points:

- g) crime continued on a downward trend and is predicted to fall further following the custodial sentencing of a prolific auto crime offender;
- h) ASB had been a specific issue with hot spots on the Wells Road and Woodlane Gardens, but this is to be further investigated;
- i) the latest cleanliness statistics had increased from 90% to 95% on the cleanliness index;
- work is underway to encourage residents to raise or report issues of concern in the area;

 Inspector Simon Alladice reassured the Committee that although there appeared to have been 26 more crimes, this was a reflection of the 12 on-going investigations regarding the Children's Home which dated back decades. In addition, there had been 8 shoplifting incidents at Sainsbury's.

Michelle Graley, NDO for St Ann's Ward, highlighted the following points:

- although overall crime statistics were lower than the same time last year, there had generally been an upward trend in Anti-Social Behaviour and St Ann's now ranked the ward with the second highest proportion of reported ASB (mainly noise related) across the 20 wards of the City;
- m) personal robbery and violent crime, including domestic violence had increased, with domestic violence being the highest City rate;
- n) a week of action had been held on 18 March 2013 and targeted a range of issues. Partners, including Nottingham City Homes, worked together to identify possible actions to improve the aesthetics of the area. As a result, a hanging basket/window box workshop was proposed;
- some of the wheelie bins on Ransom Road and even numbered homes on Chandos Street had been left on the street as a result of a steep slope to the rear of the properties. Colleagues and the Regeneration Team are currently looking into various options to look for a solution to the bin issues;
- p) there had been a spate of dog fouling on Marmion Park and King Edward Park and action is being taken on both sites.

Citizens attending the meeting raised concerns that pedestrians and local residents found the street drinkers who gathered outside the book makers near to The Chase, intimidating and disruptive. Dorothy Holmes, South Locality Manager, informed the Committee that street pastors had been working to direct the drinkers to relevant services and that the Police were aware. Inspector Allardice informed the Committee that he would make colleagues aware of the concerns raised although he was aware that regular patrols passed through the area and discussion had already taken place with relevant individuals.

Councillor David Mellen informed the Committee that Dales currently had the highest rate of unemployment across the three wards of the area. However, following work with the Renewal Trust, the Economic Development Team and other partners, including Jobcentre Plus, a Jobs Fair for local people has been arranged for 1 July 2013 between 10am and 3pm on the square outside Victoria Leisure Centre. There was to be a Job Shop offering help producing CVs, and New College Nottingham and St Ann's Advice Centre will attend. Local businesses and employers which were recruiting to jobs and apprenticeships had been invited and there will be information and advice to local businesses on the benefits of employing local people, how they can benefit from establishing apprenticeships, and details of the Nottingham Jobs fund. A dedicated free bus service would ensure that citizens living in the Mapperley Ward will be able to attend the event.

Information on the Jobs Fair will be handed to every claimant of Job Seekers Allowance in the area who attended their fortnightly review meeting at the Job Centre, however, if people from other areas attended they would not be turned away.

Citizens emphasised the need for people offering advice to have knowledge of Nottingham and its communities.

It was noted that all entry level jobs at the City Council were targeted at local people.

Citizens were disappointed to hear that the contractor building the Nottingham City Homes properties by the Windmill, will not be employing local workers. Dorothy Holmes offered to look into this and report back to the Committee.
