Progress through authorisation per wave




As of today:

The Final Evidence Report (FER)

Is based on the CCG's site visit report (SVR) but also includes the CCG's 'considered response' to the SVR

Is finalised by the Key Assessor (KA)

Summarises the assessment that has been completed thus far

Provides a structured analysis of root cause, risk & local context

Reflects any comments made by the applicant CCG on their assessment



Authorisation outcomes

Authorised:	The CCG has demonstrated to the NHS CB that it satisfies all the requirements for authorisation. A list of the powers and duties that a fully authorised CCG will have from April 2013 are set out in <i>The functions of CCGs</i> . The CCG will be invited to agree a development plan consistent with the potential beyond authorisation set out in the guide for applicants.
Authorised with conditions:	If the CCG has not fully satisfied the NHS CB that it meets all the thresholds for authorisation, the Board may give it conditional authorisation by setting conditions or directing the CCG as to how it carries out any of its functions. Conditions or directions will be specific to the particular criteria that have not been satisfied, and proportionate to the level of risk associated with the relevant function.
Established but not authorised:	Legally these CCGs are established 'with conditions' but where the conditions are such that it cannot be described as authorised to take on its functions as a CCG. The NHS CB will make alternative arrangements for commissioning for that population until the shadow CCG is ready to move forward to authorisation.



The Moderation panel

Reviews the un-moderated conclusions of authorisation assessment

Considers whether the authorisation thresholds have been consistently applied

Looks at the results across the wave and between waves and considers whether they are consistent

Can moderate a red criterion to green or vice versa



Condition setting

Prior to the application being put before the Conditions Panel, the authorisation governance team will:

 Draw-up the proposed conditions (including where required drafting bespoke conditions)

 Discuss the proposed conditions and support options with relevant regional directors.

Record the outcome of this discussion to be reported to the Conditions Panel.



The Conditions panel

Considers what conditions should be applied for each CCG

 Matches any conditions applied with an offer of support (choosing from 7 support options set out by the Board)

Where intensive support is indicated, considers whether the CCG should be authorised with conditions or authorised as a shadow CCG

Does not review decisions made by the Moderation Panel



CCG review of proposed conditions

CCGs have 10 working days to review proposed conditions

CCGs may indicate why they consider some/all proposed conditions no longer required

CCGs may provide additional evidence

CCG response is reviewed by regional director for ops & delivery

Recommendation to sub-committee as to whether CCG response supports proposed condition no longer being required



Support options

Where it is decided that a CCG with conditions needs support, the NHS CB can select from the following options:

i. Model document / toolkit		
ii. Make advice / expertise available		
iii. Decision sign off / approval by the board		
iv. Insert / provide specific team / individual		
v. Accountable Officer (AO) not ratified / alternative AO appointed		
vi. Specific functions removed		
vii All functions removed		

Within the support packages for iii-vii, the specifics would be determined for each occasion they were used.



CCG authorisation sub-committee

Non-statutory sub-committee with full delegated authority from the NHS CB to make decisions on authorisation

Considers the recommendations of the moderation and conditions panels

Receives assurance and provides assurance of the quality and rigour of the decision-making process

Makes the decision to authorise aspiring CCGs in each wave

Communicates the outcome of its deliberations to all applicant CCGs

Considers and approves or rejects the recommendation that a proposed condition is no longer required
