6 <u>MINUTES</u>

RESOLVED that the minutes of the last meeting held on 19 February 2010, copies of which had been circulated, be confirmed and signed by the Chair.

7 CHAIR'S ANNOUNCEMENTS

The Chair informed the Authority that he had received a personal audience with Princess Anne on HMS Belfast as a result of his work with the Firefighter's Charity.

Congratulations were passed to:

- Councillor Griggs for her City Council appointment as Sheriff of Nottingham;
- Councillor Grocock for his appointment as Lord Mayor of Nottingham City Council;
- Councillor Pettengell for his appointment as Chair of Nottinghamshire County Council, especially as he had named the Fire Fighter's Charity as the Chair's chosen charity.

It was hoped that with three such high profile members of the Authority, the profile of the Service would be raised.

The Chair had attended a meeting of the Safer Nottingham Board which had discussed the initiative 'Arrow' which aimed to improve police performance. During the event, a Police Officer informed Councillor Pulk of the praise worthy fire prevention and safety work being undertaken by firefighter Richard Cropley who was based at Ashfield Station. The Chief Fire Officer was to send a letter of acknowledgment to Mr Cropley.

The Chair had visited the Regional Control Centre and work continued with the Regional Management Board, including work streams on the Regional Control Centre and Work Force Development.

Councillor Carroll had accompanied the Chair during visits to Highfield and Ashfield stations. Councillors were encouraged to visit and attend events at stations. If they did not have contact names for officers at the stations then councillors could contact the Chief Fire Officer's Personal Assistant who would provide the information.

The Chair had attended the annual memorial service at the National Arboretum in Staffordshire where a monolith was inscribed with all the names of firefighters who had lost their lives in service since the Second World War.

A 'passing-out' parade had taken place at Ollerton and was attended by Councillors Wheeler and the Chair who found it interesting and encouraging, especially as it was said that the results of the officers were particularly impressive and two of the ten officers were women.

It was noted that Bob Neill MP had been appointed as the new Fire Minister.

Financial restrictions and a cut of 5-10% were predicted to affect the Authority, particularly as an effect of the freeze in council tax and the requirement to publish any spending of \pm 500 and above. Collaborative working would be required to ensure that front-line services were not affected.

Finally the Chair informed the Authority of a 'ladies' driving challenge' event which was to be held on 12 September 2010 at Newark Showground in aid of the Firefighters Charity, and encouraged councillors to promote the event and, where appropriate, become involved.
