1. BACKGROUND

- 1.1 The Local Government Association organises an annual conference for Fire and Rescue Authorities. This event has now become a major event in the 'fire' calendar. Previous themes for the conference have included "Making Connections Solutions for our Communities", "Forward Together", "Fire and Rescue in 2017: Rising to the Challenge" and "Building Resilience: Responding to Environmental Change."
- 1.2 At its meeting in February 2011, the Fire Authority approved attendance at this conference for the Chair to accompany the Chief Fire Officer.

2. REPORT

- 2.1 The Local Government Association Fire and Rescue Conference 2011 took place from Tuesday 8 March Wednesday 9 March 2011 and was held at the Hilton Hotel in Gateshead.
- 2.2 The theme of the conference was "The Future of Fire". The programme for the two days covered a range of topics of interest to the fire community with particular focus on current and future issues in the fire and rescue service, meeting future challenges, and what will be done regarding poorly performing fire authorities.
- 2.3 Speakers were drawn from both within and outside the fire community and a number of workshops were offered, covering:
 - Localism and spending cuts.
 - Radical approaches to delivery.
 - National functions.
 - Fire and Rescue and the voluntary sector.
 - Minister's address.
- 2.4 There was also a mix of panel sessions and plenary sessions with opportunities to question the speakers. These included flexible staffing arrangements, improved sickness management, pay restraint and recruitment freezes and shared services, amongst other areas.
- 2.5 In addition to the opportunity to receive information on current fire and rescue service issues, and networking with Members from other Authorities, attendance at the event contributed to the learning and development opportunities for Members and has been recorded within the development portfolio of those Members who attended.
- 2.6 The meeting of Combined Fire Authorities was also held on the evening of Tuesday 8 March 2011, where items such as the impact of the Localism Bill, business rate impact for CFAs and the formula funding review were discussed. Agreement for a further CFA conference in 2011 was obtained, with a time and venue to be decided.

3. FINANCIAL IMPLICATIONS

The conference fee was £360 (+VAT) per delegate for Member Authorities, excluding travel, accommodation and subsistence, which took the final cost to approximately £600 per delegate. This was met from the budget for Members' conference expenses.

4. HUMAN RESOURCES AND LEARNING AND DEVELOPMENT IMPLICATIONS

The LGA Fire Conference offers an excellent learning opportunity for Members associated with the Fire and Rescue Service. The opportunities of networking with their peers from other areas of the country, as well as being updated on national issues, supports the ongoing awareness required within the role.
