8 FIRE COVER REVIEW

Further to minute 58, dated 25 February 2011, the Chair of the Fire Cover Review Working Group updated the meeting on the work carried out by the Working Group which was formed at the meeting on 25 February 2011 to look in depth at the implications relating to the Fire Cover Review. The Working Group was required to report back to the Chief Fire Officer on its findings by 10 June in order that a report could be submitted to the 24 June meeting of the Fire Authority.

RESOLVED that the Working Group be tasked to produce a report on its findings to the Chief Fire Officer by 10 June 2011 and that the Chief Fire Officer submit a report to the 24 June meeting of the Authority.

9 SCHEME OF DELEGATION
