## **Purpose of Report:**

To advise members of the outcome of the review by the Standards Committee of revised Standing Orders, Terms of Reference, the Complaints Against Members Procedure and Financial Regulations.

## 1. BACKGROUND

In order to maintain the smooth running of the Fire Authority and its Committees and Sub-Committees, it is necessary to update the current constitutional arrangements, which, in some cases, have been in place for more than 10 years. This is the first of a number of similar reports which will be submitted to the full Fire Authority for final approval following consideration by the Standards Committee.

#### 2. REPORT

The initial report to Standards Committee dealt with Standing Orders, Terms of Reference for Committees, Complaints against Members of the Fire Authority and, following receipt of comments back from Internal Audit, revised Financial Regulations. Future reports will deal with the Gifts and Hospitality policy and Codes of Conduct both of which are affected by the provisions of the Localism Act 2011. It is intended that all these documents, when approved, will be included on the Fire Authority website.

Discussions about the proposed revised Standing Orders raised a number of issues which require clarification. Consequently this report does not seek approval to these at this stage but will be the subject of a report to a future meeting of the full Authority.

The review by the Standards Committee raised no issues in respect of the other documents presented to the Committee aside from a request that the Terms of Reference be circulated to the individual committee chairs. Apart from the Standards Committee, where it was felt to be unnecessary, this has been done and comments received will be reported back verbally at the meeting.

Consequently this report now seeks formal approval to the following documents:-

- 2. The procedure and documentation relating to complaints against Members of the Authority attached as Appendix 2.
- 3. The revised Financial Standing Orders attached as Appendix 3.
