#### 1 APPOINTMENT OF CHAIR

### 4 DECLARATIONS OF INTERESTS

John Buckley, Assistant Chief Fire Officer declared a personal and financial interest in agenda item 9, 'Appointment of Deputy Chief Fire Officer,' (minute 9), and left the room when this item was discussed.

#### 5 MINUTES

RESOLVED that the minutes of the meeting held on 24 February 2012, copies of which had been circulated, be confirmed and signed by the Chair.

#### 6 CHAIR'S ANNOUNCEMENTS

The Chair reported on the following matters:

- (a) the Chair welcomed three new City Council members to the Fire and Rescue Authority: Councillor Collins, Councillor Norris and Councillor Wood;
- (b) the Chair agreed to write letters of thanks to Councillors Arnold, Morris and Packer as recognition of their hard work and contribution to the Fire and Rescue Authority over the previous municipal year;
- (c) the Chair agreed to write to Councillor Cross on behalf of the Fire and Rescue Authority wishing him a speedy recovery from his current illness;
- (d) on 17 April, the Mayor and Deputy Leader of Gedling Borough Council had visited Fire Authority HQ and toured various departments. They had been very impressed with both the premises and the staff. The Chair thanked John Mann for co-ordinating the visit. Gedling Borough Council would be holding an Away Day at HQ shortly. The Chair reminded members that the facility to hold Away Days was available to other organisations by prior arrangement;
- (e) the Chair had been on a visit to Mansfield Chad, where there had been considerable interest in the Fire and Rescue Authority's use of solar panels on its premises and its green credentials generally;
- (f) Andy Beale, Deputy Chief Fire Officer was due to retire on 27 May. Andy had joined the Fire Service in Essex in 1986. In September 2003, he had joined Nottinghamshire and City of Nottingham Fire and Rescue Service. In 2006, he had been promoted to Assistant Chief Fire Officer and in 2009 to Deputy Chief Fire Officer. The Chair wished him well in his retirement and presented him with a gift from colleagues. Councillor Wheeler wished Andy a long and happy retirement on behalf of the Conservative Group at the County Council.

# 8 HUMAN RESOURCES COMMITTEE OUTCOME - ORGANISATIONAL RESTRUCTURE

Consideration was given to a report of the Chief Fire Officer, copies of which had been circulated, informing members of the decisions made by the Human Resources Committee held on 20 April 2012, with regard to the organisational restructure and subsequent deletion of posts and creation of new roles and seeking ratification of those decisions.

John Buckley, Assistant Chief Fire Officer left the room prior to the consideration of this item.

#### 9 APPOINTMENT OF DEPUTY CHIEF FIRE OFFICER

Consideration was given to a report of the Clerk to the Fire Authority, copies of which had been circulated, seeking approval for the recommendation from the Appointments Committee with regard to the appointment of Assistant Chief Fire Officer John Buckley to Deputy Chief Fire Officer on a permanent basis.

Councillor Wheeler sought, on behalf of the Conservative and Liberal Democrat members, to amend the recommendation to appoint to the position on a permanent basis, on the basis that appointment to the post should be market tested as it was such an important role. He pointed out that the Conservative and Liberal Democrat members of the Appointments Committee had decided not to attend the meeting following the decision of the Policy and Strategy Committee to make the appointment a permanent one, on the basis that those members favoured a temporary appointment on a 12 month rolling basis.

Councillor Wheeler stated that it was the view of the Conservative and Liberal Democrat members that such an important appointment should be market tested and reviewed every 2 years. There was no objection to the appointment of John Buckley per se; indeed the members had full confidence in his ability to undertake the role.

The Clerk advised the meeting that it was the function of the meeting to ratify or not to ratify the appointment on a permanent basis but not to seek to change the terms of the appointment. If the meeting voted against ratifying the decision of the Appointments

Committee, the matter would be referred back to the Appointments Committee for further consideration.

RESOLVED that Assistant Chief Fire Officer John Buckley be appointed Deputy Chief Fire Officer with effect from 28 May 2012 in accordance with the recommendation of the Appointments Committee.

Councillors Carroll, Collins, Fielding, Grocock, Norris, Pulk, Smith, Spencer and Wood voted in favour of the recommendation and Councillors Barnfather, Cooper, Hempsall, Kerry, Rigby, Wheeler, Yates and Zadrozny abstained from the vote.

John Buckley rejoined the meeting and the Chair congratulated him on his appointment.

## 10 <u>FEDERATION OF THE EUROPEAN UNION FIRE OFFICER ASSOCIATIONS (FEU)</u> <u>CONFERENCE 2013</u>

Consideration was given to a report of the Chief Fire Officer, seeking approval of the Fire Authority for Nottinghamshire Fire and Rescue Service to host the 2013 Federation of European Fire Officer Associations (FEU). The Chief Fire Officer explained that this was an organisation designed to enhance fire safety and provide expertise to European Bodies in matters concerning the development of fire brigades and fire safety in Europe. The FEU met twice yearly on a rotational basis. In 2013, the UK was scheduled to host the Spring FEU conference. The opportunity had arisen for Nottinghamshire Fire and Rescue Service to host the event. It would be an opportunity to promote both the Service and Nottinghamshire to the delegates. It was anticipated that the cost would be in the region of £7,500, but it was hoped that if members agreed to host the event, potential sponsors would be forthcoming with sponsorship monies, effectively reducing the cost.

Councillor Rigby appreciated the kudos which could be gained from hosting the event but thought it inappropriate to be spending public monies on such an event at a time when staff had been made redundant.

RESOLVED that Nottinghamshire Fire and Rescue Service host the FEU Conference in Spring 2012 within the budget parameters identified.

#### 11 RETAINED FIRE-FIGHTER PENSIONS

Consideration was given to a report of the Chief Fire Officer, copies of which had been circulated, bringing to the attention of members, the potential human resources and financial implications of the outcome of the Retained Fire-fighters Employment Tribunal which granted retrospective access to the Fire-fighters Pensions Scheme.

The report was introduced by the Chief Fire Officer who explained that this had arisen due to the Fire Brigade's Union (FBU), bringing a claim through the Employment Tribunal system under the Part-time Worker (Prevention of Less Favourable Treatment) Regulations 2000 against their Local Government employers and the Secretary of State for Department of Communities and Local government (DCLG). An agreement had been reached on the terms and condition claim but the claim granting retrospective access to the Fire-fighters Pension Scheme had not been settled. There would financial implications for the Authority if retained fire-fighters opted to buy-back their service through an amendment order. Liabilities should begin to emerge in the 2013/14 financial year.

On behalf of Fire and Rescue Authorities, the Local Government Association was seeking legal advice on the Government's liability for the balance of the scheme liability and on whether it had been appropriate to exclude employers from the settlement agreement discussions in the event that the conclusion was to pass on the additional costs to Fire and Rescue Authorities.

Councillor Kerry pointed out that whilst the implications were noted by members, they were not necessarily accepted and the first recommendation needed to be amended accordingly.

As soon as the ramifications were known, they should be considered first by the Finance and Resources Committee and then put before the full Authority for ratification.

#### **RESOLVED:**

- (1) that the potential implications of the outcome of current negotiations on the settlement negotiations between DCLG and the FBU be noted;
- (2) that the Finance and Resources Committee be tasked with allocating an earmarked reserve to address the potential liabilities within the 2013/14 budget process if greater clarity was available by that time.
