20 BRIDLESMITH GATE – STREET TRADING POSITION

Consideration was given to a report of the Corporate Director of Community and Culture, copies of which had been circulated, detailing an application for a street trading position on Bridlesmith Gate.

The applicant, Mr S Fisher, accepted the Committee's invitation to attend the meeting and presented his case.

Mr S Fisher and Mr N Ehrhart, having made their submissions, withdrew from the meeting during the Committee's deliberations.

RESOLVED that the grant of a street trading consent for the sale of fruit juices and smoothies for the daytime street trading position on Bridlesmith Gate be approved.

21 HACKNEY CARRIAGE FARE INCREASE REQUEST

Consideration was given to a report of the Corporate Director of Community and Culture, copies of which had been circulated, requesting an increase in the maximum fares charged for journeys taken by hackney carriages.

RESOLVED

(1) that, subject to resolution (2) below, the increase in hackney carriage tariffs, set out as follows, be approved with effect from 6.00 am on 31 March 2008:-

6.00 am to 10.00 pm

Initial hiring charge to rise from '£1.80 for any distance up to, but not including 201.5 metres' to '£2.00 for any distance up to, but not including 285 metres'
