PRIORITIES FOR WEST AREA ACTION PLAN 2006-09

1 <u>SUMMARY</u>

1.1 This report informs members of the key issues that should be considered as priorities in line with One Nottingham Partnership guidance.

2 <u>RECOMMENDATIONS</u>

- 2.1 It is recommended that members agree the following priorities for the *West Area Action Plan 2006-09*:
 - Health Deprivation and Disability
 - Teenage Pregnancy
 - Coronary Heart Disease
 - Employment, Education and Training
 - Adult Education
 - Long-Term Unemployed
 - Pre-16 Education
 - Key Stage 2 Maths
 - Key Stage 2 English
 - GCSE Passes
 - Crime and Disorder
 - Burglaries
 - Youth Offending
- 2.2 A draft plan based on key priorities to be presented to this area committee for approval in March 2006.

3 BACKGROUND

- 3.1 Members may recall that a report, *Area Action Planning 2006-2009*, was presented to this Area Committee at its meeting on the 16 November 2005. The report outlined the process recommended for the development of a new round of action plans.
- 3.2 The key focus for the new round of action plans is:
 - Stronger local governments
 - Stronger local communities
 - Services tailored to meet the need of neighbourhoods
 - Joined-up service delivery
- 3.3 A major difference between previous action planning processes and this round of action planning is the requirement that the plans link directly into service and strategic processes of partner organisations.
- 3.4 The City-Wide Steering Group for Action Planning have requested a *Project Scoping*

Form (Appendix 1) outlining key output measures and timescales for the action planning process from each area.

- 3.5 Each area is expected establish a steering group for action planning whose responsibility will be to share intelligence and statistics to determine priorities for the 2006-09 action plan. A list of steering group members is attached (see Appendix 1, Project Scoping Form Item 4.)
- 3.6 The steering group, as requested by the One Nottingham Partnership, identified the priorities for the action plan based on the *Indices of Deprivation* information provided by the Observatory. Each group has been asked to identify four (maximum six) priorities based on the *Indices of Deprivation* data. Once priorities have been agreed there is an expectation that detailed consultation will be carried out and justification for each priority provided to the One Nottingham Partnership
- 3.7 The steering group have completed the template provided by One Nottingham Partnership (*Evidence for Identification of Area Action Plan Priorities*) – see Appendix 2.
- 3.8 The Broxtowe Partnership Trust have carried out a similar exercise targeting the Broxtowe are of Aspley Ward. See Appendix 3.

4.1 It is proposed that members agree on the priorities identified for the *West Area Action Plan 2006-09.*
