## <u>VOLUNTARY SECTOR RECURRING GRANT AID PROGRAMME - CORPORATE SINGLE GATEWAY</u>

#### 1 **SUMMARY**

The Single Gateway is the Corporate process for all grant aid requests. A report was agreed in principle at the Executive Board 20<sup>th</sup> December 2005 subject to comments from Area Committees. Information on affected voluntary and community groups which are located in your Area are contained in the appendix to this report.

#### 2 **RECOMMENDATION**

It is recommended that the Area Committee consider and comment on proposals for recurring grant aid contained within the attached appendix which lists community groups which are located in your area.

### 3 BACKGROUND

- 3.1. Executive Board on the 20<sup>th</sup> December 2005, approved in principal recurring grant aid proposals, subject to comments from the relevant Area Committees in which the affected voluntary and community groups are located. Attached is a copy of a summary sheet of the voluntary and community groups in your Area. Each funding department published the criteria for their service area within the application pack. Application packs were circulated and distributed during August and September 2005. Further information on the criteria used can be obtained from the contact officers.
- 3.2 Within the Social Services related grants to the Executive Board Report there is £31,866.50 unallocated funds. Social Services have identified a need for a BME service and/or an Older Person service. Before a final decision is taken on the allocation of this funding, Social Services propose to re-appraise the applications that they have already received against the Council's strategic and service priorities, and corporate and service criteria. A further report will be presented to the Executive Board March 2006

Grant aid benefits a wide and diverse range of voluntary and community groups and projects, many providing services and activities for disadvantaged sections of the

An important element of a community cohesion strategy is to ensure that all the allocation of funding through grant aid and is equitable, and that the Council and all sections of the population are clear why resources have been allocated to certain voluntary and community groups. It is proposed that a review is undertaken to the staff support given by Community Services to B.M.E groups
