REPORT OF THE CORPORATE DIRECTOR OF NEIGHBOURHOOD SERVICES

'YOUR CHOICE, YOUR VOICE' NEIGHBOURHOOD CONSULTATION EVENTS

1 SUMMARY

This report summarises the outcomes of the 'Your Choice Your Voice' Consultation Events held in the Aspley and Bilborough Wards on the 23rd and 9th of November respectively.

2 RECOMMENDATIONS

It is recommended that the committee:-

- a) Note the outcomes of the two consultation events summarised in appendix 1 and 2;
- b) Approve the actions, to be taken by the Neighbourhood Management Team, as detailed under 'Next Steps'.

3 BACKGROUND

- 3.1 The 'Your Choice Your Voice Consultation Events were jointly initiated by One Nottingham and the City Council's Strategic Partnership Team to engage with a wider group of people to identify neighbourhood priorities.
- 3.2 The Neighbourhood Management Team promoted the events locally, encouraged participation from hard to reach sections of the community and used the events as an opportunity to glean views on the Local Community Plan.
- 3.3 Between both the Bilborough and Aspley events, approximately 100 people participated. The events were well attended with involvement from a diverse section of the community, including BME groups, older people, single mothers and people with disabilities.
- 3.4 The overall feedback from local residents through the completion of evaluation forms was positive as in general they felt the events were well organised and relevant in meeting their expectations. However, there were some people who felt the method in which the research was conducted did not allow a wider selection of views to be covered.
- 3.5 Appendices 1 and 2 provide details of the issues, comments and priorities raised by the residents at each event. It should be noted these are the initial evaluations for both events and a more comprehensive evaluation will be made available in February 2007 by the Strategic Partnerships Team and the findings will be published in the Arrow.

4 PROPOSALS

This report provides an opportunity for the Area Committee to become aware of local peoples views on the one Nottingham One Plan priority themes and other localised issues. The information generated from the events can be used to monitor performance of services in responding to the needs of local neighbourhoods.

5 FINANCIAL IMPLICATIONS

The organisation costs for both events were met by the Strategic Partnership Team. Should this Committee want to hold similar consultation activity in the future, the costs can be met from the West Area incidental budget.

7 EQUALITY AND DIVERSITY IMPLICATIONS

- 7.1 The Your Choice Your Voice consultation events created an opportunity for all local residents to participate in the events, and make their views known on issues they felt were important to them in their neighbourhoods.
- 7.2 The information from these events will help develop an active citizenship engagement model for the Area. The Neighbourhood Management Team will work with key partners and continue to consult and engage with the local community. The events offer an opportunity to those sections of the community who normally do not participate in decision making.

9 CONSULTATIONS

- 9.1 Your Choice Your Voice events were created and delivered for the purpose of consulting with local people on key areas including the One Nottingham One Plan priority themes, Neighbourhood Policing, Environmental Improvements as part of the Area Capital Fund allocations for the year 2007/08 and 2008/9 and local neighbourhood issues.
- 9.2 Feedback from local residents will help ensure that the resources and services being delivered in the area are in line with the views and recommendations of local people.

10 NEXT STEPS

- 10.1 The Neighbourhood Management Team will contact all individuals attending the events to feedback what actions will be taken on the issues they raised. The Neighbourhood Management Team will also provide information on how the Area Capital Allocation will be used in the Area and how the views of the attendees were taken into consideration.
- 10.2 The Neighbourhood Management Team will use this and other information to ensure its work plan is linked into the issues that really matter to local people.

11 STRATEGIC PRIORITIES

Both events across the West Area created an opportunity for One Nottingham and Nottingham City Council to consult local residents on a number of strategic priorities including the One Nottingham One Plan, Neighbourhood Policing, Local Community Plan and the Area Capital Fund.

12 CRIME AND DISORDER ACT IMPLICATIONS

Feedback from local residents on crime and disorder issues in their neighbourhoods will enable One Nottingham and Nottingham City Council to introduce measures and resources which are effective, efficient, economically viable and well targeted to the needs of local people. For example, the allocation of the Area Capital Fund will contribute towards the improvement of community safety by improving street lighting, fencing (where needed). The identification of hot spots within particular natural neighbourhoods will ensure that those responsible for addressing crime and disorder issues will be able to effectively target their resources/services.

13 VALUE FOR MONEY

- 13.1 Both events for the West Area were delivered within the key principles of Best Value.
- 13.2 The total cost for the delivery of both events was £278.10 this covered the cost for venue hire, food and refreshments, crèche, local partnership forum costs, raffle prizes and the hire of a P.A. system.

- Attacking drug-related crime 91% said High Priority
- Giving local people a say in Council decisions 74% said High Priority
- Promoting responsible behaviour 83% said High Priority
- Helping young people to do better, socially and academically 57% said High Priority
- Help people move off benefits and into work/training 87% said High Priority
- Help People to Live Longer (quitting smoking/more exercise etc.) 65% said High Priority

Local Policing Issues

Those present were asked to identify which, from a wide range of Community Safety Issues, affected their neighbourhood. They were then asked to identify four that they thought were most important to them.

Top 4 Issues in this Neighbourhood:

- 1) Speeding cars/boy racers/joy riders/motorbikes etc. 15 votes
- 2) Litter 11 votes
- 3) Dog Fouling 10 votes
- 4) Drinking alcohol in streets/binge drinking 8 votes

Area Capital Funding

People became involved in identifying issues on a map in the areas of the ward where they felt attention was needed. Feedback and analysis from this will be available from the City Development Highways team as soon as possible. The information gathered will feed into the decision making process for allocating the Council's Area Capital Funding in 2007/08 and 2008/09.

Evaluation of Feedback

16 people strongly agreed *or* agreed that the event was well organised.

- **14 people** strongly agreed *or* agreed that the content was relevant and met expectations.

- **16 people** strongly agreed *or* agreed that there was a good balance between information giving and discussion and group work.
- **15 people** said they had a better understanding of the community strategy
- 13 people said they had a better understanding of Neighbourhood Policing
- 13 people said they had a better understanding of Area Capital Funding items
- 13 people said they had a better understanding of Local Issues

Any other comments?

When asked where improvements could be made to the consultation process, the following points were made:

- Ranking priorities already in the community strategy is nonsensical. There was no
 explanation of how to improve the community strategy in future, or a timetable of how
 this will be done.
- To inform us on who decides on what is spent, when and how much in each area would have been beneficial.

The **location and overall environment** were considered 'very good and appropriate' and **refreshments** were, again, well received.

It was widely reported that the community were glad to have people from the council listen to their ideas, to find out about their Neighbourhood Policing strategy and to have a point of contact with the officers responsible for their area.

- Helping young people to do better, socially and academically 81% said High Priority
- Help people move off benefits and into work/training 65% said High Priority
- Help People to Live Longer (quitting smoking/more exercise etc.) 46% said High Priority

Local Policing Issues

Those present were asked to identify which, from a wide range of Community Safety Issues, affected their neighbourhood. They were then asked to identify four that they thought were most important to them.

Top 4 Issues in this Neighbourhood:

- 1) Speeding Cars/Boy Racers/Joy Riders/Motorbikes 14 votes
- 2) Rowdy Behaviour/Intimidation 11 votes
- 3) Dog Fouling 11 votes
- 4) Drinking Alcohol In Streets/Binge Drinking 10 votes

It is worth noting that Litter and Drug Misuse/Dealing/Discarded Needles both received 9 votes each.

The location, overall environment and refreshments were largely considered as 'great'

When asked where improvements could be made to the consultation process, the following comments were noted:

 Create a website so that residents can send in concerns to Local Area Group/Police and get a response.

It was also noted that the community members were surprised that senior councillors were aware of the problem areas and streets in the neighbourhood
