44 PARKS DEVELOPMENT – APPLICATION FOR RELEASE OF SECTION 106 FUNDS TO MATCH FUND IMPROVEMENT WORKS ON OPEN SPACE

45 AREA CAPITAL RESOURCES

(Directors of Neighbourhood Regeneration and Housing)

Members made the following comments:-

- further consultation was needed with Tenants' and Residents' Associations on where the work was required;
- the Area Committee needed to have some input into the environmental works controlled by Nottingham City Homes Limited, as it was crucial that their consultation linked with the committee:

ACTION

 even though the utility companies were aware of the work the Council was doing, and the Council had worked with them to establish their work programme, it was still a frequent occurrence for them to carry out work after the Council had resurfaced a pavement. If this was to continue then the utility companies needed to replace the surface to the same standard as the Council.

- 46 REVIEW OF THE PROVISION OF SERVICES FOR YOUNG PEOPLE CONSULTATION BY THE CHILDREN AND YOUNG PEOPLE STANDING PANEL

(Director of Performance and Scrutiny)

The Chair informed the committee that consultation had already begun in the area at a meeting of the Tenants' and Residents' Association Chairs and the Neighbourhood Manager reassured members that further consultation would be carried out by forwarding the questions from the report to Tenants' and Residents' Associations, meeting with school representatives from the area, forwarding the questions to specialist services e.g. Youth Inclusion Project and involving the Education Welfare Officers for the area.

The Chair also informed the committee that it was of paramount importance to involve people in the consultation that were representative of the area e.g. from a deprived background, and a forum would be established to enable this to take place.

Jill Wilkinson, Keys to Success informed members that each school had a school council and would each be electing two representatives to be on the Education in Partnership Council which would discuss key issues in the area. This new group could be utilised for the consultation process.

Members made the following comments:-

- there was a weakness in engagement and dialogue with young people which needed to be improved. Young people were the future and it was important that their needs were being met;
- Leen Valley didn't have many Tenants' and Residents' Associations so another way would have to be devised to consult in the area;

<u>ACTION</u>

 all vulnerable groups needed to be engaged and consulted as they were the ones who didn't voice their opinions. There needed to be real consultation over a very broad spectrum.

RESOLVED that the questions be submitted to Tenants' and Residents' Associations and all other relevant groups within the area for consideration and that a collective response be submitted to the Overview and Scrutiny Team by the first week in March 2008.
