42 NOTTINGHAM IN BLOOM NEIGHBOURHOOD INITIATIVES

(Director of Sport, Leisure and Parks)

In addition to the information presented in the report, maps showing the proposed locations of troughs and planters were circulated. 44 <u>NEIGHBOURHOOD ACTION TEAM UPDATE AND REQUESTS</u> FOR FUNDING

(Acting Director of Local Communities)

The Area Manager informed members that details of the Community Chest initiative were not included in the report as it was an area wide project and information on all of the applications received had previously been emailed to members. All but one of the applications had been supported.

Members commented that in future they would like to see all of the applications requesting funding before making a final decision. The application which had not received support was from Wollaton Vale Community Centre, as this was for painting and decorating which members felt should be met from their maintenance budget.

The Area Manager reassured members that information on all Community Chest applications would be circulated at an earlier stage in the future.

RESOLVED

- (1) that the report be noted;
- (2) that the following requests for funding, totalling £8,810.00, be approved:
 - (a) £1,710.00 as a contribution towards Christmas parties across Aspley on 19, 20 and 22 December 2008 and the intergenerational tea dance on 17 February 2009, met through contributions of £710 from Councillor Chapman's budget, £500 from Councillor James' budget and £500 from Councillor Unczur's budget;
 - (b) £600.00 to have a number of large boulders placed on Beechdale Mews Park to prevent football being played and causing damage to residential fencing, met from Councillor Foster's budget;
 - (c) £1000.00 as a contribution towards publicity material for the Local Action Groups covering the three beat areas in Leen Valley, met from Councillor Long's budget;
 - (d) £5,500.00 to replace trees and resurface the pavement on Robinswood Road, to be met from the Leen Valley Public Realm budget.

45 AREA CAPITAL RESOURCES 2006-09

(Director of Housing and Neighbourhood Regeneration)

RESOLVED that the following be noted:
