53 <u>NEIGHBOURHOOD ACTION TEAM UPDATE AND FUNDING</u> <u>REQUESTS</u> (Acting Director of Local Communities)

Gill Bainbridge left the room prior to consideration of this item.

Members made the following comments:

- if a breakdown on the composition of the membership of the Tartanaires was provided and there were members from Bilborough then a contribution could be made from the Bilborough councillors budget;
- useable office furniture was regularly disposed of by the Council that could be utilised by community groups. There was a section on the website where departments could advertise furniture that was surplus to requirements but this was not well advertised;
- furnishing for community centres should be funded by the department and the possibility of this needed to be investigated. Councillor Chapman, as Portfolio Holder for Resources, could look into this issue for all community centres;
- the over 50's event was welcomed but advertising material for the event should have the Area Committee and Council logo on it to ensure that the community knew the Area Committee had provided funding. Leaflets and posters needed to be displayed at libraries and community venues as not everyone had access to the website;
- members should be provided with the postal codes of people accessing the health event at Harvey Hadden to ensure it was attracting people from all wards.
