37 APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors Cresswell and Saghir and from Heidi May and Imogeen Denton (Neighbourhood Management) and John Day (St Martin's Church).

38 DECLARATIONS OF INTERESTS

No declarations of interests were made.

39 MINUTES

(a) <u>Confirmation</u>

RESOLVED that the minutes of the last meeting held on 11 January 2011, copies of which had been circulated, be confirmed and signed by the Chair.

(b) Further to minute 35, resolution (3), Councillor Wood reported that, while he had received a response to his query regarding works undertaken at St Agnes Court, he was still of the opinion that, prior to any works being undertaken using ward budgets, all ward Councillors must be consulted.

40 <u>LAND AND PLANNING POLICIES: DEVELOPMENT PLAN DOCUMENT</u> (LAPP DPD) – ADDITIONAL SITES (Director for Planning and Transport)

Paul Tansey presented the report and stated the following:

- the LAPP DPD would provide the planning policy framework against which future planning applications were considered and would sit underneath the Aligned Core Strategy and set out development allocations, as well as detailed development management policies;
- an 'Issues and Options' consultation was recently undertaken, which asked how the Council could change its current Local Plan (adopted in 2005). As part of that process, people were invited to submit additional development sites, over 0.5 hectares, which they considered suitable for allocation within the next Local Plan. Following receipt of responses, consultation on suitable sites put forward would take place between 5 March and 30 April 2012, and anyone wishing to view the consultation document could find it at www.mynottingham.gov.uk/localplan;
- the 6 suitable sites proposed in West Area were:
 - Broxtowe Country Park: part (north corner) residential/commercial use:
 - New Aspley Gardens Option 1: residential/community/food store use:
 - New Aspley Gardens Option 2: residential/retail use:
 - Beechdale Baths and Ambulance HQ: food store use:
 - Land adjacent to Bobbers Mill: residential/retail use:
 - Former PZ Cussons: residential use:

- there was general agreement that the Committee would prefer 'green' land (especially allotments) not to be developed as there was a lot of community interest in allotment ownership in the area;
- the use of the northern corner of Broxtowe Park was welcomed, as long as the right quantity and style of housing was built.

41 <u>URBAN FORESTRY STRATEGY</u> (Director for Sport, Culture and Parks)

Paul Fountain presented the report, and gave the Committee a short presentation, regarding the Urban Forestry Strategy, aimed at creating a cyclical system of inspection and remediation of all tree stocks in the City, regardless of land ownership, to manage risk and resources more effectively than at present and ensure that trees were considered in all aspects of development in the future.

Sioban Campbell presented the report, which detailed the outcome of consultation regarding the new locality management structure and development of ward action plans, agreed at a meeting of Executive Board on 19 July 2011.

43 AREA CAPITAL RESOURCES 2011/13

(Director for Neighbourhoods and Communities)

Further to minute 35 dated 11 January 2012, Fi Cusick presented the report, which detailed monies available to each ward for capital schemes in relation to the Area Capital Programme for 2011-13.

RESOLVED

- (1) that the report be noted;
- (2) that, subject to the following, the Bilborough, Leen Valley and Aspley Ward schemes, as detailed in appendix 1, be approved:
 - (a) the Broxtowe Lane near Coleby Road waiting restrictions and pedestrian crossing schemes (Aspley Ward) were not approved and should form part of, and be funded from, a central scheme;
 - (b) the monies allocated in (a) above (£15,000) should be used towards the Limetree Avenue surface treatment scheme (Aspley Ward), which was presently on hold due to a lack of available funds.

44 <u>FINANCIAL POSITION OF WEST AREA COMMITTE</u> (Director for Neighbourhoods and Communities)

Sioban Campbell presented the report, which detailed the financial position of West Area Committee at 6 February 2012, and proposed that any remaining balances from completed and expired schemes be reallocated to wards on a percentage basis by utilising the Indices of Multiple Deprivation (IMD) (Aspley 44%, Bilborough 39% and Leen Valley 17%).

It was reported that the total uncommitted/decommitted funding was £183,079, with £80,555 to Aspley Ward, £71,401 to Bilborough Ward and £31,123 to Leen Valley.

During discussion, the Committee stated that the report was well presented, easily understandable and that it should be used as a template for all Area Committees to present their financial reports in the future.

RESOLVED that the decommissioning of the schemes, as detailed in appendix 1, and the reallocation of the carried forward and decommitted balances, as detailed in appendix 2, by utilising the IMD, be approved.

45 <u>ROBERT SHAW PLAYING FIELD – DEVELOPMENT THROUGH USE</u> OF SECTION 106 (TOWN AND COUNTRY PLANNING ACT 1998) FUNDING

(Director for Neighbourhoods and Communities)

Sioban Campbell presented the report, which requested authority to use £42,000 of Section 106 (Town and Country Planning Act 1998) funding to develop cricket and football facilities on the Robert Shaw playing field at Southfield Road.

RESOLVED

- (1) that the allocation of £42,000 of Section 106 (Town and Country Planning Act 1998) funding, towards development of cricket and football facilities on the Robert Shaw playing field at Southfield Road, and amendment of the capital programme to reflect that expenditure, be approved;
- (2) that delegated authority be given to the Director of Neighbourhood Services to place capital orders as required in respect of the proposed scheme.
