




All Crime in Leen Valley - % Change over 2010/11 Baseline (Rolling 12 Month)








- •For September 2012 All Crime in Leen Valley showed an increase of 30% (14 crimes) compared to September 2011.
- •However, this year Leen Valley is showing a reduction of 21% in All Crime year to date compared to 2011/12 figures.
- •The graph above shows that All Crime in Leen Valley is down 12% against a long term 2010/11 baseline, however this is an increase on last month.
- •The rate of All Crime (per 1000 of the population) for Leen Valley falls below the City average.








- •For September 2012 compared to September 2011 Leen Valley has experienced a reduction of 24% (11 calls).
- •This year compared to 2011/12 Leen Valley has experienced a reduction in All ASB calls of 38% (133 calls).
- •Over a 2010/11 baseline Leen Valley is showing a reduction in ASB of 28% (see above graph). The graph also emphasizes the general decline in All ASB against the long term baseline, indicating that this month's performance is not an anomaly.
- •The majority (79%) of All ASB calls received for Leen Valley in September 2012 were categorised as 'Nuisance'. This finding is consistent with the Division as a whole.




Fly Tipping

Incidents of Fly Tipping




Cleanliness Index



Community Protection

In Leen Valley in the last month there was the following court outcome:

• 1 tenancy terminated (or abandoned by perpetrator) following legal action by Community Protection for ASB.

Data has been received from Community Protection and where postcodes have been listed these have been geo-coded and mapped to determine the Ward. All addresses relate to the address of the Perpetrator.

FPNs are not currently available at Ward level.

Methodology

Crime Data and ASB calls have been extracted from the Police systems and mapped to ascertain which Ward they occurred in.

Due to the dates of the meetings, data for all Wards was extracted at the same time at the start of the month - and as such is not officially 'validated' data.

Where possible the most recent data is used, although for some areas this may be a month further in arrears.

Discussions continue with other agencies regarding what further data can be included.
