1 BACKGROUND

- 1.1 The Children and Young People's Plan 2008-11 is Nottinghams' second Children and Young People's Plan (CYPP). It is the single over-arching plan of for partners delivering services to children and young people (0-19) and their families.
- 1.2 An update of this plan was completed in 2009 with a decision being made to create a new plan for 2010 to 2014.
- 1.3 A period of initial key stakeholder engagement together with a series of intelligence reviews and policy guidance informed a decision making workshop on December 15th 2009. This workshop agreed the revised priorities to take forward to the full consultation process.
- 1.3 The Children and Young People's Plan is now owned and driven by Nottingham Children's Partnership who will develop the Plan to set a clear framework for strategic planning, resource allocation and accountability.
- 1.4 After adoption by the Children's Partnership Board, in 2010, the new Children and Young Peoples Plan will be subject to annual review.

2 <u>REASONS FOR RECOMMENDATIONS (INCLUDING OUTCOMES OF CONSULTATION)</u>

- 2.1 The next phase of Children and Young People's Plan review is to provide an opportunity for stakeholders to comment on the revised priorities relating to the long term, strategic objectives of the Children and Young People's Plan
- 2.2 The consultation process on the revised priorities will run from January 2nd 2010 to April 2nd 2010.
- 2.3 The strategic objectives link to the Sustainable Community Strategy that is taking Nottingham forward to 2020.
- 2.4 The Partnership will allocate resources to support the priorities in the Children and Young People's Plan, through strong links to budget setting and planning cycles across partner organisations.
- 2.5 There will be ongoing stakeholder engagement with the Children and Young People's Plan.
- 2.6 The key aims of the stakeholder consultation process are to engage and inform all appropriate groups and also identify any final stakeholder views regarding potential omissions from the Children and Young People's Plan.

3 OTHER OPTIONS CONSIDERED IN MAKING RECOMMENDATIONS

- 3.1 A range of stakeholders (of which Area Committees are one) are being contacted between January and late March 2010 to gather their views on the revised priorities of the new Children and Young People's Plan.
- 3.2 All of the feedback received will be collated, analysed and considered at the Senior Officer Group (SOG) prior to the Children and Young People Plan draft being

considered at The Children's Partnership Board on 28th April 2010.
