39 <u>MINUTES</u>

The Committee confirmed the minutes of the meeting held on 18 November 2014 as a correct record and they were signed by the Chair.

40 <u>CITY COLLEGE NOTTINGHAM</u>

Hassan Ahmed, Principal of City College Nottingham (CCN) delivered a presentation to the Committee and highlighted the following information:

- (a) as well as preparing people and getting them back into work, City College Nottingham are engaging with young people outside of work. One of the ways in which they do this is through sport;
- (b) within the skills development provision, there is the opportunity to take courses right up to Level 3, a supervisory level. Anyone using the service must have a Level 1 provision;
- (c) CCN will go to an employer's site to deliver apprenticeships. A range of vocational courses are offered;
- (d) The following are offered under the title of 'Special Projects:
 - (i) **Alternative Provision** aimed at 16 year olds, who will be sent out on courses by their schools
 - (ii) **European Projects** some citizens cannot access publicly funded programmes for their first three years of residency
 - (iii) **Empty Homes** work with landlords to refurbish properties
 - (iv) Youth Programme supported by Nottingham City Council;
- (e) enrolments are highest in the 25-40 age group, with the ethnic profile spread evenly. By ward, Dales provides the highest number of students, with the lowest intake coming from Mapperley;

Following questions and comments from the Committee, the following information was provided:

(f) students have always been evenly distributed by ethnic background. Across the three wards, Mapperley has the lowest number enrolled. Hassan reported that the college has capacity for more students;

RESOLVED to note the presentation and thank City College Nottingham;

41 NOTTINGHAM JOBS PLAN

Kevin Rowland, Operations Manager at City College Nottingham (CCN) delivered a presentation to the Committee and highlighted the following information:

(a) a target of engaging with 175 people has been set, with 123 to be in training, or other provision. This is a two year programme aimed at the whole of Area 6.

Out of 14 people that started the programme, 3 have gone onto further education;

Following questions and comments from the Committee, the following information was provided:

- (b) no target has been set for individual wards. CCN will work with area officers if any particular area needs additional help;
- (c) although CCN often goes out to sites of employers, it can be approached 5 days a week at its main campus on Carlton Road. CCN felt that it was easier to go out to residents, as many individuals will not travel;
- (d) Greg Foister, NDO for Dales was interested to see the provision in the Dales ward, and also wanted to emphasise the real need to focus on youth unemployment in Sneinton Dale within the Pakistani/Kashmiri community.

CCN were happy to work on this issue with Nottingham City Council. In addition, they took Greg's comments on board regarding the provision at the Surestart building at 144 Sneinton Dale;

- the aim is to get people into sustained jobs, rather than temporary employment. There are also the apprenticeships, which will be for one year. Once in work, people are monitored and a line of contact is kept open, with further guidance being offered;
- (f) CCN are aware of generational poverty issues affecting white males for deprived backgrounds. The Construction Programme has a good level of uptake from this particular demographic;

RESOLVED to note the plan and thank representatives from City College Nottingham for their contribution;

42 <u>FIT IN THE COMMUNITY</u>

Martin Barradell, Assistant Community Sport Officer at Nottingham City Council, and Siobhan Reilly, Tenant and Leaseholder Involvement Officer at Nottingham City Homes (NCH), delivered a presentation to the Committee and highlighted the following information: Area Committee East (A.C.E) Dales, St Ann's & Mapperley - 10.02.15

- (a) FIT in the Community is a 3 year Sport England project, and tries to address what factors are stopping people from being active. Age groups are broken down in 14-25 years, 26-59 years, and 60+;
- (b) NCH have started work in the St Anns ward. A consultation plan is being put together to find out who lives in the area, and what it's makeup looks like;
- (c) delivery stage of the project will be from April 2015, for a period of six weeks. After this point, groups that have developed during this six week period should be sustainable, and be run by volunteers from the local community. The volunteers will be NCH tenants;
- (d) there are currently very few NCH tenant groups in the Dales ward. More conversations need to be held between the NDO for Dales, and Martin Barradell and Siobhan Reilly. The week of action in June on NCH estates in the Dales ward represents a good opportunity to promote FIT in the Community to these specific residents.

New tenant and resident associations could be set up in the upcoming months;

(e) training is currently limited to NCH tenants, but there could be opportunities to engage with other groups, such as City College Nottingham, in the future;

RESOLVED to thank representatives from Nottingham City Council and NCH for their presentation;

43 VICTORIA PARK & ST MARY'S REST GARDEN

Martin Harris, Parks Technical Officer at Nottingham City Council delivered a paper on Victoria Park and St Mary's Rest Garden to the Committee and highlighted the following information:

- (a) Kingdom Hall does not fall within this proposal. Talks are ongoing regarding its status, but nothing has been finalised; the hope is that it will be put back into use;
- (b) although this proposal falls under Section 106 funding, more industrial developments would not necessarily meet the same criteria;

RESOLVED to:

- (1) note and support the proposals for the park improvement projects at Victoria Park and St Mary's Rest Garden;
- (2) approve the allocation of £39,846.01 from Section 106 funding (Marco Island 14/01696/PFUL3) for improvements to Victoria Park and St Mary's Rest Garden;
- (3) request a report to follow on Section 106 funding at a future meeting;

Kristian Murden, Tenancy and Estate Manager at St Ann's Housing Office, presented the report of the Chief Executive of Nottingham City Homes (NCH) outlining key performance updates on programme and environmental issues, highlighting the following:

- (a) the works at the Victoria Centre are due to finish at the end of February;
- (b) an additional £640.43 was tabled for Hungerhill Road for the installation of two concrete bollards, and returfing;

45 WARD PERFORMANCE

Michelle Graley, Neighbourhood Development Officer (NDO) for St Ann's, Greg Foister, NDO for Dales, and Fi Cusick, NDO for Mapperley, introduced the Strategic Director for Commercial and Neighbourhood Services' report providing summary updates on key themes within the Nottingham Plan 2020 for Quarter 3 2014/15, highlighting the following:

<u>St Ann's</u>

(a) there are public meetings in the St Ann's ward on 25 February 2015; 4, 16, 31 March 2015, and 7, 15, 28 April 2015;

<u>Dales</u>

- (b) there is a year on year increase in burglary and anti-social behaviour in the Dales ward. The Police are responding to this with the use of the ASB car, and an increase in numbers of Community Protection Officers (CPO). Mill Park has been identified as an area that needs focusing on;
- (c) the increase in instances of dog fouling could be due to more people now reporting these incidents. In addition, the silver bins within the ward are going missing.

Dales ward fared well on the cleanliness index;

(d) NDO's are shaping the delivery of employment offers in wards, through conversations on the Youth Contract;

<u>Mapperley</u>

- (e) cleanliness score was above the required level. In addition to this, fly-tipping hotspots in the ward are being discussed;
- (f) rough sleeping issues are being progressed as a priority;

Summary of issues (including benefits to citizens/service users):

The ward performance reports provide updates on key issues and themes which link back to local priorities addressed by Neighbourhood Action Teams and the strategic themes in the Nottingham Plan 2020. The reports provide summary updates on the following key themes:

Recommendation(s):

1 Area Committee note and comment on the Ward Performance Reports for quarter 1 2015/16.

1 REASONS FOR RECOMMENDATIONS

- 1.1 Ward performance reports provide a descriptive and statistical picture of what is happening at a ward level and invite community representatives to comment, debate, and challenge and identify how they can add value to improve their neighbourhoods.
- 1.2 Ward performance reports also monitor progress in the wards and act as a catalyst for debate about the key performance issues impacting upon the ward on a quarterly basis.

2 BACKGROUND (INCLUDING OUTCOMES OF CONSULTATION)

- 2.1 Neighbourhood Working has been important for a number of years in Nottingham as a means of engaging better with citizens and to drive forward service improvement.
- 2.2 The Nottingham Plan has a goal that 'public service delivery will be better integrated and appropriately devolved, ensuring more accessible and responsive services for all and giving residents more control over what happens in their neighbourhoods'; the Ward Performance reports help to support this.
- 2.3 The Ward Performance Reports captures work at a local level to support the Nottingham Plan; it is a short summary of key updates on priorities and issues in the ward. More detailed implementation plans sit behind the report such as the Ward Action Plan, Neighbourhood Action Team's Action Log, Crime Drug Partnership (CDP) plans and other partner's implementation plans.
- 2.4 The Ward Performance Reports are co-ordinated by Neighbourhood Development Officers every quarter, with the data analysis undertaken by the CDP.
- 2.5 The following brief summary by the respective Ward NDO highlights the key issues:

Ward: St Ann's – NDO: Michelle Graley

The NAT Team are currently in the process of arranging the St Anns Week of Action. The theme will be a round the environment and the promotion of positive individuals and groups in the area. Strap line will be 'Spirit of St Anns' and will take place week commencing 28th September 2015. We would like to encourage local schools and young people to take part in making this week one of success.

Safer Theme – Criminal Damage, Violence & Dwelling Burglary

Domestic Violence Update

Over the coming year we anticipate an increase in domestic violence crimes compared to the same period the previous year. This is due to the new concentrated project working within St Anns See St Anns Ward Priorities

- Continue awareness raising campaign
- Provide training for community organisations
- Encourage all staff working in the ward to access Equation training.
- Ensure availability of black and red cards in all public venues.
- Provide specialist support in to Social Care and Family support teams to enable case holders to achieve better outcomes with families and children.

Provide networking opportunities for staff working in the ward to ensure better joint working.

Overall Crime

St Anns All Crime is up by 8% from 2013/14 from 283 to 306 in 2015/16. Year to date up by 23. ASB

Continues to increase at 14%. Qtr 4 – figures show 2013/14 - 201 to 230 in 2015/16. Year to date up by 29.

Neighbourhood theme – Cleansing and Environmental issues

- The Banks project is now completed, apart from Truman Close Truman Close which will be
- The St Anns NDO along with Cllrs and Partners has compiled a St Anns Improvement Plan for the Public Realm, Carriageways, and Footpaths across the area.
- Raised beds throughout St Anns have the same planting as the Banks and are now in place
- A number of Carriageways are in the process of either being done or will be carried out by 15th June 2015. These include Hungerhill Road to Ransom Road. St Anns Valley Road, Rushworth, Luther Close, Elgar and Britten Gardens.
- NDO and Councillors have progressed an Area Capital scheme of works across the area
- Continue to work on the Drug dealing and Needle misuse areas with St Ann's Ward to tackle as part of the Nat's Task & Finish Group. A pilot scheme is in the process of being implemented in spring 2015. We hope to see the impact ready to be reported November 2015
- The Cleanliness score for St Anns are consistently showing above 86 baseline average. Fly
 tipping and Graffiti are also showing a down hill trend. Whilst Dog Fouling remains at an all
 time high year to date. The priority for the NAT's will be to discuss the plan with CPO's to
 tackle hotspots and campaign to encourage responsible dog ownership during the St Week
 of Action.

Community engagement

- 12 x Public Meetings. To date issues that local residents have brought to the St Anns Councillors attention have been around Offending Trees, Commuter Parking & ASB which has included residents identifying hotspot area. The local community in attendance, raised concerns regarding the proposed closure of the front counter in St Anns. I'm pleased to report that this has had no real impact on the quality of services from St Anns Police Station.
- Commuter and poor parking remains an issue and as a result, the St Anns Councillors and NDO are listing priority areas and working with Traffic Management to resolve some of the worst affected areas through a phased approached.

Financial Inclusion & Unemployment

St Anns Councillors are very keen to ensure clear targeted work in their ward to support the unemployed back into work, with a focus on the under 25s, the over 50s and the long term unemployed. They are also keen for support on financial inclusion and help with basic financial management, e.g. access to bank accounts, best online deals for fuel, avoiding high cost lenders

Nottingham City College are currently planning a jobs fair that will be held on their site on Carlton Road. Details to follow

2.6 Ward: Dales - NDO: Greg Foister

Safer Theme - Crime and anti social behaviour (ASB)

Crime -

From Ward data figures for April – The first month of the new recording year Burglary in dwelling is up by 2 from same time last year (7-5) looking at the offences, of the seven, 1 was by a tenant, 1 was by an ex-partner, 1 was by flat mate. Of the remaining 4, 3 were attempts and 1 was where property was stolen.

Burglary Other – No issues have been identified, only 1 offences in April which was a shed in a premise on the Industrial Estate.

Vehicle Crime – 4 offences (down from 12 last April) TWOC by daughter, a stolen motorbike, an unlocked car and petrol from a car.

There is an Increase in Violence and Public Order offences which mirrors the increases over the year. This increase is down to crime recording issues rather than increases in violent incidents per se. As can be seen over half the violence is accounted for by DV. No other issues re this other than an increased number of reports re problem residents. This is being Pro-actively dealt with and the next NAT will be addressing how we can respond to this in the local community. Public Order offences – 1 is DV harassment, 1 is police generated for urinating in the street, 1 is an affray involving people known to each other.

Criminal Damage – Reduced 21-13 offences from same time last year. Sexual Offences – 4 in April, 2 historic, 1 following a search of a house, 1 involving sex in a public place.

Other issues impacting on the current data May 2015 -

Co-op – is experiencing an increase in shop thefts, Colwick Car Boot - Has an increase in purse dipping; mobile phone theft and fraud offences – There is a local patrol plan in place to address this

<u>ASB –</u>

No issues with on street ASB. Hotspot patrol areas remain the Greenway Park and the usual areas of Boulevard/Kentwood etc. We have increased reports of off road bikes on Colwick Country Park (3 on same day) The CP services are currently assessing options with regards to how we deal with this.

Community Protection -

In April Sneinton/Dales CPOs dealt with the following

Intelligence submitted- 132. Letter s/ leaflets delivered to residents regarding local matters- 173. Fly posting - 124

The NAT has asked that these figures be explored in more detail to better understand the problem we have and to assist with the allocation of resources. This should be reflected in the NAT priorities presented to the September 2015 Committee.

Neighbourhood theme – Cleansing and Environmental issues

The Dales Ward compares well generally in the area of cleanliness. The data supports local concerns regarding the problems of Dog Fouling, fly tipping, bins on streets and the perception of general cleanliness. Page 20

The NAT priorities are currently being reviewed and will reflect these concerns. Hot Spots for Dog Fouling, fly tipping and bins on street, are being identified and are currently being reviewed. In addition to this we are currently identifying the most problematic ally ways with a view to joint work between members of the NAT led by CP services. The Dales has recently purchased a new mobile camera which will be used as part of out work to address these issues

The Neighbourhood Operations Manager and his team (Street Scene) are working to improve the average bench mark and address seasonal issues. Hotspot streets for litter, bin contamination and fly tipping are being reviewed with a view to setting new NAT priorities. As above the Dales has recently purchased a new mobile camera which will be used as part of out work to address these issues

The standard of our playgrounds and parks, along with the safety on our roads remains a concern for local people and local Cllrs. A number of schemes have been funded out of Area Capital monies to improve road users and pedestrian safety These schemes are currently being programmed. Cllrs have committed ACF monies to the development of the Greenway Park, along with working with Parks to submit a WREN bid. This bid has been successful and work to consult and implement the improvements is being planned.

The Windmill park has been identified by resident and Cllr, supported by CP and the Police as an area of concern for drug usage and vandalism. Cllrs have hosted a park summit to look at the issues, Parks are working with the users of the windmill park to write a new management plan. Area 6 NDOs have developed with partners a focused project to tackle drug dealing and misuse in this park, supported by Cllr funding. This park remains a significant priority for the NAT.

Community engagement

Local Cllrs have a series of Ward Walks and Local Issues meeting planned for 2015/16. New times for some of the ward walks are being planned at the end of a working day. The detail of this can be found in the appendix to this report. The Neighbourhood action team are seeking two joint patch walks with NCH as part of this activity.

The local police are starting a new initiative called 'street by street' this is an opportunity for the police and community protection staff to meet local people. In addition the local police team are piloting a web based meeting.

The current review of the NAT priorities reflect the need to deal with a number of local problems raised by residents in the last period. They will build on the work that has been achieved over the last year. The priorities have been drawn together as a result of listening to local people in a number of forums and looking at the data available. As a result the priorities whilst broadly set out under themes, seek to identify specific locations that need prioritising where it can or specific cohorts of residents that need focusing on. The NAT has now moved its meetings to MCO and will take to the street 3 times a year; to both increase its engagement activity and check its assumptions.

As part of the Sneinton week of Action this year (w/c 13th July) there will be a family event on the Friday afternoon and awards for the best gardens. The week of action seeks to act on the issues raised by local residents so in addition to the community events, residents will be involved in the garden awards. Work is currently underway to organise a citizens litter pick, lead by STARA and the screening of an open air film.

Working theme – Unemployment

The contract for providing youth employment work in the Area has been awarded to Nottingham City College. Currently provision is being delivered out of the Greenway Centre. The NAT and the NDO has asked that future work be delivered where possible from premises on Sneinton Dale to ensure that those young people who do not easily access these services have that opportunity.

Nottingham City College are currently planning a jobs fair that will be held on their site on Carlton Road. Details to follow.

The NDO is currently seeking the engagement of the Economic Development Team as the NAT priorities as due for review. All Data suggests that young people, 50+ and long term unemployed are our priority groups to focus on. Evidence also suggests that we have a very diverse make up of unemployed people. Future priorities will need to reflect delivery elements to focus on these groups.

No local monitoring Data has been received at the time of writing this report to assess the effectiveness of this programme against agreed targets.

Family and Community Team

The reviewed NAT priorities will reflect not only the universal provision provided by the Family and Community Teams, but also the contribution of these teams to the wider priorities of the Area. For example there contribution to work on DV, sexual exploitation, there contribution to work with young people around pre employment activity and health and ensuring that identified young people in relationship to targeted provision are taken to the VPP.

The NAT is currently seeking the further involvement of the family and community team and the Local Area Partnership in its work.

Health

The Health team have identified Ward based health priorities and have now provided the LM team with localised data. They have also provided the LM team with an up to date list of local service provision. Further discussion with the Health Team are being held to review the health priorities of the NAT and to look at the day to day business of tackling health in the Ward in line with the new strategic health plan.

2.7 Ward: Mapperley – NDO: Fi Cusick

Safer Theme - Crime and anti social behaviour (ASB)

- Auto crime remains a priority policing issue and statistics are down on this time last year 10 incidents in April 2015. The statistics show that Mapperley Ward has dropped out of the top 3 for vehicle crime.
- Burglaries figures show a steady reduction year to date 10 incidents in April 2015.
- Criminal Damage and Arson same as year to date 12 incidents in April 2015.
- Sexual offences shows a slight increase in reported issues 4 incidents in April 2015.
- Domestic Violence and Hate Crime have both seen a slight increase year to date 14 incidents in April 2015.
- The Prostitution Task Force report that levels remain at a constant low with girls now working on Forest Road East instead.
- The CCTV camera on Elm Bank remains fully operational and is working well.

2 REASONS FOR RECOMMENDATIONS

2.1 The Nottingham LTP strategy 2011-2026 maintains a commitment to deliver local transport improvements across Nottingham's Neighbourhoods and prioritises small scale transport improvements of importance to local communities.

As part of the budget process Nottingham City Council approved in March 2015 an LTP capital allocation of £1.25 million citywide between 2015-2016.

BACKGROUND (INCLUDING OUTCOMES OF CONSULTATION) 3

- 3.1 The Area Capital Programme was established to improve the environment of the neighbourhoods and to create a sense of place for residents in order to improve the quality of life of local people. Since it was established in 2006 to meet the then corporate priority of "Transforming Neighbourhoods" the Area Capital Fund has included a total programme expenditure portfolio of £40 million. The improvements that have been carried out to date using this programme have included footpath, fences, visual enhancements to public realm, refurbishment of parks and improvements to public buildings.
- Resources are allocated from the Nottingham City Council general fund, the Local Transport 3.2 Plan (LTP) and from the Housing revenue Account. To achieve a joint approach to environmental improvements in neighbourhoods, a greater degree of flexibility has been established to prioritise and deliver improvements so that there is a synergy in local solutions for local issues across neighbourhoods.
- 3.3 The programme of works is a rolling programme. There have been instances where schemes are started, with strong community involvement and interest, only to be altered at a later stage due to changing circumstances such as economic conditions and changes in land values.
- 3.4 The Area Committee, particularly community representatives, are invited to comment specifically on those schemes identified in the proposals column and also to consider whether certain schemes can be linked to other programmes of work in order to generate best value and create a greater impact on the local area.
