#### 17 MINUTES

Subject to the inclusion of the following attendees, the Committee confirmed the minutes of the meeting held on 22 June 2015 as a correct record and they were signed by the Chair:

Councillor Georgina Culley requested that the meeting in February 2016 be changed from the 8<sup>th</sup> to the 15<sup>th</sup>. It was agreed that this will be looked at outside of the meeting and discussed/agreed at the next meeting.

## 18 <u>NOTTINGHAM FESTIVALS MONTH</u>

Nigel Hawkins, Head of Culture and Libraries, gave a presentation on festivals taking place in Nottingham in October and highlighted the following points:

- (a) a video promoting Nottingham as the UK's festival city in October has been released on YouTube and viewed over 20,000 times;
- (b) the promotion is being done to attract overnight visitors to Nottingham and help boost the economy to £1 billion by 2020 through partnership working. It will also help build a profile for the City and better promote its events offer;
- (c) £120,000 has been budgeted for the project to reinvigorate Nottingham as the primary visitor destination for October for 2015 and 2016;
- (d) £45,000 of the £120,000 budget has been invested into a destination marketing campaign;
- (e) events include:
  - Goose Fair;
  - a Spiegel Tent music/drama/comedy/cabaret;
  - the Robin Hood Beer and Cider Festival;
  - an international Microfilm Festival;
  - the Hockley Hustle;
  - Oktoberfest;
  - Robin Hood Festival Week
  - the Robin Hood Pageant;
  - Game City;
  - the Nottingham Fringe Festival;
  - the Nottingham Canal Festival, plus many more;
- (f) there are adverts in 6 national newspapers, including The Times, The Guardian, and The Sun on Sunday;
- (g) there are radio adverts on 4 stations, including Heart Yorkshire and North West, Smooth North West and West Midlands;
- (h) there is a competition running until the end of September to win one of two weekend stays, with over 1,500 entries so far;
- (i) public relations include:
  - a media announcement sent out on 1 August;
  - engaging with local, regional and national media outlets;
  - tailored press announcements for families, foodies and beer lovers;
  - social media advertising through Google AdWords, Facebook and Twitter.

The Committee and others in attendance made the following comments:

- (j) there are many other events happening in the City in October but all of them are not included in the brochure as there was a deadline for submitting information. Other brochures and advertising will cover the other events;
- (k) this is the first time this approach has been taken so it is important to learn from it;
- (I) the project is impressive and includes something for all ages.

RESOLVED to thank Nigel for his presentation and request that analysis of the success of the project be submitted to a future meeting.

## 19 POLICING ISSUES IN AREA 7

Inspector Rob Wilson, Nottinghamshire Police, updated the Committee on the following issues:

## Wollaton East and Lenton Abbey

- (a) dwelling burglary has reduced by 17 offences year to date, which is a 51% reduction:
- (b) criminal damage has increased based on last year's figures but the beat team have intervened so it is reducing again;
- (c) burglary other has increased based on last year's figures which is mainly due to sheds and garages being left insecure;
- (d) there has been a slight increase in car crime year to date but the number of incidents is still quite low at 7;
- (e) 16 homes have been fitted with solar security lights;
- (f) there are lots of activities to promote crime prevention including the timer campaign, involvement in the week of action, etc:

#### Wollaton West

- (g) dwelling burglary has reduced by 18 offences year to date, which is a 55% reduction:
- (h) burglary other has reduced by 59 offences year to date, which is an 84% reduction:
- (i) there has been shop theft from the Co-ops so work is being done with them on crime prevention;

## General

- (j) there is a reduction in bike theft from the university grounds;
- (k) some of the crime figures contained within the ward performance report are incorrect but will be updated for the next meeting.



- 2.5 Nomination forms were sent out along with the Terms and References for the Role of Area Committee Community Representative to groups and organisations on the basis that it provides a geographical representation of the ward.
- 2.6 Completed nomination forms and expression of interest for Community Representatives onto the Wollaton & Lenton Abbey Area 7 Committee for the municipal year 2015/16 were received from groups and community organisations and these are listed in Appendix 2.

# **The Role of Community Representatives**

- You will be encouraged to act as an ambassador for the Area Committee to help to raise the profile of the work done by the Area Committee.
- You should attend all Area Committee meetings, events, training etc wherever possible.
- If you cannot attend the meetings try to find someone who will cover for you.
- You should represent the views of residents and of your group or community who live and work in the area.
- All business representatives should have business premises within the area.
- You will be encouraged and entitled to speak on all items discussed at Area Committee meetings.
- Events and training will be held for you to give you the confidence and knowledge to be actively involved within the Area Committee. We will ask you what training and events you would like.
- You will be invited to put forward items for discussion at the Area Committee meetings. You will need to do this at least 3 weeks before the date of the meeting.
- You will be encouraged to tell us when things are not running well.
- You will find it much easier to fulfill your role if you have read the reports before the meeting and, if possible, had a chance to discuss the report with your community group. Everyone will benefit from this as it allows the community representatives to play a much more active role and makes for a more effective and informed contribution to discussions and debate.
- Most importantly, any relevant information should be passed back to your community group to any local friends, neighbours or colleagues.
   None of the information made available during the meetings are secret or confidential.

 One of the biggest challenges for the Area Committee is to keep people informed. Your agreement to pass on information, display and distribute any publicity material in community venues and promote involvement in the work of the Area Committee and to take an active role in local community consultations is appreciated.

# <u>CENTRAL LOCALITY - COMMUNITY INVOLVEMENT IN AREA COMMITTEES: THE</u> CRITERIA AND PROCESS FOR SELECTION

# **INTRODUCTION**

- Encouraging greater participation in service delivery and decision making was one
  of the main reasons for establishing Area Committees in 1995.
- The new terms of reference give Area Committees more responsibilities which in turn will have an impact on the involvement of local representatives.

### THE CRITERIA FOR SELECTION

- Community or Voluntary organisations that wish to be represented on Area Committees will be properly constituted (i.e. have a constitution/terms of reference, have regular meetings, and operate an Equal Opportunities Policy)
- All community group representatives (except those representing citywide organisations), should live in the area and seek to represent the views of their group(s) or community organisation and not individual viewpoints.
- Community Group representatives will have established networks/systems for passing information to the Area Committee from groups that they represent, citizens that they aim to serve within their area and likewise feedback information from the Area Committee.
- Representatives will be selected each civic year (normally in May), Only one nomination per group will be accepted by the Area Committee at any given time. Any person from the group can attend Area Committee meetings although only the nominated community representative will be allowed to speak. If the community representative is unable to attend a meeting, the group can nominate an individual to speak on behalf of the community representative for the group.
- Any member of the public may have the right to attend Area Committee meetings as an observer.

### POWERS OF COMMUNITY GROUP REPRESENTATIVES

- Community Group Representatives are entitled to speak on all items discussed at Area Committee meetings and can 'influence' the decisions (but cannot vote on any matter) being made by the area committee.
- Community Group representatives will be entitled to claim expenses for travelling and care costs related to attending Area Committee meetings.
- Community Group representatives will be able to submit items for inclusion on the Area Committee agenda at least three weeks before the meeting or in advance of the meeting with the agreement of the Chair.
- Community Group representatives will be entitled to attend specific events and training across the city in order to carry out their role and responsibilities in relation to Area Committee/Working.
- Community Group Representatives can make formal presentations at Area Committee meetings on community projects/initiatives with the prior agreement of the Chair.

# POWERS OF COUNCILLORS IN RELATION TO COMMUNITY INVOLVEMENT IN AREA COMMITTEES

- Only Councillors can vote on all matters in respect of the Area Committee
- If a representative fails to attend committee meetings consistently without good reason, the Area Committee may approach their organisation for a replacement.
- If a representative is deemed to persistently not abide by the corporate policies of Nottingham City Council, (e.g. Health & Safety, Equality and Diversity), he/she will be required to resign their position as local community group representative on the Area Committee
- Councillors may choose to invite representatives from other organisations outside their geographical area in order to widen participation from under-represented groups.
- Councillors will allocate a small 'rolling budget' for reimbursement of Community Group Representative's expenses.
- If Community Representatives find it beneficial and have made a request, Councillors will provide community group representatives with an opportunity to meet together with the Neighbourhood Development Officers of the Central Locality Team prior to each Area Committee meeting, to discuss the agenda or other items of concern.

### THE PROCESS

- Each year Councillors must determine the number of Community Representatives
  that they wish to represent the community. This may be based on a set number of
  places per ward or according to specific interests and issues in the area.
  Representation should take account of the population make up of the area. Where
  under-representation exists, city wide groups may be approached for
  representation.
- Once per year (normally in March) the Central Locality Team will send out nomination forms by post, (together with an Area Committee information pack), to all community organisations in the area, inviting them to nominate a representative from their organisation to be involved in Area Committee meetings
- Locality Managers will assess completed nomination forms to ensure that the selection criteria are met and will produce a report for Area Committee detailing nominations received.
- Councillors will decide which of the nominations should be selected for community group representation at Area Committee meetings, taking into account the population make up of the area or specific issues/interests in the area.
- Those community group organisations selected will be notified in writing of the offer by the Central Locality Team. Details of future dates of committee meetings will be sent out at the same time.
- A review will take place each civic year (by Councillors advised by officers) to determine what groups are the most appropriate to be represented on the area committee
- Where nominations are not accepted, a letter explaining why will be signed by the Chair and sent to the organisation, together with details of other options for involvement in area working.
- Where groups are dissatisfied with the decision, they have the right to appeal to the Area Committee within four months.
- Councillors will then enlist the assistance of other Councillors of the city (Area Chairs Panel), to review the decision and any decision made thereafter, will be final.

Area Committee note and comment on the Ward Performance reports for quarter 3 2015/16

### 1. REASONS FOR RECOMMENDATIONS

- 1.1 Ward performance reports provide a descriptive and statistical picture of what is happening at a ward level and invite community representatives to comment, debate, challenge and identify how they can add value to improve their neighbourhoods.
- 1.2 Ward performance reports also monitor progress in the wards and act as a catalyst for debate about the key performance issues impacting upon the ward on a quarterly basis.

# 2. BACKGROUND (INCLUDING OUTCOMES OF CONSULTATION)

- 2.1 Neighbourhood working has been important for a number of years in Nottingham as a means of engaging better with citizens and to drive forward service improvement
- 2.2 The Nottingham Plan has a goal that 'public service delivery will be better integrated and appropriately devolved, ensuring more accessible and responsive services for all and giving residents more control over what happens in their neighbourhoods. The Ward performance reports help to support this.
- 2.3 The Ward Performance reports capture work at a local level to support the Nottingham Plan; it is a short summary of key updates on priorities and issues in the ward. More detailed implementation plans sit behind the report such as Neighbourhood Action Team's Action Log, Crime and Drugs Partnership (CDP) plans and partners implementation plans
- 2.4 The Ward Performance reports are co-ordinated by Neighbourhood Development Officers every quarter, with the data analysis undertaken by the CDP.
- 2.5 The following brief summary by the respective Ward NDO (Neighbourhood Development Officer) highlights the key issues. The more detailed Ward reports are attached as Appendix A.

### Ward: Wollaton West NDO: Lylse-Anne Renwick

**Crime:** Crime in the Wollaton West Ward has continued to fall. Theft from vehicles are still causing some concern and the NAT team are working tirelessly to resolve the issues, e.g. Police car patrol in the area where theft is prominent, visual Police Beat Officer patrol, educating citizens and working collaboratively with Wollaton Park to look at solutions of theft from cars in the park.

The total numbers of crimes in the ward in the last three months are:

August: 66 September: 59 October:42

**NB:** This is the actual Police beats breakdown given to the Neighbourhood Action Team by the Safer Neighbourhood Team in October 2015.

**Cleanliness -** in the ward has increased to 88% above the 'neighbourhood as clean as the city centre' benchmark target of 86%. **Graffiti** continues to decrease across the ward. There were no incidents in August and September. **Dog fouling**, there were only 3 dog fouling incidents reported across the ward in August 2015. **Fly-Tipping** – there was 3 incidents reported in August.

**Deliberate Fire: -** The ward continues to see a decrease in deliberate fires, there was no deliberate fires over the last four months, June to September 2015.

**ASB:-** There was a spike in ASB incidents in the ward in August 2015 which resulted in 22 reported incidents, but this figure fell to 13 incidents in September and 4 incidents in October. During the summer months there tend to be more reported ASB incidents than other months. Please note that ASB includes (nuisance, youth, alcohol etc.) there are 16 other categories.

**Domestic Violence Crimes:** There were 3 incidents reported in August and 3 incidents in September this is a decrease from the previous months, 4 May, 6 June and 6 July 2015. The NAT team are ensuring that domestic violence is on the agenda and workshops and training is advertised.

**Unemployment Rate:** The ward has seen a slight decrease of unemployment; there were 118 unemployed in August compared to 119 unemployed in July 2015.

### **Key Successes:**

**Wollaton Park Superheroes Picnic:** - August 19<sup>th</sup> 2015 saw the third Superheroes Picnic event in Wollaton Park. The hugely popular event saw thousands of children and families from Nottinghamshire and beyond who took the opportunity to enjoy this fantastic event which comprised of a funfair, games, crafts, archery, football and dancing with Daisy Dazzle. Over five thousand people attended and the Guinness World Record for the number of people dressed as superheroes in one place was achieved. The event was a huge success and the staff are already planning for next year 2016 event.

The Secret Science Show at Wollaton Hall: - Friday 25th September 2015 saw the free open evening for students, teachers, children and families to meet professionals and engaged in current Science and Engineering Research and also to discover the applications of science and technology in career choices. The event was aimed at school groups, secondary schools and year 6 students, families, teachers and interested adults. The event was a tremendous success; there were lots of very keen young scientists, the youngest was age 7. People particularly enjoyed the keynote speech which included using 3D glasses, Adam Smith's plesiosaur demonstration, the 3D printer used for noise reconstruction demonstration and the human evolution session with NCC museum freelance educators; there were also many positive comments about Wollaton Hall and the collections.

**Summer Deep Cleans across the ward:** - City Services have been very busy undertaking Deep Cleans in key hotspots around the ward identified by the Wollaton West Ward Councillors, Neighbourhood Development Officer, Neighbourhood Operations Manager, the LAG groups and residents.

**Grangewood Days Of Action:-** Days of Action are planned with partners to identify key issues for development and improvement in a specific area. On August 10<sup>th</sup> the NAT team, (Places for People, Tuntum Housing Association, Police, Locality Management Team) and City Services carried out three days of action on the Grangewood Estate. The event was to assist in resolving issue raised by residents and colleagues in the area, e.g. antisocial behaviour, dog fouling and fly tipping. The event was an enormous success, residents participated in meetings to look at resolving issues in their area, City Services carried out a bulky waste collection and consultation with the young people in the area was carried out by the NAT team and the Pythian Club. Ideas for improvement to the area were suggested by residents which the team will be working on over the next few months.

### Issues:

Fly-tipping at the side of garages on Radford Bridge Road are causing problems for citizens in the surrounding area. The CPO and Neighbourhood Operations Manager is actively dealing with the issues and will continue to monitor the situation to ensure that the issue does not continue.

The untidy shop front on Wollaton Road, (The Little Carpet Shop) has been causing a problem for both business and residents. The Enforcement team have written to the owner to clear the area of litter and to ensure that it is upkeep. Recently the area has again been filled with litter of carpet tubes and carpet offcuts which has caused residents to complain. The Enforcement team will take further action to eradicate the problem. The shop is in a very prominent location on Wollaton Road, the gateway into the village and close to Wollaton Park, which is very unsightly for residents and visitors to the area.

**Events:** A range of meetings and events have taken place this quarter including, Wollaton West Community Association Meetings, Friends of Wollaton Park Group Meeting, Local Area Group meetings, NAT meetings and Wollaton West Youth Café which continues to be a success.

Wollaton West Christmas Lights Switch On – Thursday 3<sup>rd</sup> December, 5:30pm, Bramcote Lane – The organisation of the Wollaton West Christmas Lights Switch On is in progress. The Wollaton West NDO, Events Management, Kingswood Methodist, Grangewood Methodist and St Leonards Churches together with Fernwood Nursery and Primary school and the local business on Bramcote Lane are all working diligently to bring together a fantastic event on the day.

**Football in The Community** – Nottingham Forest will be carrying out free football coaching sessions for young people at Fernwood Secondary School, Goodwood Road, Wollaton, NG8 2FT. After the success of the free football coaching sessions in the local parks over the summer, Nottingham Forest Football Club are continuing to offer coaching session at the school to encourage the young people who attend the summer sessions to continue and to also encourage more young people to participate in the activities. These sessions will help to address the anti-social behaviour in the ward and to also promote healthy lifestyles.

**NAT's(Neighbourhood Action Team)**: - The team represents various key services provides who meet to look at current issues across the ward. The team are working together on agreed ward priorities set by residents as well as the day to day issues that arise in the ward. The NAT team are at present jointly working to resolve issues across the ward. The key Issues are theft from vehicles and antisocial behaviour.

## Wollaton East and Lenton Abbey Ward: NDO: Pauline Dorey

**Crime:** During April – September 2015 (compared with April – September 2014) all crime in the Wollaton East and Lenton Abbey Ward increased by +4% (by 9 crimes, with an increase in victim based crime of 5 crimes) criminal damage of 9 incidents. Thefts decreased by -7 incidents with the majority being of bikes from the University and dwelling burglary decreased by -19 incidents during April – September 2015 for the same period in 2014. Please see detailed breakdown. The rate for all crime per 1,000 of population in the WELA ward is the lowest across the 20 wards. There is an increase of 11 incidences in ASB for the ward Year to Date.

**ASB**: During April – September 2015 (compared with April – September 2014) ASB increased by 12% by 11 incidents. The Ward has the lowest rate per 1,000 of population of the 20 wards across Nottingham.

**Domestic Violence Crimes:** 15 incidences reported for April – September 2015 YTD with an increase of 4 (40%) from previous year to date. However we have been informed that there are a significant number of unreported incidences of Domestic Violence in Lenton Abbey.

**Fire:** Even though incidents of Fire are low in the ward with 1 Deliberate Secondary and 1 Accidental fire in the quarter. With the Ward Year to Date ranking the lowest for All Fires with 2 (property and secondary) out of 20 wards across Nottingham. Events and Home Fire Safety Checks targeting vulnerable residents and groups and school children continue to take place in the Wollaton East and Lenton Abbey ward.

**Community Protection:** No Fixed Penalty Notice (FPN) or Statutory Notice data was available.

Cleanliness of the Ward has decreased from the previous quarter and to a 90 average above the 'neighbourhood as clean as the city centre' benchmark target of 86%. There has been no change in graffiti at 8 incidences and a slight increase in fly tipping and in dog fouling for the period April – August 2015 in comparison with the previous Year. For April – August 2015 Graffiti has increased slightly across the Ward by 1 with 10 incidents. Fly Tipping across the Ward in April – August 2015 has increased by 6 to 22 incidents. Dog Fouling across the Ward in April – August 2015 has increased by 10 incidents but with a downward trend to 58 incidents. However currently there have been no real issues raised regarding empty student properties and waste over the summer in the WELA ward.

**Unemployment:** Is increasingly falling for the WELA Ward with a decrease of -157 -30% for the period April - August 2015. This being the lowest in the City. With NDO support there has been successful ongoing volunteer team challenges, volunteer recruitment, development, training and capacity building at Sheila Roper Community Centre. This is highlighted in the Ward Report under the Ward Priorities for Work.

**Health:** Health data is currently being updated for the ward. Sheila Roper Community Centre are currently exploring the possibility of offering different health sessions with various partners.

### **Key Successes:**

**Lenton Abbey Park Development Plan and Bid –** In April 2015 we received the exciting news that NCC has secured an external Funding Bid of nearly £40,000 for new developments on Lenton Abbey Park developed with Ward Councillors, NDO, residents and Parks and Open Spaces. Work is underway commissioning the contractors to undertake and install the new developments of a football pitch, wildflower meadow, fruit trees, new outdoor gym equipment and under 5's equipment, table tennis tables. This will further enhance the Green Flag status already awarded for the Park. We hope to have a launch in the Spring 2016.

**Sutton Passeys Crescent Play Area** – Full and comprehensive community consultation results from 2 months consultation with local residents by WELA NDO and Parks Development Officer from Parks and Open Spaces was submitted as part of an external funding bid for £50,000 for the construction of the new Play Area. This is in addition to the £16,805.00 match funding already committed by Wollaton East and Lenton Abbey ward Councillors from their WELA ward budgets through Area Committee in November 2013. A decision is expected in early December 2015.

**Autumn Deep Cleans across the ward** – City Services have been busy undertaking Deep Cleans in key hotspots around the ward identified by WELA Ward Councillors, Neighbourhood Development Officer and Neighbourhood Operations Manager and WELA residents. Focussing on alleyways, off road areas and twitchels.

**Student Week of Action** – Days of Action were completed with partners as part of the City wide Student Waste Management Plan for the Student Week of Action starting 12<sup>th</sup> October. On 15<sup>th</sup> October hotspot streets were targeted in Wollaton Park estate and Lenton Abbey by NDO working with partners from Community Protection, PCSO, Student Strategy, Waste Advisers, Ward Councillors and University of Nottingham staff to welcome students and reinforce campaign messages about community and personal safety, crime prevention, anti-social behaviour, recycling and waste management and promote local groups and facilities and use of Bulky Waste collections, bin day texting service and electoral registration. This work also strengthened HMO registration and Nottingham City Council good Landlords Scheme.

Wollaton Park Residents Association (WPRA) Christmas Fair – Saturday 5th December Plans are underway with WELA NDO working closely with WPRA, local creatives and other NCC and VCS partners. If you have any new activities/ ideas please get in touch. Please look on the WELA facebook page for upcoming news and dates.

Christmas Light Up Events and Lenton Abbey Residents Association – Wednesday 2nd December 5pm The Blossoms Plans are well underway to build on the success of last year's event with WELA NDO working closely with LARA, Sheila Roper Community

Centre and Afterschool Club, local schools, the University and other NCC and VCS partners. Please look on the WELA facebook page for upcoming news and dates.

Neighbourhood Transformation Plans – detailed Action Plans on tree planting and old allotment sites in Lenton Abbey led by NDO are currently being updated and implemented with Allotments Service, Ward Councillors, NCH, CPO's, CP Enforcement, City Services and and Community Payback partners. Allotments on Brook Road, off Manton Crescent and off Woodside Road using Ward Cllrs, NCH and Allotments Service budgets have been cleared over the last few months and brought back into use are to be let out to new Allotment holders. Building on the 'Grow For It' campaign. Further works on fencing on Woodside Road 'the Blossoms' will add to enhancements and transformation on this city gateway route. Building on the success of the Trees For Cities Project delivered in WELA ward in February 2015 with overwhelming resident support. Allotments Service working with WELA NDO have engaged new residents to take on waste/ 'no man's' land on the corners of Enderby and Bosley Squares for cultivation. These Action Plans and Gateway To Nottingham Plans are monitored through the Neighbourhood Action Team meetings.

**Area Capital and Public Realm Funds – s**ince the last Area 7 Committee in September 2015 a new TRO and timed parking zone has been implemented opposite the shops on Woodside Road to resolve parking issues and improve parking and access for disabled and elderly customers. Phases 2 & 3 of Woodside Road Parking scheme are currently being planned to reduce damage to the verges and help create off road parking which will help to transform this major City Gateway route. A survey will inform decisions about further Residential Parking zone schemes in the Charles Avenue area and Traffic Safety measures are currently being considered.

### Issues:

The Experimental Traffic Restriction Order (TRO) in Lenton Abbey has now been fully implemented. We are currently monitoring emerging parking issues in Lenton Abbey. The 1<sup>st</sup> Phase of works have been completed on Woodside Road. Phases 2 & 3 of Woodside Road Parking scheme are currently being developed influencing and complementing designs and plans for the Cycle Ambition Western Cycle Corridor on Woodside Road.

Half Term Youth Activities programme – In order to address the increase in Anti-Social Behaviour by some young people in Lenton Abbey over the Easter holidays a strong Summer Youth Activities programme was developed by WELA NDO and various partners delivering across the whole summer in Lenton Abbey Park and in different sites in Wollaton Park estate. It has increased community engagement with young people and involvement in term time provision. This has been built upon with further delivery.

Cycle theft has decreased on the University of Nottingham campuses over the last 6 months with the Police and Sustrans working closely with University security staff. Although dwelling burglary has increased in September, there has been a decrease from April 2015 in comparison to 2014 Year to Date. In response WELA NDO in partnership with Nottinghamshire Police, WELA Ward Councillors and Crime and Drug Partnership have developed a Crime Prevention Target Hardening Project which has continued to be rolled out from March 2015 to WELA's most vulnerable residents. On both issues the Neighbourhood Police Beat Team have responded with swift action and successful local operations resulting in arrests and suspects being charged.

### **Events:**

During this quarter a range of events and meetings have and are due to take place including TRA's and Local Action Group ( ) meetings, Sheila Roper Community Centre

Management Committee, LAFFDA (planning for Lenton Abbey Fun Day), Community Meetings, Wollaton Park Resident Association local issues meetings. Working in partnership with TRA's and NCH there will be some development work to increase resident and tenant involvement in local groups to enable continued participation and representation following the change in Tenant Panels.

The NAT (Neighbourhood Action Team) which has representation of various key service providers across the Ward are currently delivering on the revised and refreshed Ward Priorities. There has been strong partnership working on the Allotment Action Plan led by Neighbourhood Services NDO, working with Allotment Services, NCH, Community Protection and City Services on patch operations on clearing allotment sites, to reduce ASB and enforcement of Allotment Hiring Agreements which have brought some allotment sites back into use and back into cultivation. We have extended this positive partnership to bring other overgrown 'no man's land' green sites into cultivation by local residents. We are still working closely with the HMO Team on the additional HMO registration in Wollaton Park estate which should improve contact with HMO landlords. Partnerships have been further strengthened with Stonewater Housing Association, addressing resident issues and ASB impacts and Sheila Roper Community Centre.





July – September 2015 Data

<u>Wollaton West</u> – Wollaton is a pleasant, residential area located in the suburb of Nottingham. Wollaton West has a total of 14,741 residents, 7,267 are male (49%) and 7,474 are female (50.7%). Within Wollaton West 8.4% of all adults smoke, this is the lowest within Nottingham City, 48% of all adults are estimated to be overweight/obese which is marginally higher than the City average but not significantly so.

Life expectancy for males is 83.1 years which is significantly higher than the national figure and life expectancy for females is 88.6 years which is significantly higher than the national figure. Wollaton West is ranked as the 5,026<sup>th</sup> most deprived out of England 7,589 wards and the least deprived in the City. It has some of the most desirable housing in the city. Key spots in the area are Wollaton Hall and Park, together with Martin's Pond, Harrison's Plantation and Raleigh Pond (local nature reserves).

<u>Wollaton Village</u> still retains a village type atmosphere, with its tree lined roads and a handful of local shops. Although part of the City of Nottingham, Wollaton Hall and the deer park create the illusion that the village is away from urban living.

# **BUSINESS ENTERPRISE**

There are a small number of small and medium enterprises (SME's), particularly around Bramcote Lane, Crown Island. Bramcote Lane shops offer a reasonable variety whilst Crown Island shops are somewhat more limited.

**HOUSING** – Wollaton West has higher house prices than other wards within the City. The area is largely owner occupied. Wollaton West has a higher percentage of older people (65+). These residents account for 20.1% of the ward population.



- The WELA ward has a growing diverse community in Lenton Abbey with 74% white British and 6% other white some of whom have English as another language and others of mixed heritage, Black British and Caribbean and Asian origin. The 2012 Insight and 2010 ONS statistics are slightly skewed by the transient student population mainly studying at University of Nottingham.
- Wollaton Park estate has a hidden community of disabled children, young people and older adults and due to caring responsibilities have pockets of fuel poverty.
- In the top 10% nationally of SOA's for Crime and Disorder and Income Deprivation affecting children. However reported crime figures have generally fallen across the ward compared to the previous year.
- Wollaton Park estate have seen a growing number of HMO's and are experiencing increasing problems with their landlords.
- Ongoing car parking and traffic issues across the Ward

#### 1. REASONS FOR RECOMMENDATIONS

- 1.1 The Nottingham LTP strategy 2011-2026 maintains a commitment to deliver local transport improvements across Nottingham's Neighbourhoods and prioritises small scale transport improvements of importance to local communities.
- 1.2 As part of the budget process Nottingham City Council approved in March 2015 an LTP capital allocation of £1.25 million citywide between 2015 2016. In addition for 2015-2016 a Public Realm General Fund has been approved of £750,000 Citywide.
- 1.3 To give opportunity for the Area Committee to make comment on suggested schemes and their progress.

#### 2. BACKGROUND (INCLUDING OUTCOMES OF CONSULTATION)

- 2.1 The Area Capital Programme was established to improve the environment of the neighbourhoods and to create a sense of place for residents in order to improve the quality of life of local people. Since it was established in 2006 to meet the then corporate priority of "Transforming Neighbourhoods" the Area Capital Fund has included a total programme expenditure portfolio of £40 million. The improvements that have been carried out to date using this programmed have included footpath, fence, visual enhancements to public realm, refurbishment of parks and improvements to public buildings.
- 2.2 Resources are allocated from the Nottingham City Council General Fund, the Local Transport Plan (LTP) and from the Housing Revenue Account. To achieve a joint approach to environmental improvements in neighbourhoods, a greater degree of flexibility has been established to prioritise and deliver improvements so that there is a synergy in local solutions for local issues across neighbourhoods.
- 2.3 The programme of works is a rolling programme. There have been instances where schemes are started, with strong community involvement and interest, only to be altered at a later stage due to changing circumstances such as economic conditions and changes in land values.
- 2.4 The Area Committee, particularly community representatives, are invited to comment specifically on those schemes identified in the proposals column and also to consider whether certain schemes can be linked to other programme of work in order to generate best value and create a greater impact on the local area.
