REPORT OF HEAD OF DEMOCRATIC SERVICES

1. Purpose

To update members on the terms of reference for the Children and Young People Scrutiny Committee.

2. Action required

The Committee is asked to note the purpose and remit of the Children and Young People Scrutiny Committee, as detailed in the terms of reference (appendix 1).

3. <u>Background information</u>

- 3.1 On 9 September 2015, Full Council established the Children and Young People Scrutiny Committee to provide robust scrutiny of issues and services relevant to the wellbeing and safeguarding of children and young people in Nottingham.
- 3.2 The Jay and Casey Reports on Child Sexual Exploitation, and how it was addressed in Rotherham, drew specific attention to the need for better local authority scrutiny to contribute to the protection of children and young people, through listening to local people, influencing policy and holding decision makers to account.
- 3.3 During its inspection of services for children in need of help and protection in April 2014, Ofsted noted that whilst Nottingham City Council's Overview and Scrutiny Committee receives a copy of the Nottingham City Safeguarding Children Board's (NCSCB) Annual Report, the governance arrangements were not sufficiently robust and the Committee does not hear directly from the NCSCB independent chair on safeguarding issues.
- 3.4 The Committee will meet on a bi-monthly basis and have a responsibility in relation to children and young people to:
 - (i) provide an appropriate and robust level of challenge to those in authority and hold local decision-makers, including the Council's Executive, to account for their decisions, action and performance;

- (ii) review policy and contribute to the development of new policies and strategies of the Council and other local decision-makers where they impact on Nottingham's children and young people;
- (iii) explore any matters affecting Nottingham's children and young people;
- (iv) make reports and recommendations to relevant local agencies in relation to the delivery of their functions, including the Council and its Executive, and monitor implementation of all accepted recommendations.

Children and Young People Scrutiny Committee

- (d) To invite, take account of and respond to the views of local people (including children and young people) about their concerns and the delivery of services in relation to children and young people.
- (e) To be required to consider the following issues / topics when developing the work programme, though the Committee's scrutiny activity need not be limited to these matters:
 - (i) Safeguarding
 - (ii) Looked After Children
 - (iii) Vulnerable Children and Young People (eg in relation to disability, domestic violence, missing)
 - (iv) Child Sexual Exploitation
 - (v) Early Intervention
 - (vi) Educational Attainment
 - (vii) Commissioning of Services for Children and Young People
 - (viii) Performance of Services for Children and Young People

- (f) To consider potential risks to children and young people, how they are being managed and to report concerns as soon as possible to the appropriate individuals/ bodies if risk is identified;
- (g) To monitor the progress made by, and effectiveness of the Council and its partners, in addressing the areas of concern and specific recommendations for actions made by Ofsted and any other relevant inspection/ assessment bodies;
- (h) To have regard to the work of other committees/ panels/ boards, such as the Corporate Parenting Board and the Local Safeguarding Board, to avoid duplication, but to ensure that such bodies are held to account when appropriate;
- (i) To refer any health issues in relation to children and young people to the Health Scrutiny Committee.

Membership

Membership will include the Chair of the Overview and Scrutiny Committee who will also chair this Committee:

When the Committee plans to consider an education issue, the statutory education co-optees* must be invited to be full and equal members of the Committee with voting rights for that specific item.

CHILDREN IN CARE - UPDATE

REPORT OF HEAD OF DEMOCRATIC SERVICES

1. Purpose

To consider a brief overview of the current demands and to receive an update on Nottingham City Council's Children in Care.

2. Action required

The Committee is asked to consider an overview of Nottingham City Council's arrangements for Children in Care.

3. Background information

- 3.1 The term looked-after children or children in care refer to all children under the age of 18 being looked-after by a local authority. It includes both those subject to a care order under section 31 of the Children Act 1989 and those looked after by a volunteer agreement with their parents under section 20 of that Act.
- 3.2 Once a child becomes looked after, children may be placed by the local authority with a family member, foster carers or in a residential children's home. The purpose of the care system is to look after children where parents are unable to do so for a variety of reasons. These include situations where parents are abusive or cannot provide adequate care, or where there is no parent or relative available, such as unaccompanied asylum seeking children or those whose parents have died.
- 3.3 The welfare of all children and young people in the local community is a top priority for any local authority. Safeguarding ensures that children are kept as safe as possible by identifying needs, views and any risks they face.
- 3.4 Over the last five years overview and scrutiny committees have become increasingly aware of the need to consider the effectiveness of local safeguarding arrangements. This was highlighted by Professor Jay's 2014 Independent Inquiry into Child Sexual Exploitation in Rotherham and the response by the Communities and Local Government Select Committee.

Children in Care or Looked after children

3.4 Since 2012 there have been a number of significant changes to the legislation and policy context for looked after children. Whilst many of the

underlying principles of good practice remain the same there has been a renewed impetus to improve and develop the system. This has included:

- A new drive to speed up the adoption process for children by establishing clear time frames and 'fostering for adoption' regulations.
- The 'staying put' framework to enable care leavers to remain living with their foster families till the age of 21 to support them in education and training.
- New quality standards for children's services in general and for the health and wellbeing of looked-after children in particular.
- A focus on narrowing the gap in educational attainment for looked-after children by introducing the Virtual School Head (VSH) role and implementing the use of Personal Education Plans (PEPs).
- New regulations for children's homes with a focus on quality, management and leadership.
- A new national level multi-departmental Care Leavers Strategy.
- 3.6 Children in the care of a local authority are one of the most vulnerable groups in society. The majority of children in care are there because they have suffered abuse or neglect. At any one time around 68,000 children are looked after in England with over 90,000 passing through the care system each year.
- 3.7 There has been an overall increase in the numbers of children entering care country-wide since 2007 and a rise in the proportion who are removed through the intervention of the courts as opposed to coming into care by agreement with parents.
- 3.8 When elected, all councillors take on the role of 'corporate parent' to children looked after by their local authority. There is a duty to take an interest in the wellbeing and development of those children. The scrutiny function provides a key way in which councillors can fulfil this responsibility as it presents an opportunity to ask questions to service providers and assure themselves that the systems are in place to ensure children in care are being well looked-after.

Focus for review of children in care

3.9 As of 1 October 2015, Nottingham City Council was responsible for 601 children in care in the city, which equated to 94 children per 10,000 population. In the 2014/15 financial year 70 children in our care were adopted. At 1 October in 2015/16 financial year 44 children in our care have been discharged as a result of permanent outcomes, such as Adoption Order, Child Arrangement Order or Special Guardianship There are 7 children's homes, which are registered with OFSTED, and 5 Semi-independent homes preparing young people to leave care.

3.10 Nottingham City Council provides educational support for children in care via a Virtual School. The Virtual School for children in care is a cross phased school supporting children in care from 4 to 18 years and keeps track on how pupils are progressing. The school works collaboratively across various departments within Nottingham City Council, external organisations and schools to ensure that the Council's cohort of children in care receive the best education possible.

Included in this are requests for children to become Looked After by Nottingham City. The increase in the number of children coming into care (or becoming Looked After) is a trend mirrored nationally. This trend is reflected through our current Statistical Neighbour Average (SNA) of 784 children in care (CiC). Our aspiration is to perform significantly better than SNA and as a result, we have set an ambitious out-turn target of 575 children in care for the year 2015/16. Despite this target being set significantly lower that the SNA, based on our 2014/15 performance, this target is achievable, providing wider socio economic factors and pressures remain stable. Year To Date (YTD) figures show that there are 601 children in care. Work is underway to reduce this figure by exiting children from care via permanent outcomes (e.g. adoptions orders, special guardianship orders and child arrangement orders), as well as preventing admissions into care when it safe to do so.

At half through the year, we are over half way to achieving the target set for 2015/16 (with the YTD figure and target being 44 and 75, respectively).

The YTD figure shows that we are currently underperforming by 6.7% when compared to our 2015/16 target. Factors that have contributed to our current performance include - delays in arranging appointments for children placed outside of Nottingham City boundaries - noncompliance of young people to attend appointments once they have reached 16 years old - capacity issues within the Children in Care Heath Team still remain although the impact that this has on performance has reduced this financial year - there continues to be an issue with missed appointments Remedial action to address issues in performance is discussed during regular meetings between the Children in Care service and health colleagues.

Although our current performance is 7.5% below our target for 2015/16, our performance this year, month on month, has been better or on par with our 2014/15 out-turn. The issues of missed appointments and noncompliance of young people aged 16 years and over have contributed to our performance. However a contributor to the figure reported are issues relating to inputting data. A recent push in data inputting and shift to data being inputted by business support colleagues has led to the improvement in performance recoded in September.

As a result, capacity to undertake these tasks has been recently created in within business support. It is anticipated that action will lead to an increase in performance.

This can be attributed to our close working relationship with Nottingham City Homes (NCH) and the robust protocol is in place with NCH to prevent eviction and homelessness.

This has an impact on the performance recorded. Despite this, current performance is 5.9% above our 2015/16 target. Performance overall, has improved as a result of the introduction of the Employability Personal Advisor who is tasked with linking care leavers with employment, education and training opportunities. Recently a £2,500 grant was secured through this post. The grant will support young people access physical activity opportunities.
