### 65 NOTTINGHAMSHIRE POLICE

Inspector Gordon Fenwick of Nottinghamshire Police, provided an update to the Committee, highlighting the following points:

- there has been a recent split in the geographical areas covered by Inspectors, and a reorganisation of the Police. As a result, the Wollaton and Lenton Abbey area is now covered by 2 Police Inspectors;
- (b) in the Lenton area, crime in general is comparable to levels last year, but with one issue there has been a significant increase in shed burglaries. An arrest has been made of a prolific offender so shed burglary figures will come back down;
- in the Wollaton area, the biggest problem from residents is of people speeding in the 20mph zones. Nottinghamshire Police have carried out 10 operations, with additional operations conducted by Response Officers with hand held devices. This intervention has received positive feedback. A local Officer has been tasked to investigate the possibility of a community speed watch. Crime in general has decreased by 20%, apart from slight increase in burglary dwellings which will be investigated further.

There were a number of comments and questions from the Committee:

- (d) the Committee offered thanks on the issue of speeding in 20mph zones. It has been very positive to see a number of speed traps on key 20mph roads, and these traps are welcomed by local residents;
- (e) there is an ongoing speeding issue on Grangewood Road. As it is a wide, straight road, drivers speed along it to beat the congestion. Whilst there have been speed cameras deployed in Grangewood Road, it hasn't been in the evening when the main problem occurs. Speed traps in the evening would be more beneficial;
- (f) Cllr Sam Webster wished to put on record his concern that there was a lack of detail in the report. He understood that the Area Committee is now covered by 2 Police Inspectors but wanted to ensure that future reports have detailed information from both wards covered by the Area Committee;

- (g) the Committee noted that the Police last reported to the Committee in May, and that area committees are often the only opportunity there is to update communities across the ward areas. The Area Committee requested a briefing note to be attached to future agendas with crime statistics and figures over a period. However, information to be attached to agendas needs to be available several weeks in advance of the meeting, and at meetings with Councillor Graham Chapman, it has already been agreed that Police will prepare a briefing document to be presented at area committees, rather than in advance, so that it contains the latest relevant information;
- (h) as students have only just returned from summer holidays, there aren't any detailed student crime figures available as yet. There has been one incident involving an office premises on campus being broken into, but an arrest has been made. There has also been an increase in thefts of bicycles from campus. Safeguarding of students is on ongoing part of the Police's work;
- (i) at the start of term there is a student week of action, which involves multi partnership working over a couple of weeks. Specific small A5 cards have been delivered to hot spot streets, and door knocking has taken place to encourage engagement. There have also been some stalls in Lenton and Dunkirk involving a multi partnership approach, and a coordinated approach has taken place with both universities. The student unions are also involved in planning and in the practical aspects such as the door knocking itself.

RESOLVED to thank Inspector Gordon Fenwick for the update, and note its contents.

### 66 ISSUES FROM COMMUNITY REPRESENTATIVES

### 66A ITEMS OF GOOD NEWS

A number of issues were raised from the community. Some positive news from the area over recent months was offered to the Committee:

- (a) the first Wollaton arts festival was held in July. The event was a great success, with lots of residents, schools and organisations taking part, and it is hoped that it will improve year on year;
- (b) medals were presented recently to 350 children and young people who completed the Summer Reading Challenge, of reading more than 6 books. A special prize was awarded to a young man who read 70 books. The event would not have been possible without the help of local volunteers;
- (c) this summer saw a Good Garden Award event, and a popular and enjoyable tea party;
- (d) a Green Flag was awarded to Wollaton park. The award of the Green Flag was dependent on the park having a Friends Group, so it would not have been possible without them.

RESOLVED to note the items of good news.

### 66B TRAINING OF COMMUNITY REPRESENTATIVES

Pauline Dorey, Neighbourhood Development Officer, provided details on a training event for Community Representatives. A refresh of training combined with a celebration event will be held on 15 October 2016, and all Community Representatives will be invited. The event will be a celebration of the role of Community representatives, and an opportunity to share best practice. It will include a workshop training element.

### **RESOLVED** to note the training date.

### 66C RADFORD BRIDGE ROAD ALLOTMENTS UPDATE

Jenny Cole, Planning Officer, updated the Committee on the Radford Bridge allotments, highlighting the following points:

- (a) work started on the site in March 2016, which included road and land lay out of allotments. Stop notices were served in April / May to prevent work continuing on site, surrounding non-compliance of conditions. Developers started the appeal process in June, with statements due towards the end of September. In July developers submitted details to discharge some of the conditions, relating to layout of the allotments, drainage, and location of the road;
- (b) discussions are ongoing regarding the appropriateness of the documentation that has been submitted, and ecology conditions have almost been agreed. The main areas of concern are the allotment provision and infrastructure, and the management plan.

The Committee offered questions and comments on the development, and further information was provided in response:

- (c) allotment renters have been strung along, and been told a move is imminent for a number of months. In the meantime, a year's worth of gardening has been lost. There is a worry that unless the issues are resolved in early 2017, another year will be lost. There is a real onus to resolve this properly in the next 6 months;
- (d) the residential part of the development will happen as part of phase 3, from around the end of 2017 to the beginning of 2018. Timetables are difficult to gauge, as details have not been submitted yet;
- (e) if the appeal against the stop notice is successful then the enforcement notice will fall away. However, the developers are starting to correct things and submit documentation, and are in ongoing discussion.

RESOLVED to thank Jenny Cole for the update, and note its contents.

### 66D ARLESTON DRIVE PARKING / CAMERA LOCATION

Councillor Steve Battlemuch, Chair of the Committee, provided an update:

(a) as in every school, there are ongoing issues and tensions at Fernwood Primary and Nursery School between parents who drive their children to school, parents who walk their children to school, and people who live close to schools. These tensions sometimes bubble over. The issues at Arleston Drive were ongoing long before the

extension to the school was proposed. As a positive approach there's been engagement between Councillors, school staff, parents, and residents. A week of action in April was very successful. Signs designed by children have gone up outside the school, and since the last Area Committee there was a meeting with parents, the Traffic Team and local Councillors. What became clear from the consultation was that there were lots of different ideas, but only a few practical and affordable ones:

- extension of double and single yellows on key roads around Arleston;
- a new walk in entrance;
- encourage more families to walk to school;
- if they are going to drive, encourage parents to park further away and walk to school:
- enlist parent volunteers for a "park and stride" scheme, where accredited volunteers walk children to school from a nearby car park;
- more parking enforcement cameras. Whilst these are used only for enforcement on zig zag lines, even having a visible camera nearby would be a deterrent on inconsiderate (but not illegal) parking as well.
- (b) a bid has been submitted for a camera when a council wide scheme is expanded. Funding has been agreed for the extension of yellow lines. Councillor Battlemuch will report back on the other ideas.

The Committee asked some questions about the issues and proposals, and Councillor Battlemuch provided further information:

- (c) whilst there are traffic calming measures and chicanes already present around Fernwood, this issue relates to illegal, dangerous or inconsiderate parking, rather than speeding;
- (d) there are some minor issues around Fernwood Academy as well, as even though the pupils are aged 11-16, quite a few parents still drive their children to school. However, they have not been on the same scale as the problems surrounding Fernwood Primary School.

RESOLVED to thank Councillor Steve Battlemuch for the update, and note its contents.

### 66E CYCLE PATH JUNCTION AT MIDDLETON BOULEVARD: SAFETY ISSUES

John Bann, Cycling and Road Space Transformation Manager, presented an update to the Committee:

- (a) the aim of the main scheme was to improve the junction and keep traffic moving. At the same time, as a long standing route, money was spent on resurfacing paths and giving more priority to pedestrians and cyclists;
- (b) the City Council has ambitions to have a world class cycling network. This has been a significant route linking residential areas, hospitals, universities, industrial estates etc. Up to now cyclists had to give way at side roads. The new layout is quite unusual, as cyclists have right of way. Work has been completed in consultation with the Road Safety Team there are 3 stages to the safety audit. The third stage is following installation of works to consider how the new design is working;

- (c) temporary cameras have been added to some junctions on Middleton Boulevard to monitor how the new designs are working. The visibility on the side roads on Middleton Boulevard is not as good as some other locations. Whilst the cycle path is not wide enough to warrant a direction-segregation white line, following feedback, one will be painted on;
- (d) the average speed of cyclists using the path is 10-12 miles per hour, with a maximum speed recorded of 16 miles per hour. Users tend to slow at the side roads as the path is not as straight. A traffic survey showed 400 vehicles using the side roads, with only around 7% interacting with a cyclist. Local residents have highlighted many issues which will be addressed.

The Committee asked some questions about the issues and proposals, and John provided further information:

- (e) residents near Wollaton Park reported that they are concerned, as the give way junction stops vehicle users between 2 hedges, with very poor visibility. The main entrance to Wollaton Park is now not wide enough for 2 vehicles to safely pass each other, and if a car stops on the way into the turning, the vehicle is still partly in the road. John took a note of these issues and will look into the location of the give way line and the width of the access road;
- (f) work is ongoing with the Student Unions to communicate the new Road Safety protocol;
- (g) "keep clear" markings cannot be added at the Harrow Road junction, as such markings cannot be placed along zig-zag lines which are present near a pedestrian crossing;
- (h) residents who live on Radford Bridge Road, Charlbury Road and related streets have been concerned for some time about access from Radford Bridge Road onto Crown Island. This has got worse since the ring road works were completed as there is an extra lane now that cars have to get across in order to exit Crown Island towards the City Centre, towards QMC or towards Wollaton. Residents were promised that road sensors would be placed on Radford Bridge Road in order to link to the traffic lights and allow more time to exit the junction. The Committee requested that an update be provided to a future meeting.

RESOLVED to thank John Bann for the update, and note its contents.

### 67 NOTTINGHAM CITY HOMES - UPDATE AND APPROVALS

Paul Howard, Tenancy and Estate Manager at Nottingham City Homes, updated the Committee on performance and requested funding for 2 schemes. Whilst a long-standing anti-social behaviour issue has been resolved, there has also been a seasonal increase in the number of anti-social behaviour cases, mostly relating to tenants' gardens. Tenancy sustainment is very high in both wards.

Lylse-Anne Renwick and Pauline Dorey, Neighbourhood Development Officers, presented the Area Capital Fund report to the Committee.

  - £1,200.00 for the installation of street name plates in the Farndon Green area;
- (2) approve the following Area Capital Fund programme of LTP schemes for Wollaton West:
  - £9,500.00 for a residents parking scheme and junction protection in the Bramcote Lane area;
  - £10,250.00 for the provision of a vehicle activated sign facing inbound traffic on Torvill Drive:
  - £7,250.00 for parking restirctions on Glenwood Avenue and other roads as appropriate;
  - £4,900.00 towards provision of permit parking zones in St Leonards, Rectory Gardens and Parkside areas;
- (3) approve the following Area Capital Fund programme of Public Realm schemes for Wollaton West:
  - £15,100.00 towards provision of permit parking zones in St Leonards, Rectory Gardens and Parkside areas;
- (4) note the following 2016/17 Area Capital Fund allocation:
  - £66,375.00 remaining balance available for Wollaton East and Lenton Abbey;
  - £738.00 remaining balance available for Wollaton West.

### 69 AREA 7 WARD REPORT

Lylse-Anne Renwick, Neighbourhood Development Officer, presented the Wollaton West Ward Report to the Committee:

(a) recently a lot of cars have been broken into, but a lot of these cases have involved keys and valuables being left in cars. There have also been occasions where children have been left in cars whilst parents go for a run;

- (b) there have been falling numbers at the youth cafes. New leaflets will be produced. Previously the service was only offered to 13 to 19 year olds, it will now be offered to 10 to 17 year olds to try and increase numbers;
- (c) there was a summer programme of activities, some were quite successful.

Pauline Dorey, Neighbourhood Development Officer, presented the Wollaton East and Lenton Abbey Ward Report to the Committee:

- (d) there was a very successful Wollaton East and Lenton Abbey Children and Young People Summer Programme, with 60 families engaged. A review meeting will shortly be held to obtain formal feedback from partners. The summer programme covered some sessions on Wollaton Park which enabled citizens from both wards to use the sessions;
- (e) there have been a variety of consultations across both wards. The Woodside Road parking scheme phase 2 has now finished, and consultation on phase 3 has finished;
- (f) local residents are being asked to vote to support a funding bid to refurbish the Sheila Roper Centre;
- (g) the external wall insulation project in the ward is coming to an end. Feedback will be coming soon from a review of the scheme. It will be interesting to see local residents' experiences;

RESOLVED to thank Lylse-Anne Renwick and Pauline Dorey for the report, and note the contents.

### 1 REASONS FOR RECOMMENDATIONS

1.1 From April 2013, the public health function was transferred to local authorities as a result of the Health and Social Care Act 2012. The Council subsequently became responsible for improving the health of their local population including health improvement, health protection and the commissioning of public health services.

Councillors are directly involved with their local communities and able to understand and identify the needs for health and wellbeing services specific to the local population.

Over the past 18 months, Councillors have had a series of meetings with public health and commissioning colleagues to consider local health data and experiences of local residents in order to support the planning and provision for local health and wellbeing services commissioned by the Council.

This report is an update of the work to date, including the engagement and information provided by Area Committee members on the remodelling of the healthy lifestyles public health services. Committee members are invited to consider the work so far and advise on next steps.

### 2 BACKGROUND (INCLUDING OUTCOMES OF CONSULTATION)

2.1 Local health profiles were developed by the Public Health team using nationally available data to better understand the health and wellbeing needs of local residents. The data was arranged at Nottingham Ward level to enable commissioners and Councillors to have a clearer picture of the health and wellbeing needs for their ward compared to Nottingham overall and to wards across England. Councillors from each of the Nottingham City wards met to discuss the data profiles and to add further insight that would enable a greater understanding of local need.

School health and area committee level health profiles were also produced to aid local understanding and planning. Public health services were mapped and included within directories for each area; these were presented to Area Committees during 2015.

Area Chairs as part of their Area Cluster Review process invited Public Health to present the health profiles and local health priorities. It was identified that further awareness and understanding of the commissioning process for public health and health services would be useful in a separate session.

The commissioning awareness session was well attended by Area Chairs and Councillors and received good feedback and requests for further sessions that were

more topic focused such as teenage pregnancy, smoking and mental health in young people. Part of the session included an overview of the modelling and engagement of a live commissioning review. Councillors agreed to contribute to the live review through a series of questions discussed with their respective Area Committees. The responses to the consultation and an overview of how the results from the consultation have been considered are included in the appendices to this report.

### **Area Committee – Wollaton and Lenton Abbey**

## Engagement with the consultation on the recommissioning of healthy lifestyle services

In July this year, a number of area clusters were invited to contribute to a consultation on the redesign of healthy lifestyle services to support the procurement of new services for the city. These included services supporting people to stop smoking, increase physical activity, and to achieve and maintain a healthy weight.

The information from this engagement helped to inform the development of a new model to better reflect local need. The new services aim to improve access, uptake and effectiveness; the new services are currently out to tender and due to start from the 1<sup>st</sup> April 2017.

The consultation asked five questions:

- 1. How can we support citizens to access services which will help them to have a healthy lifestyle?
- 2. What are the barriers/gaps?
- 3. What enablers can help overcome these barriers?
- 4. How can we make services more attractive for hard to reach groups?
- 5. What works well in your area?

As part of these discussions, Councillors identified a number of common key issues affecting the different areas including valuable detail on specific issues at local community level. Common themes included:

- Alcohol and drug misuse, impacts on individuals and communities
- Mental health and wellbeing including loneliness and isolation
- Healthy eating and cooking skills
- Sexual health
- Prevention messages and healthier living including access to services
- Smoking including tobacco linked crime

Key barriers and gaps included:

- Citizens not registered with GPs
- Fear, apathy and not knowing where services are located
- Lack of resources
- Lack of suitable activities/services
- Getting information to those who need it
- Not enough focus on prevention

The findings from the consultation will be summarised and presented at the Area Committee Chairs meeting to inform the on-going knowledge and information needs of the Chairs. Potential next steps could include:

- Briefings on specific agendas e.g. teenage pregnancy, mental health, smoking in young people
- Further training sessions on specific agendas affecting the public's health

- Providing information for local newsletters
- Health input to the planning for ward walks
- Further information of commissioned public health services

Area committees may wish to identify areas that may be included in their ward and area plans. Area Committee members are invited to comment and consider how local needs to improve health may be addressed.

#### 1 REASONS FOR RECOMMENDATIONS

- 2.3 The programme of works is a rolling programme. There have been instances where schemes are started, with strong community involvement and interest, only to be altered at a later stage due to changing circumstances, such as economic conditions and change in land values.

1.1 Each Ward manages a set of priorities and key issues through regular meetings of its Neighbourhood Action Team (NAT). These meetings are led by Neighbourhood Development Officers (NDOs) and supported by core partners including Nottingham

- City Homes (NCH), Neighbourhood Policing, Community Protection, Children and Early Help, City Services / Waste Management; Notts Fire and Rescue Services.
- 1.2 Ward Councillors are also invited to participate in these meetings.
- 1.3 Ward Priorities are identified and informed from a range of sources including Citizens, Councillors, Partners and Officers and current issues will be updated for each Area Committee.
- 1.4 The list of events and activities will take account of the work which all NDOs undertake with partner organisations within their Ward and shows the depth of activity in place working alongside Neighbourhood Management to improve social cohesion and tackle priorities at a ward and area level.

#### 2. BACKGROUND (INCLUDING OUTCOMES OF CONSULTATION)

- 2.1 The Wollaton East and Lenton Abbey and Wollaton West wards sit within the wider Wollaton & Lenton Abbey Area Committee which adopted four Area Based Priorities at its first Area Cluster meeting – 'Safe and Clean Neighbourhoods', 'Young People', 'Health and Wellbeing for Older People' and 'Parks, Open Spaces, Leisure and Culture'.
- 2.2 These priorities demonstrate a link to the City Council's current ambitions contained in the latest City Council Plan 2015 2019. Actions for each Priority will be developed and led by appropriate Service Teams and partnerships. The Area Priorities were reported to the Wollaton & Lenton Abbey Area Committee on 16<sup>th</sup> May 2016 and will be updated on a regular basis to Area Committee.
- 2.3 The Area Priorities listed in 2.1 sit within wider pieces of work and broader agendas which are being addressed by multi agency approaches across the City. At a Ward level it is important to identify how some of these more complex priorities can be worked on at local levels either Ward or Area by introducing local solutions. This could, for example, include more targeted use of funding such as Ward Councillor budgets to support healthy eating initiatives or the use of Area Capital to develop an outdoor gym facility.
- 2.4 The current Ward Priorities which have been reported previously through the Area Committee Performance Reports are shown in Appendix 1 in each ward attachment. These priorities will be updated for each Area Committee, taking into account discussions at NAT meetings and various groups and activities involving local residents.
