



**NOTTINGHAM CITY COUNCIL (THE VICTORIA EMBANKMENT, NOTTINGHAM) (OFF-STREET PARKING PLACES AND RESTRICTED PARKING AREA) ORDER 2015 (OSP 8017)**

**NOTICE IS HEREBY GIVEN** that Nottingham City Council proposes to make an Order under Sections 32, 35, 35A (1) (3) and 39 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and by the virtue of Section 74 of the Traffic Management Act 2004 ("the 2004 Act") as amended and all other enabling powers, in respect of roads in the City of Nottingham being a Civil Enforcement Area (CEA).

The effects of the Order will be, to introduce a new pricing structure to the Off-Street Parking Places within the Victoria Embankment that will operate 8am to 5pm Monday to Friday inclusive. Shown in Schedule 1 to this Notice, and to amended the articles as listed in Schedule 2 to this Notice, in order that a Civil Enforcement Officer can issue a Penalty Charge Notice to any vehicle that is contravening the Order below:-

**SCHEDULE 1**

**New Pricing Tariff**

<b>Car &amp; Vans</b>	<b>Disabled Badge Holders</b>	<b>Motorcycles</b>
First 2 hours free More than 2 hours = £2.00	First 3 hours free More than 3 hours = £2.00	First 2 hours free More than 2 hours = £2.00

To qualify for the free parking, the driver/rider must register by phone to the Council's agent (*Advertised on site*). For Disabled Badge Holders, they must display the disabled clock and identify the time they parked.

**SCHEDULE 2**

1. To impose a Restricted Area to the whole of the Victoria Embankment which prohibits parking 'At any time', except in designated parking place between the hours of operation 8am – 5pm on Monday to Friday inclusive, including bank holidays as shown in Appendix B to the Order.
2. Definition: - D44. "Restricted Area" is defined as grassed areas, road or parts of a road within the limits of the ground of the Victoria Embankment and defined by the blue boundary line in Appendix B to this Order.

This Order will bring the Victoria Embankment Off-Street Parking Places in line with the Council's current working practices and policies and ensure it is fully up to date with current legislation and guidance.

The usual exemptions will be provided, for example: to vehicles waiting with the permission of a Police Constable in uniform. Copies of the Order and map may be inspected between the hours of 9.30 am and 4.00 pm – Monday to Friday either at the Local Studies Library, Central Library, 1st Floor, Angel Row, Nottingham or at Loxley House, Station Street, Nottingham by appointment made by telephoning 0115 8765244. Written objections (stating grounds and quoting ref: **OSP 8017**) must be received by me by the **21<sup>st</sup>** day of **October 2015**.

The Order is intended to manage the Victoria Embankment area and help stop indiscriminate parking on the grassed area or other identified restricted areas (Double yellow line).
