#### **Nottingham Castle Conservation Management Plan**

# 1 **SUMMARY**

Nottingham City Museums and Galleries Service and the Nottingham Castle Project seek approval and adoption of the comprehensive Nottingham Castle Conservation Management Plan prepared for Nottingham City Council by Rowenna Wood, Senior Heritage Consultant from Purcell Architects.

The Nottingham Castle Conservation Management Plan is a document which sets out the heritage significance of the site and provides a new policy framework on how this significant asset should in the future be conserved and managed during any repairs, maintenance or future development.

# 2 RECOMMENDATIONS

That Planning Committee note the Nottingham Castle Conservation Management Plan and recommend its approval by Council, and adoption by Nottingham City Council as a document of best practice for the management and development of the Nottingham Castle site.

# 3 BACKGROUND

The production of the Nottingham Castle Conservation Management Plan (CMP) has been undertaken as part of the redevelopment of Nottingham Castle. Adopting and putting in place a Conservation Management Plan is fundamental to good stewardship and management of historic assets and a requirement when embarking on any major change or developments.

The purpose of the CMP is to provide an assessment of the values of different architectural elements, detail any special permission required regarding potential works and to provide clear recommendations and approaches for the conservation and management of a historic site. The CMP, when adopted, will become the go-to-guide when considering alterations to any area of the site during the development project and beyond.

The CMP, attached as Appendix 1 to this paper, consists of 212 pages and is divided in to 5 sections including Introduction, Understanding, Significance, Issues and Opportunities and Policies; based on the 3 underlying principles of Understanding the Site, Assessing Heritage Value and Creating a Positive Future.

#### 4 CONSULTATION AND OBSERVATIONS OF OTHER OFFICERS

In order to develop this CMP we worked with a wide range of specialist advisors and have ensured that critical external reviews of the document have taken place in order that it reflects an agreed statement document for Nottingham Castle.
