Acceptance and spend of DEFRA Air Quality Grant 2016-17

Total Value:

£250k (£200k external grant money supplemented by £50k Council Energy Development Fund match funding (Type: Capital and Revenue)

Decision Being Taken:

To delegate authority to the Corporate Director Commercial and Operations to accept the terms of grant funding for the DEFRA Air Quality Grant 2016-2017 and to authorize expenditure for the £200k grant funding (awarded February 2017) in line with the conditions of grant.

Reasons for the Decision(s)

The Energy Projects Service submitted a competitive bid to DEFRA for their Air Quality Grant Scheme in November 2016. Our bid was to install Fuel Cell technology in Council buildings located within Nottingham's clean air zones. The bid was successful and the project will commence in March 2017, for one year.

Background:

The project supports the Council's objective of improving air quality in its air clean air zones.

The aim of this project is to trial innovative fuel cell technology on a small scale within Nottingham City Council's property portfolio. The trial will enable us to determine the effectiveness of the technology in reducing air pollution and carbon emissions using readily available natural gas as its fuel source, when compared to traditional gas fired boiler technology which exists in the majority of buildings found in the city. The trial will also test the new technology's financial model and enable us to determine whether a large scale roll out and investment is viable for the City Council, partner organisations and stakeholders, in the future.

Other Options Considered:

The alternative option was to not submit a funding bid. We would not be able to fund fuel cell technology, due to its high capital cost and status as an emerging technology.

Finance Advice:

The use of the grant and NCC contribution aligns with the 2016/17 Energy Services Business Plan priorities [1] of:

- 1. 'Make energy savings across the council (including SCoRE programme in schools) and across Nottingham through behaviour change initiatives' and
- 2. 'Develop high quality bids into funding opportunities, to bring in money to deliver energy and waste strategies at lowest cost to the council'

Funding is in place for this decision. Grant monies of £0.200m have been awarded from DEFRA. The additional funding of £0.050m from NCC is earmarked within the Energy Development Fund which is managed by Energy Services - Projects.

There is a requirement to report expenditure up to the grant award limit to DEFRA against agreed objectives which will need to be adhered to.
