Total Value:

Decision Being Taken:

To approve commencing a procurement process to appoint a provider of mandatory Moving, Assisting and Hoisting training courses for Adult Provision colleagues on a one year contract, starting in April 2018, with the option to extend for a further 2 years subject to performance, limited to a maximum spend of £20,000 per annum which will be funded within the existing allocated budget for Adult Social Care training.

To delegate authority to the Director of Adult Social Care to award the contract to the successful provider and utilise the extension period if required..

Reasons for the Decision(s)

Colleagues providing care for citizens across Adult Provision Services are required to attend Moving, Assisting and Hoisting training every 2 years. This is an essential training requirement to ensure that they have a clear understanding of the theory and practice in assisting people to move safely. This requirement is recognised by Skills for Care and the Care Quality Commission and is compliant with the requirements of the Health and Safety at Work Act 1974 and the Health and Social Care Act 2008.
