school age

Total Value:

90,000 (Type: Revenue)

Decision Being Taken:

To approve the expenditure associated with procuring a provider to collect daily attendance and exclusion and attainment information for all Children in Care (CIC) of statutory school age commencing 1st May 2018 until 30th April 2021.

To procure a provider to collect daily attendance and exclusion information and attainment data for all Children in Care of statutory school age.

To delegate authority to the Director of Education to approve the outcome of the tender and award the contract.

To delegate authority to the Virtual School Service Manager to sign the contract arising from the tender process once the tender outcome is agreed.

Reasons for the Decision(s) The Virtual School has a statutory duty to collect, monitor and track the attendance, progress and attainment of all statutory school age CIC, we have previously commissioned an organisation to collect this data on our behalf and provide reporting in respect to this. The current contract is due to end on the 30th April 2018, we therefore need to go out to tender for continuation of this service. There is no capacity within the Virtual School team to carry out this function; a particular challenge with this is that our children in care are being educated in settings in and out of area and across the country.

Other Options Considered:

Take no action - if we do not commission this service we will not receive attendance, exclusion, attainment or progress data for our CiC who are in out of area and academy schools (we can receive data and information from city maintained schools, however, a large majority of our children in care are not being educated in city maintained schools). This would drastically limit the ability of the Virtual School to fulfil its statutory duties to monitor, track and report on the educational experience and outcomes of all our CiC- we would only be able to fulfil this duty for CiC being educated in City schools which use the SIMS attendance module and make their information available through B2B, which is less than 50% of our cohort, it is on this basis that this option is rejected.
