Summary of issues (including benefits to citizens/service users):

The purpose of the report is to consider designating streets as consent streets surrounding some schools within the City for the purposes of street trading, under the Local Government (Miscellaneous Provisions) Act 1982, so that if approved, Nottingham City Council ('the Council') will have some control over the types of street trading allowed on the streets neighbouring the

schools detailed in section 1.5. This will enable more control over traffic and congestion around schools, providing a safer environment for parents and pupils.

Recommendations:

- that the Director of Sports and Culture be authorised to serve all appropriate notices and advertise the Council's intention to pass the resolutions listed below in accordance with paragraph 2 of Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982, subject to consideration of any representations received in writing within the relevant period.
- being satisfied that it is necessary, with effect from 3rd December 2018 the streets listed below as consent streets for the purposes of street trading:
 - Beckhampton Road from its junction with Bala Drive to its junction with Belleville Drive.
 - Belsay Road.

1 REASONS FOR RECOMMENDATIONS

1.1 The Council has adopted Section 3 and Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982 for the purposes of street trading. Under the Act streets may be designated as "consent streets", "licence streets" or "prohibited streets" as follows:

"Consent Street" means a location in which street trading is prohibited without the consent of the council

"Licence Street" means a street in which street trading is prohibited without a licence granted by the council

"Prohibited Street" means a location in which trading is prohibited
At present, the streets associated with Schools named within this report are neither consent nor prohibited; vendors can set up and sell goods in an uncontrolled manner.

- 1.2 Issues of street vending outside Schools were brought to the attention of the Markets Team within the Council by councillors and local residents. There is an ongoing problem about nuisance and potential safety issues for pupils around some schools.
- 1.3 Additionally, this has a negative impact on the local area, litter and the healthy schools ethos.
- 1.4 There was concern that similar activity may be taking place at other schools so a consultation letter was sent out to all schools in the City requesting feedback on their experience about this matter. A number of schools (17) have responded indicating support for streets to be designated. The feedback received gave evidence of vehicles blocking crossing points and reducing visibility for student

crossing the road. A school reported an incident where a child was struck by a car they felt traffic congestion was a contributing factor. Some Schools also feel the vendors trade focusing on students does not support the healthy eating agenda.

1.5 To enable the Council to establish control of the types of street trading allowed on streets neighbouring schools, it is the intention to designate streets neighbouring the schools described below as consent streets. References to streets include the whole length and width of that street or road between the boundaries described.

- 1.6 If the Committee agree the recommendations, an advertisement will be placed in the local press stating that representations relating to the proposed resolution may be made in writing within 28 days of the notice. The Police and the Highways Authority will also be notified.
- 1.7 The matter will be reported back to this Committee to consider any representations that are received and to determine whether the resolutions should be passed; such

Committee will need to be convened 08 October 2018 to achieve the advertised effective date.

1.8 After consideration of the representations received, Committee may (at a future meeting), if they think fit, pass such a resolution relating to the area or any part of it. The Council must then publish a further notice, in accordance with the above legislation, for two consecutive weeks in a local newspaper circulating in the area not later than 28 days before the day specified in the resolution for the coming into force of the designation.

2 BACKGROUND

- 2.1 Feedback from schools is included *in section 1.4* has been used to create the list of streets that it is proposed should be re-designated. The feedback has, in the main, highlighted issues with traffic congestion and the increased risk to pupils.
- 2.2 Officers require authority to advertise the Council's intention to pass a resolution to designate streets for street trading purposes. The recommendations will enable the advertisement to go ahead.

3 OTHER OPTIONS CONSIDERED IN MAKING RECOMMENDATIONS

- 3.1 Designating the named streets as prohibited, but this may prevent supported activities at the schools in the future.
- 3.2 Consideration was given to designating a number of streets outside all schools in Nottingham, but after consultation only the schools mentioned in the report expressed concerns. It was considered proportionate to only designate the streets outside schools that had raised concerns

4 FINANCE COLLEAGUE COMMENTS

4.1 As a result of this decision, the expectation is that there will be minimal impact on the medium term financial plan, based on the current levels of unlicensed street vending. Any costs arising from addressing unlicensed street trading can be contained from within approved budgets.
