Decision Being Taken:	To approve the principle of the establishment of the Nottingham Historic Buildings Trust as a charitable company limited by guarantee with approval of governance in a subsequent decision
Reasons for the Decision(s)	The delivery of a Building Preservation Trust for Nottingham is a commitment within the 2015 Nottingham Heritage Strategy. Building Preservation Trusts are commonly used across the UK to help bring historic buildings back into sustainable use. They are useful mechanisms for capturing and empowering local expertise and voluntary resources, and are eligible for funding streams that are often unavailable to private organisations or Local Authorities.
	The proposal to create the Nottingham Historic Buildings Trust would include on the board of trustees 1 nominated councillor and 1 NCC officer, Chair of the Heritage Panel, two others from heritage/regeneration community, supported by experts in project management and finance. It is proposed that the members of the trust are the same as the Directors / Trustees.
	The Nottingham Historic Buildings Trust (NHBT) would be an independent body external to NCC with it's own accountancy system and decision-making process. The recommendation to have 1 councillor and Officer on the Board of Trustees / Directors would be mutually beneficial to the Trust and NCC.
	The first Nottingham Historic Buildings Trust project is envisaged to be in support of the delivery of the People's Hall project.

Other Options Considered:	Leave Heritage at Risk projects to the private sector The future of 10% of listed buildings in the city has not been safeguarded by the Private Sector on the of the findings of the 2013 NCC Building at Risk survey. Listed Buildings are at risk for a variety of reasons but one of the primary constrainst for the private sector is viability. It is very unlikely that the Private Sector would secure the future of all of the buildings on the Building at Risk register leading to high-profile Buildings at Risk persisting throughout the city.

Legal Advice:	The Heritage Trust will be a company which is not controlled by the City Council. It will be possible to register the trust as a charity which will give it access to funding that would otherwise be unavailable to the City Council. The Charity Commission does allow Local Authorities to appoint representatives to the board of charities so it should be possible for City Council member and officer to be appointed to the board of trustees but the Trust must ensure it can demonstrate its independence from the City Council. It should ensure it has minority representation only on the board. The trust board should commence operating in 'shadow' mode as soon as possible to ensure it is taking decisions independently of the City Council and the Trust in respect to the development phase of the Peoples Hall project.
