## 4 DECLARATIONS OF INTERESTS

No declarations of interests were made.

#### **5 POLICE UPDATE**

The Chair of the meeting was of the opinion that this item, although not included on the agenda, should be considered as a matter of urgency in accordance with Section 100B(4)(b) of the Local Government Act 1972, in view that it related to a current police issue that could not wait until the next meeting.

Inspector Gurmit Kaur provided the Committee with the following information in relation to the murder of Malakai McKenzie:

- 3 people had been charged with murder and would appear in court on 23 May 2012;
- there would be extra police patrols in place on the day of the court hearing;
- other suspects were still being investigated and 11 arrests had been made to date;
- it was important to encourage the community to come forward with any information they had;
- the funeral was taking place on Friday 25 May 2012 and there would be increased police patrols throughout the day.

Inspector Kaur also provided the Committee with the following information in relation to the recent firearm discharge in Hyson Green:

- the firearm was discharged a week after the murder of Malakai McKenzie, but had not been linked with Mr McKenzie's murder;
- the firearm was aimed at a car with 3 passengers on the corner of Birkin Avenue and Gregory Boulevard at 5.15 pm;
- 1 arrest was made immediately after the incident but did not result in the suspect being charged, but a further arrest had since been made.

**ACTION** 

The Committee made the following comments:

- traffic on Gregory Boulevard needed to be managed to ensure that the funeral cars, and those attending the funeral, could park close to the church:
- all partners working in the area on the day, Police, Community Protection, etc, needed to be sensitive when dealing with those attending the funeral.

# 7 WARD COUNCILLOR BUDGET ALLOCATION 2012/13 (Director of Neighbourhood Services)

John Marsh, Central Locality Manager introduced the report.

#### **RESOLVED**

- (1) that the following be noted:
  - (a) that each Councillor had been allocated an individual Ward Councillor budget of £5,000, which Area Committees were required to divide between an Area Allocation budget and individual Ward Support budgets;
  - (b) that additional monies had been made available to the top 5% most deprived wards in the City, based on the Indices of Multiple Deprivation 2007;
  - (c) that any unspent monies in individual Ward Councillor budgets at the end of the municipal year would be reallocated to the relevant Area Allocation budget;
- (2) that it be approved that decisions regarding funding from the Community Influence and Engagement budget within the Area Allocation budget be delegated to the Locality Manager or, in their absence, the Director of Neighbourhood Services, and that any such decisions be reported to the next available Area Committee meeting.

# 8 ARBORETUM AREA CAPITAL 2011-2013 LOCAL TRANSPORT PLAN SCHEMES

The Chair of the meeting was of the opinion that this item, although not included on the agenda, should be considered as a matter of urgency in accordance with Section 100B(4)(b) of the Local Government Act 1972, in view that the scheme required Area Committee approval before the money could be released.

Linda Wright, Neighbourhood Development Officer, introduced the item and explained that Committee approval was required to release £12,000 Area Capital Fund money to introduce a parking scheme in the Holland Street area of the Arboretum ward.

The Arboretum Ward Councillors confirmed that they were happy with the proposed parking scheme.

RESOLVED that £12,000 from the Arboretum Area Capital 2011-2013 Fund be approved to introduce a parking scheme in the Holland Street area.
