Introduction

The Bridge Ward is situated on the south side of the city and covers the area of Meadows and part of the City Centre including London Road, Canal Street, The Broadmarsh, Market Square, Hockley and goes as far as Parliament Street.

The total population of the Bridge Ward is 14,669 (Census 2011), total population for Bridge Ward in 2001 was 9,084; this shows an increase by population of 61.5%.

The Bridge Ward has a mixed population and communities get on well with each another. Recently the area has seen an increase of new and emerging communities mainly from Eastern European countries as well as from Africa.

There are a number of residential areas across the ward including Cliff Road, private estate off Castle Marina, Turners Quay, flats in the city centre and the Meadows. The largest community residential area is in the Meadows.

There are two distinct areas within the Meadows, The Old Meadows and The New Meadows. Old Meadows has the traditional open street layout with terraced housing in the main, where as the New Meadows has a large area of Radburn style estate where a frontage of a property will face the rear of another property. This area also has walkways that run under and to the side of properties with many cut through ways and options.

The Meadows has three primary schools Greenfields, Riverside and Welbeck. With the steady increase in the number of children of primary school age, Nottingham City Council has consulted with parents/carers, staff, governors and the wider community for expanding Riverside Primary School from a 210 place primary school to a 420 place school. Following a six week public consultation and the issuing of Statutory Notices early in 2013, final approval for the expansion of Riverside Primary School and Early Years Unit was given in March 2013. Building work is due to start in late September to increase the capacity at the school from 210 places to 420 places. The building work is due to be complete for September 2014, where the Reception year group will be 60 children, when previously it would have been 30. However, due to the high demand for primary school places in the Meadows, additional children have been offered a place at Riverside Primary School for this coming academic year. When we consulted on expanding Riverside Primary School, a large proportion of the feedback received was around expanding the nursery in line with the rest of the school. Due to this feedback, we are now undertaking an informal consultation, predominantly with other childcare providers, about our proposal to increase the nursery to 52 full time equivalent places. Consultation is due to take place in September.

Introduction

The Meadows has two Police Beat Areas which are covered by the Neighbourhood Policing Teams and they are The Meadows and Riverside. The Riverside Beat covers the New Meadows and the industrial estate off Queens Drive and Castle Marina.

The area is home to some of the best parks and open spaces across the city with Queens Walk Recreation Ground once again being honoured with the Green Flag status in 2012, and the Victoria Embankment which is used by people from across the city and wider.

A Master Plan has also been put in place for additional recreational/resources to be introduced on Victoria Embankment, with a series of consultation meetings/events taken place to obtain the views and desires of local people. The Master Plan was presented to the Area Committee in February where it was approved and since signed off by the Portfolio holder.

The Meadows is going through some major developments at the moment including the Net Phase Two line with works taking place at various locations, the Decommissioning works by NCH.

The Net Phase Two line is approaching a busier programme of works: The Appitrack machine which lays the track slab and sets the rail anchors will be operating along Queens Walk as from mid- August, both inbound and outbound tracks being constructed. You would have then seen a lot of activity there after with the installation of the rail, track welding and finishing works. The outbound track to Beeston/Chillwell along Meadows Way is progressing well and towards the end of August work will be starting to construct the crossing on Queens Road to join up with NG2 Enterprise Way. This is a complicated crossing and involves strategic phasing of traffic management to maintain traffic flow in and out of Nottingham. Work is also due to start on Arkwright Street where the crossing to link up with the bridge over the station will begin.

Decommissioning works are going well with all properties in phase 1 and 2 of the Meadows Crosswall scheme now demolished and the site cleared.

Phase one of the Meadows Q blocks is ongoing. There are 14 properties void and 10 tenants to be found alternative accommodation. A contractor has been appointed by NCC to undertake valuations on Leasehold properties and visits have now commenced.

Phase 2 of the Q blocks decommissioning programme is due to start in October 2013 and home visits will be carried out by the Relocation Support Team in the last two weeks of September. Tenants will receive an appointment letter nearer the time.

The lighting works for the Bridgeway Centre have now been approved and the materials have been ordered, works are due to commence on site late August/early September.

A Week of Action will be delivered in the Meadows from Monday 16th September to Friday 20th September, with a range of partners delivering targeted work around their respective area in addressing the ward priorities.

This report will also highlight a range of projects/activities that have been delivered between June 2013 and August 2013.

The Bridge Ward priorities were determined (for 2013) at the Your Choice Your Voice event which was held on the 5th December 2012, and have since been reviewed through consultation with citizens and partners at various meetings and events. Lead services consulted with citizens on the five core themes of Nottingham Plan 2020, and the priorities highlighted are those that have been agreed by citizens with partners for targeted action/s over the past several months. Dragons Den segment of the event was hugely successful with citizens voting in favour of 20 local projects that are aiming to contribute towards the neighbourhood transformation agenda. This year's event will take place on the 4th December at Queens Walk Community Centre.

Your City Your Services event (Budget Consultation) will take place on Wednesday 23rd October 2013, from 6.00pm till 7.30pm at Meadows Library.

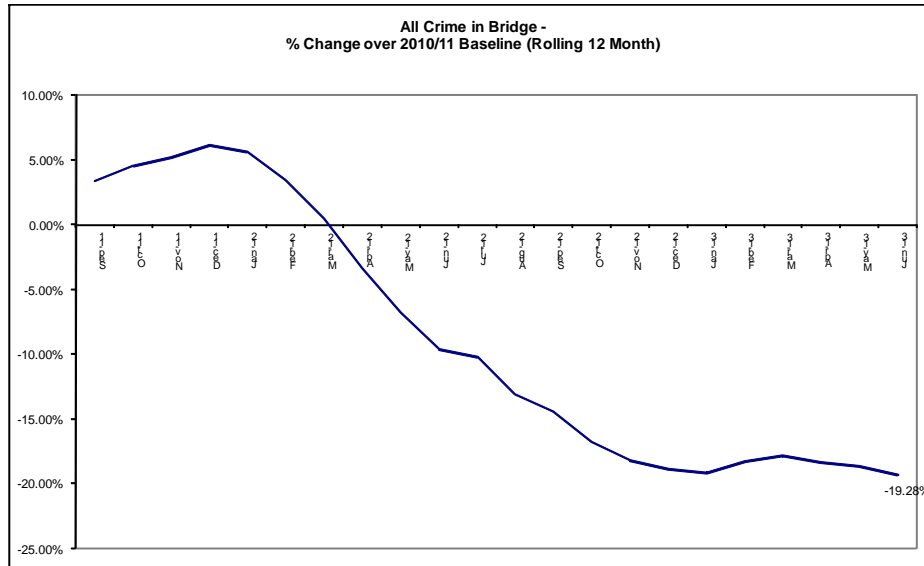

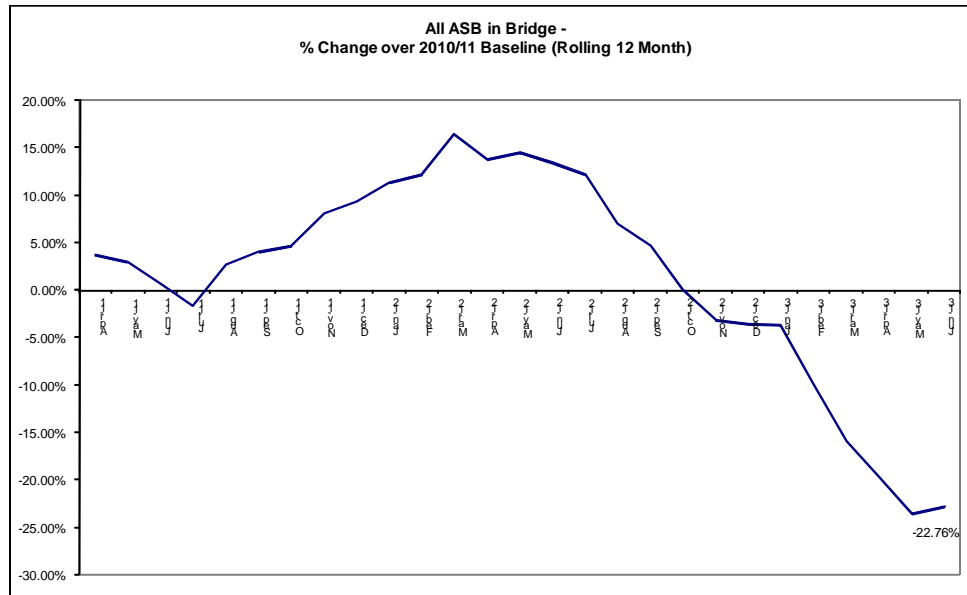

- The above baseline graph compares the *rolling* 12 month total of crime in Bridge to a *fixed* 12 month 2010/11 baseline. The current 12 month total is showing a reduction of 19.23% against the baseline.
- In June 2013 there were 78 crimes which is a reduction of 9.30% (8 crimes, see above RAG rating) compared to June 2012. The Division as a whole experienced an increase in all crime of *approximately* 6.4%.
- For the year to date Apr-Jun 13 crime has reduced by 7.76% (-18 offences) compared to the same period last year. The Division as a whole experienced an increase in all crime of *approximately* 6.2%.
- The largest volume increase this month was in Drugs and Threats, which both rose by 4 offences crimes (see Table 1 of page 5).
- Crimes with a domestic flag assigned to them are up by 3 crimes (June 2013 compared to June 2012, see Table 2 of page 5). The ward ranked 8th out of 20 wards for Domestic related offences in June.
- The rate (per 1000 of population) of all crime in Bridge is slightly worse than the average rate for the 20 wards (figures are year to date, see Table 3 of page 6).

- In June 2013 there were 56 ASB calls in Bridge ward, this is an increase of 9.8% (5 calls, see above RAG rating) compared to June 2012. The Division as a whole experienced a reduction of *approximately* 19% on this measure.
- For the year to date Apr-Jun 13 ASB has reduced by 25.43% (-44 incidents) compared to the same period last year. The Division as a whole experienced a reduction in ASB of *approximately* 25%.
- The rate (per 1000 of population) of ASB in Bridge is worse than the average rate for the 20 wards (June 2013 figures, see Table 4 of page 7). The Ward currently has the 3rd highest rate of ASB per 1000 population out of the 20 Wards in the City.

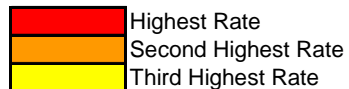

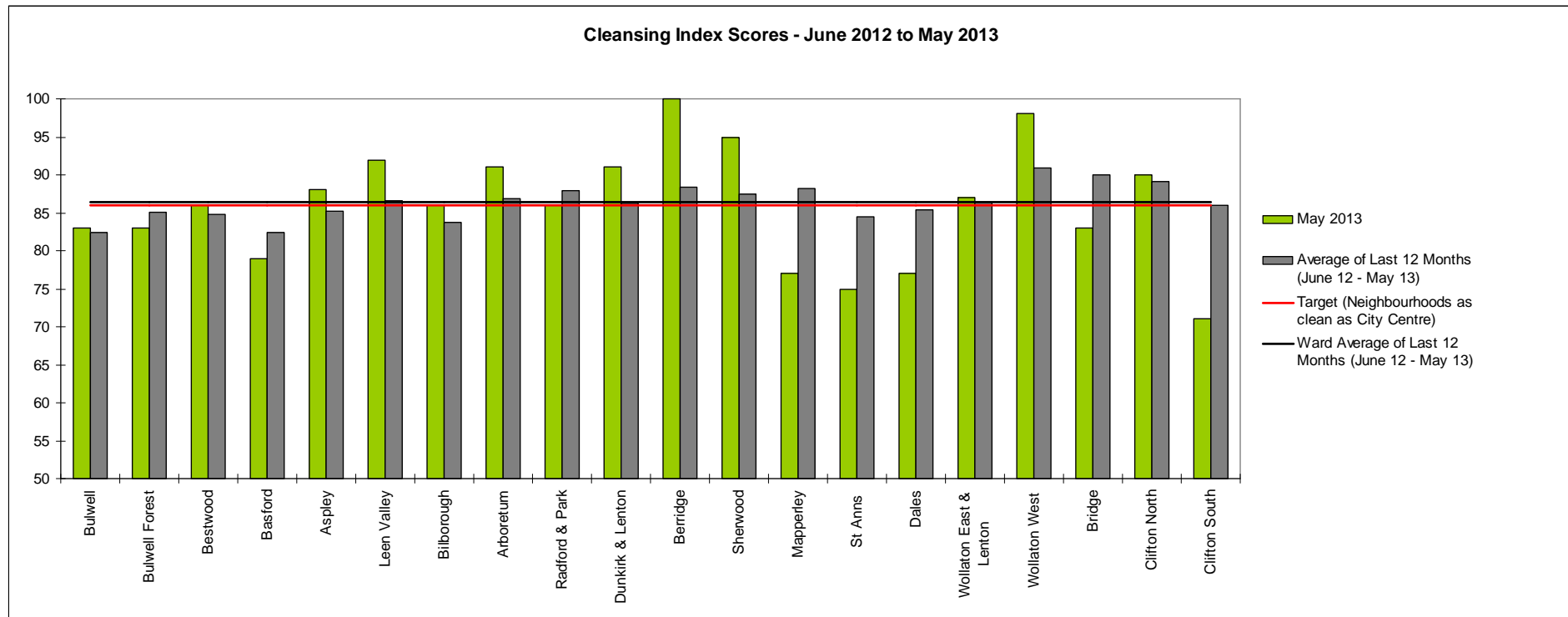

Cleanliness Index



The “neighbourhood as clean as the city centre” benchmark target on cleanliness is to achieve a score of 86% in every ward. The 86% target is shown in red in the above graph.

To calculate the Cleanliness Index (CI) an agreed number of transects are surveyed across an area covering a range of land types. Each site surveyed is awarded a cleanliness grade based on a 7 point scale from A to D where Grade A: – no litter, and Grade D: - heavily littered. The maximum possible score of 100 is achieved when all sites achieve Grade A.

The Code of Practice for Litter and Refuse (COPLAR) requires councils to strive to reach an ‘acceptable’ standard of cleanliness (grade B or better) across the Council area. Grade A is the ultimate goal and is how a site should be immediately after sweeping but is almost impossible to maintain for any length of time. For example, a grade A site is completely free of litter – one cigarette butt takes it down to B+.

To achieve the manifesto commitment of Neighbourhoods as clean as the City Centre a target of 86 is required as that was the CI for the City Centre in May 2011. To give some context if all areas surveyed achieved a grade ‘B’ standard, this would equate to a cleanliness index of 67.

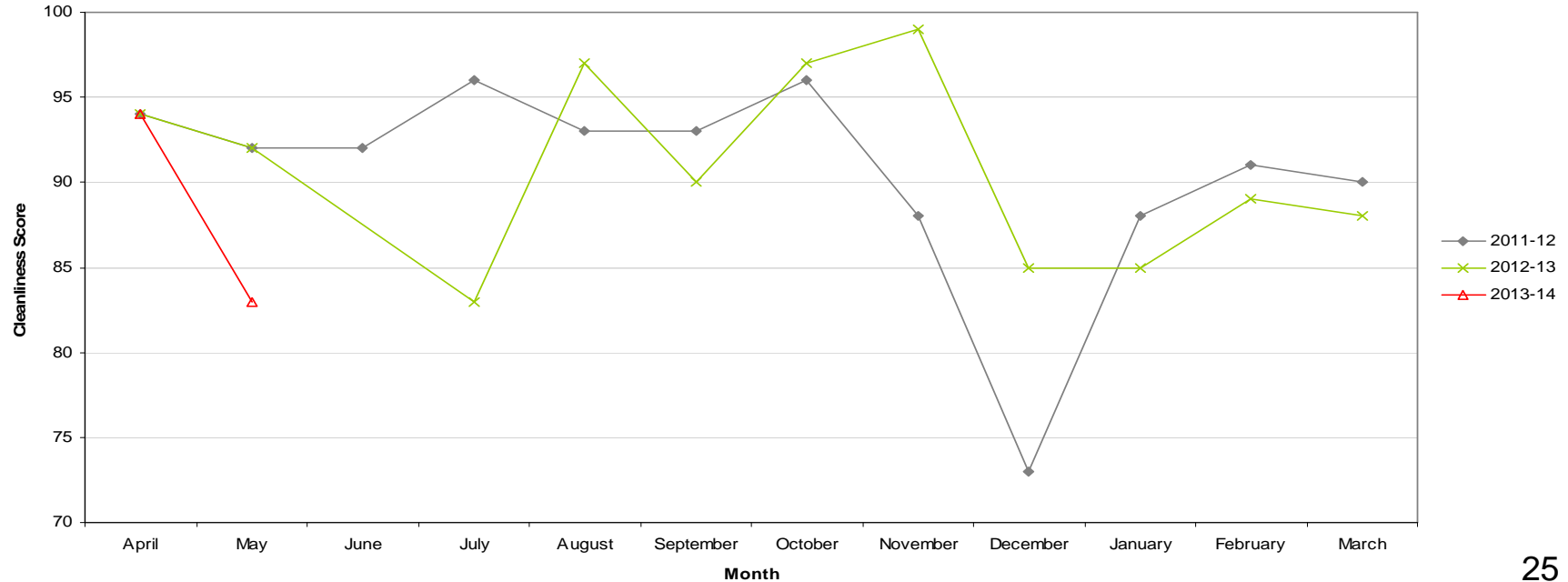

Cleanliness Index - Bridge

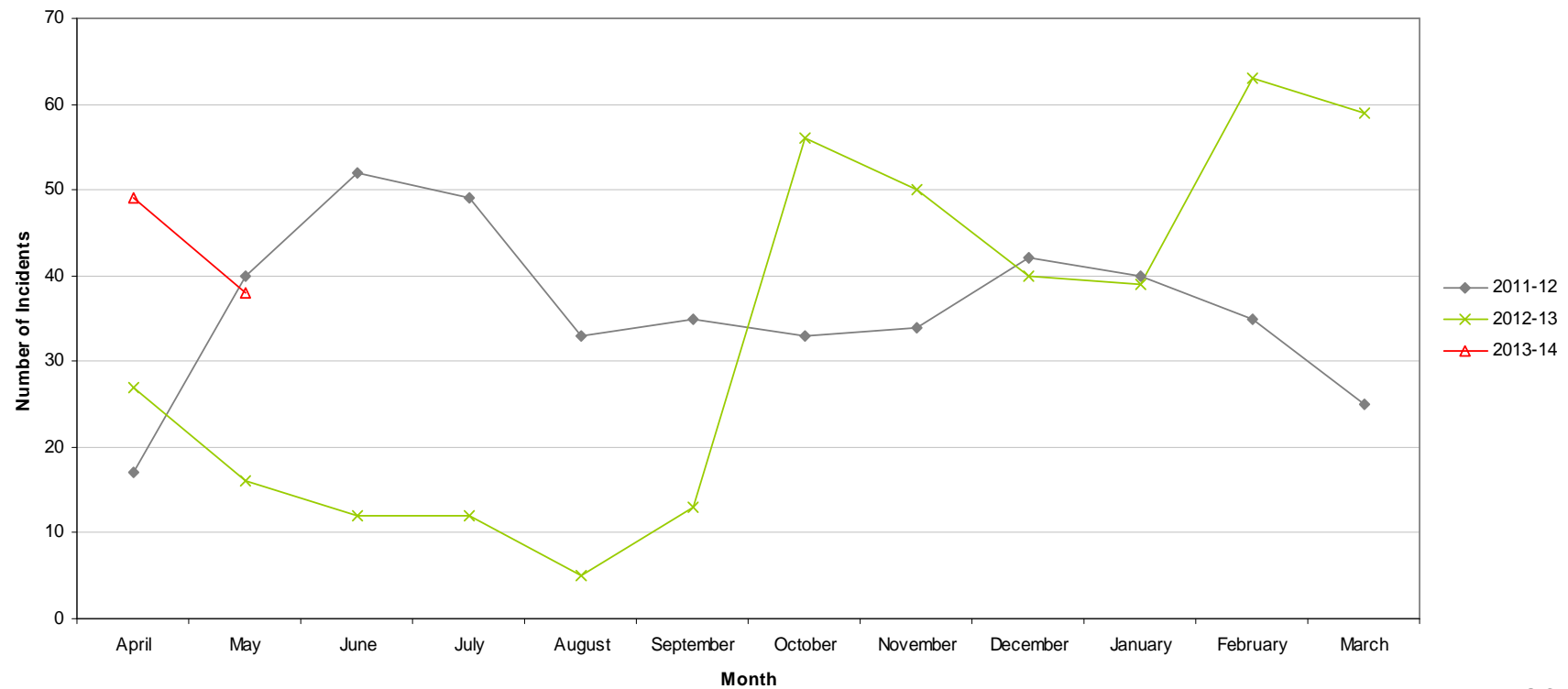

Incidents of Graffiti - Bridge

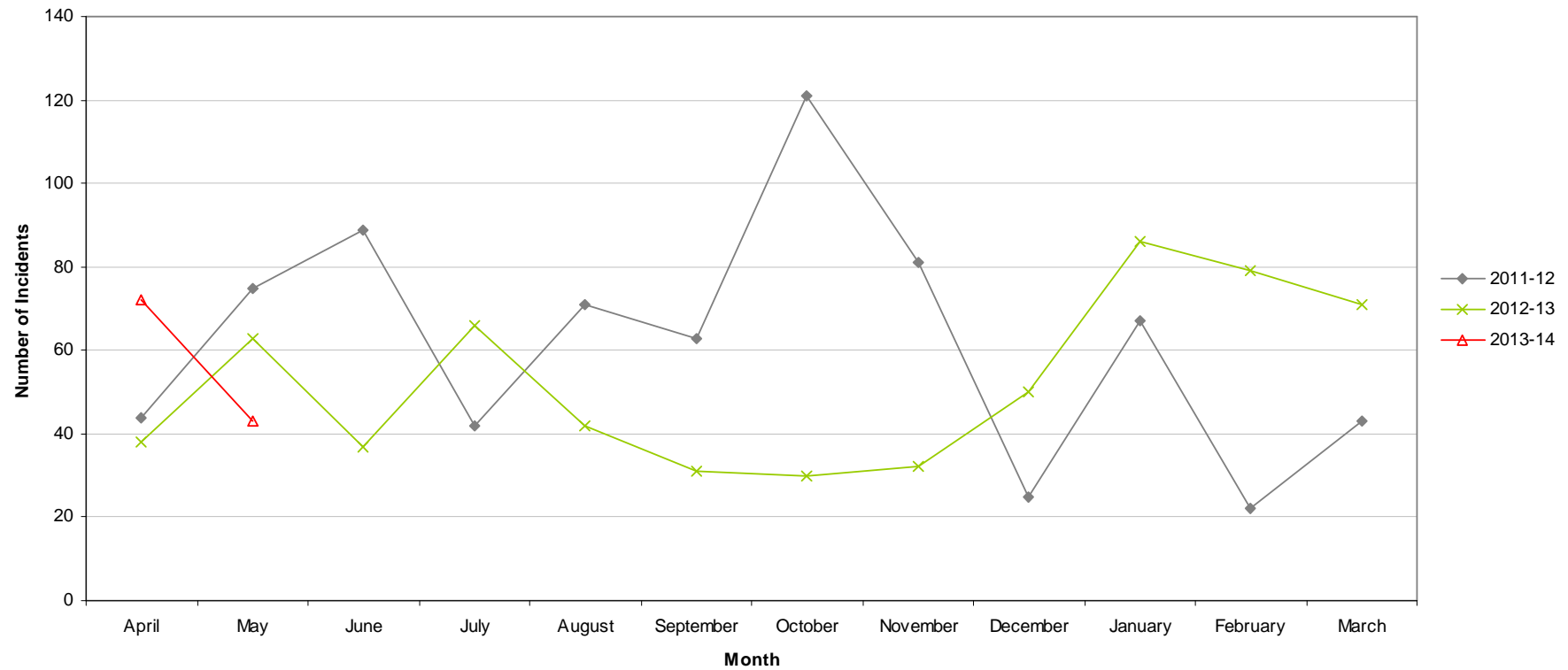

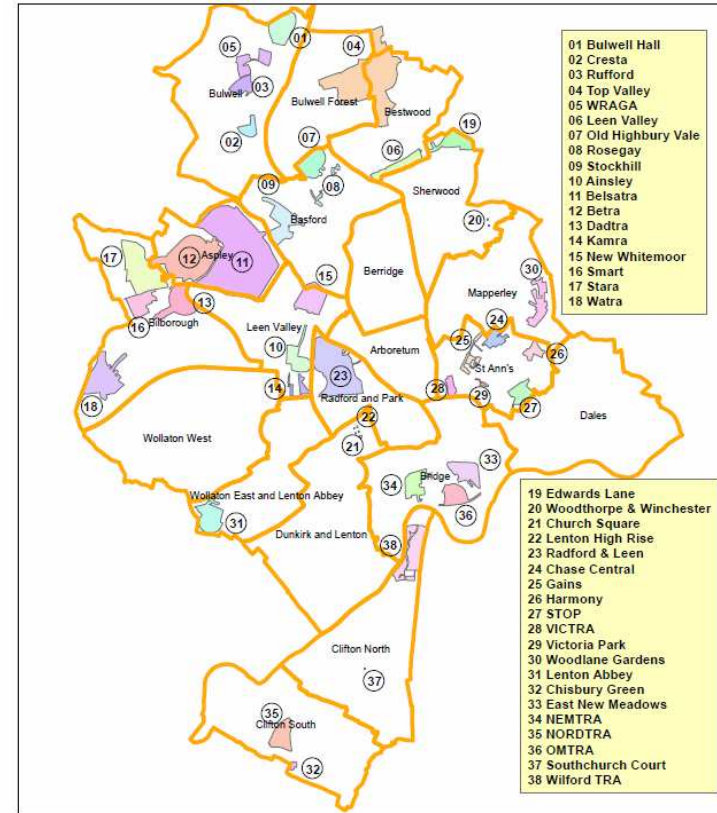

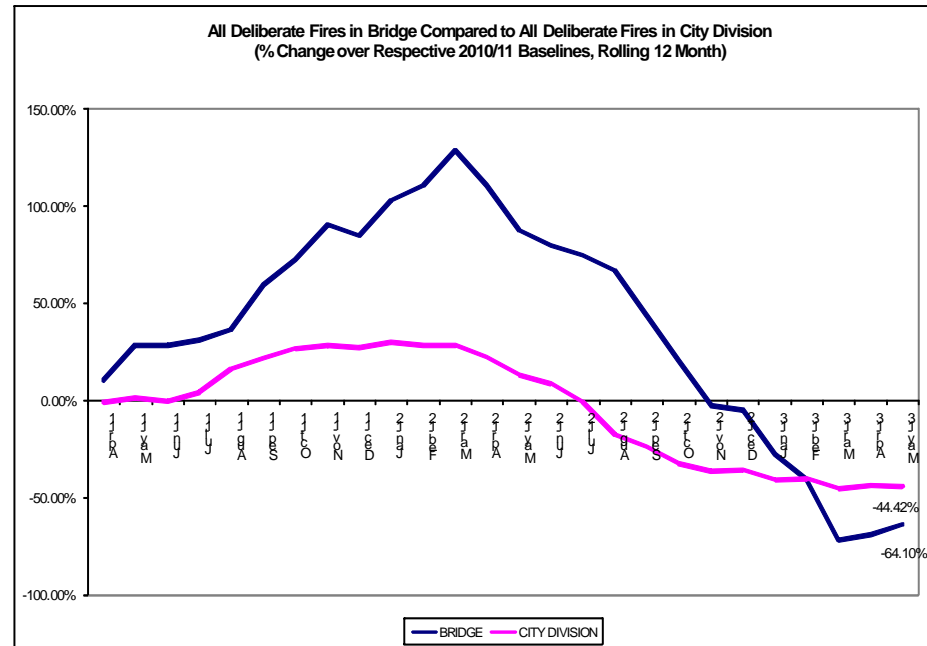

- The above table shows volume of deliberate (primary and secondary) fires in the 20 wards. In May 2013 there were 3 fires in Bridge. Year to date deliberate fires in Bridge are up 150% (+3 fires) compared to the corresponding period last year.
- The graph on the right shows a *rolling* 12 month total of deliberate fires in Bridge against the *fixed* 2010/11 baseline. The performance of the City Division against *its* baseline has also been shown for comparison purposes.

Note: Where ward boundaries overlap with the City Centre fires that occurred in the City Centre have been **included** in the ward figures.

Methodology

Data has not been audited or verified and therefore must only be used as a reflection of crime.

Crime data and ASB calls have been extracted from the Police systems and mapped to ascertain which Ward they occurred in.

Where a ward boundary overlaps with the City Centre, crime data and ASB calls relating to the City Centre have been removed.

Where possible the most recent data is used, although for some areas this may be a month further in arrears.

Discussions continue with other agencies regarding what further data can be included.
