10 OFFICIAL COMMUNICATIONS

The Chief Executive reported the following communications:

Natural England

Nottingham received a Natural England Site of Special Scientific Interest (SSSI) Certificate of Recognition, recognising the contribution Nottingham made in helping to deliver the Government's 95% target to get England's SSSIs into a favourable or recovering condition.

Keep Britain Tidy

From the 10 local authorities that entered, Nottingham was runner up in the Keep Britain Tidy Network Innovation Awards.

Nottingham Castle

Nottingham Castle won a top art award, winning a share of this year's £75,000 Art Fund Collect; a joint scheme ran by the Art Fund and the Crafts Council, that gives curators the chance to pick up a unique piece of craft at Collect, the Crafts Council's international art fair for contemporary objects.

The success meant a 2010 platinum brooch, an outstanding piece of contemporary craft by Italian jeweller Giovanni Carvaja, would join the Nottingham Castle collection.

Giovanni Carvaja was trained at the celebrated Padua school of goldsmithing. The astral, meditative piece is made from gold and platinum gossamer and platinum wire.

Local Government Improvement and Development for the Department of Health's Reducing Health Inequalities through Tobacco Control Programme

The Council won two awards from the Local Government Improvement and Development for the Department of Health's Reducing Health Inequalities through Tobacco Control Programme for:

- (1) the Putting Health at the Heart of Nottingham event and the full Council debate in February 2010. £200,000 was made available by the Department of Health to support this work; and
- (2) providing peer mentoring to train and develop young people to become smoke free mentors in their community. This involved running 3 eight week accredited courses, working with a total of 50 young people from across the City. It was supported by £4,500 of funding from the Health and Wellbeing Partnership, and so far 14 young people from St Ann's, Bulwell and The Meadows had completed the training to date.

Both awards were given to Kate Thompson, who is the Smoke Free Nottingham Co-ordinator in Community Protection – Trading Standards.

National Apprenticeship Awards

Nottingham City Council was short listed for the National Apprenticeship Award and, if successful in the regional East Midlands stage, would progress to the nationals.

Partnerships Bulletin Awards

Nottingham City Council won two national wards at the Partnerships Bulletin Awards ceremony held on London and Thursday 12 May 2011:

(1) Southwark Primary School was selected as winner in the 'Best Community or User Involvement Project' category. The £13.5 million school opened in April 2010 and is sited in the heart of Old Basford, an area of high deprivation. The project brought together a split-site school on an urban site surrounded by residential housing. The award recognised the outstanding commitment to involving the local community. A broad range of stakeholders were fully involved in the visioning and design of the project and their involvement paid off. The stunning school exceeded the expectation of those involved and is providing new opportunities for learning and community use; and

(2) the Major Programmes Team was winner in the 'Best Local Government Project Team'. The award recognised innovation and excellence and the judges found that the team provides clear project leadership, leading to innovative deal structures and the timely, efficient delivery of £170 million worth of projects in 2010. The team successfully implemented a new project methodology into the Council which had already seen savings of £3.5 million on other corporate projects. The team also played a significant role in boosting Nottingham's economy by creating 140 new jobs and spending over £30 million with local companies.

Councillor George Dobson

Former Councillor George Dobson passed away in March after several months of illness.

Councillor Dobson was appointed to represent the Clifton ward in a byelection on 12 December 1968 and was a City Councillor until 1974.

His funeral was held on 21 March at Wilford Hill Crematorium.

Councillor Malcolm also spoke about Councillor George Dobson.

The Council stood in silence in tribute to his memory.

Terms of reference

- (a) To set, manage and co-ordinate the overview and scrutiny work programme to ensure all statutory roles and responsibilities accorded to the overview and scrutiny function are fulfilled, including the ability to:
 - i. hold local decision-makers, including the Council's Executive, to account for their decisions, action and performance;
 - ii. review policy and contribute to the development of new policy and the strategy of the Council and other local decisionmakers where it impacts on Nottingham residents;
 - iii. explore any matters affecting Nottingham and/ or its residents;
 - iv. make reports and recommendations to relevant local agencies with respect to the delivery of their functions, including the Council and its Executive;
- (b) to maintain an overview of key strategic issues relevant to Nottingham and its residents to inform decisions about the work

programme so that it is focused on, and adds value by the examination of, issues of local importance and concern;

- (c) to commission time-limited review panels (no more than 3 major reviews at any one time) to carry out an individual review in accordance with the overview and scrutiny work programme. This commissioning includes setting the remit, initial timescale, size of membership and chair of the panel to meet the needs of the review being undertaken;
- (d) to monitor the effectiveness of the overview and scrutiny work programme and the impact of outcomes from overview and scrutiny activity, including the outcomes of review panels;
- (e) to establish a sub-committee known as the Health Panel, to fulfil the statutory health scrutiny function, scrutinise the arrangements for the commissioning and delivery of local health services, and consider any matters referred to it by the Overview and Scrutiny Committee to support effective delivery of the overview and scrutiny work programme;
- (f) to establish a sub-committee known as the Call-In Panel to meet as required to consider call-in requests in accordance with the Council's Call-In Procedure;
- (g) to consider requests for councillor calls for action;
- (h) to receive petitions in accordance with the Council's Petitions Scheme;
- to commission separate policy briefings to inform councillors about current key issues relevant to Nottingham, to aid decisions about the future overview and scrutiny work programme and prepare councillors to undertake overview and scrutiny work that has already been commissioned;
- (j) to co-opt people from outside the Council to sit on any of the overview and scrutiny bodies as relevant to support effective delivery of the overview and scrutiny work programme;
- (k) to establish a pool of no more than 5 scrutiny chairs (the membership of which will include the Chair of the Overview and

Scrutiny Committee and the Chair of the Health Panel) who will chair review panels and/or the Call-in Panel as required by the Overview and Scrutiny Committee.
