\* The Office for National Statistics (ONS) released new 0-17 population protections for mid-year 2011. These are based on the most recent Census data and figures show the child population in Nottingham has increased to 62,500, as a result the rate per 10,000 children will decrease. This figure is used in rate calculations from 11/12 (apart from BME measures).
