LOCAL DEVELOPMENT FRAMEWORK ALIGNMENT – JOINT WORK.

Purpose of Report

1 To inform Members of the current position regarding joint working and alignment of Local Development Frameworks in the Nottingham Core Housing Market Area.

Introduction

- At its meeting of 21st September, the Shadow Greater Nottingham Executive considered approaches to closer working on spatial planning. It was agreed that closer alignment of Core Strategy preparation was highly desirable, with an option in the future, if considered appropriate, of moving towards a single joint Core Strategy for the local authority areas of Nottingham, Broxtowe, Gedling and Rushcliffe. (Because Ashfield is partly outside the Greater Nottingham Area, it would not be possible for them to be part of a single joint Core Strategy, although they will be aligning their work were relevant.)
- Work on alignment will include the development of separate Issues and Options papers with a complementary overview, and including common conurbation wide Issues and Options, but also allowing for Issues and Options of purely local concern. These would be prepared as far as possible on a common timetable. There would be an opportunity to bring all the processes together in to one Preferred Options paper, if considered desirable, or of continuing the development of separate but aligned Preferred Options for each local authority area. This approach will be considered by the next meeting of the Shadow Greater Nottingham Executive on 14th December.

There has already been much work done on a Housing Market Area (HMA)

basis to develop a robust evidence base for local development frameworks,

which have been the subject of items to this Committee. To date joint employment land, retail, strategic flood risk, transport and housing studies

have been carried out on across the HMA. Using a joint evidence base will

assist the authorities in aligning their core strategies. There are also a number

of jointly funded posts between the authorities.

5 The Government has set new incentives for joint working proposed through

the new Housing and Planning Delivery Grant. Working jointly on core

strategies will place the authorities in the Nottingham Core Housing Market

Area in a good position to bid for additional funds, if there is a move towards a single Core Strategy. Alignment of planning policy work across the HMA is

also a key objective of the Nottingham part of the Three Cities Growth Point

proposal.

6 The key issues of governance and the links to individual Sustainable

Community Strategies would need to be addressed at an early stage.
