# **REPORT OF THE DIRECTOR OF DESIGN AND PROPERTY SERVICES**

### <u>STREET TRADING – LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT</u> <u>1982 – LACE MARKET AND ICE CENTRE AREA DESIGNATION</u>

### 1. <u>SUMMARY</u>

The purpose of this report is to consider the designation of all existing undesignated streets in and around the Lace Market and Ice Centre under the Local Government (Miscellaneous Provisions) Act 1982 for the purpose of street trading.

### 2. <u>RECOMMENDATIONS</u>

It is recommended that, pursuant to paragraph 2 of schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982:

i) The following areas, together with all adjoining car parks and other areas to which the public have access to without payment, be designated as prohibited streets for the purposes of street trading with effect from 10<sup>th</sup> July 2002.

Chardlace Walk, Trivett Square, Short Stairs, Malin Hill, Garners Hill, Carter Gate, Fisher Gate, Dean Street, Poplar Street, Sussex Street, Cliff Road, Harnett Close, Shortwood Close, Popham Street, Popham Court, Maltmill Lane, Pemberton Street, Long Stairs, London Road between its junction with Lower Parliament Street and Queens Road and between its junction with Canal Street and Plumptre Square, City Link, Trent Street, Pinder Street and Plough Lane.

- ii) High Pavement in the City of Nottingham, together with all adjoining car parks and other areas to which the public have access to without payment, be designated as consent streets for the purposes of street trading with effect from 10<sup>th</sup> July 2002.
- iii) The Deputy Chief Executive and City Secretary be authorised to advertise the above resolutions in accordance with paragraph 2 of schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982.

# 3. BACKGROUND

Members may recall that at its meeting of 8<sup>th</sup> April 2002, the Licensing Committee indicated that it intended to designate the following areas, together with all adjoining car parks and other areas to which the public have access without payment as prohibited for the purposes of street trading:

Chardlace Walk, Trivett Square, Short Stairs, Malin Hill, Garners Hill, Carter Gate, Fisher Gate, Dean Street, Poplar Street, Sussex Street, Cliff Road, Harnett Close, Shortwood Close, Popham Street, Popham Court, Maltmill Lane, Pemberton Street, Long Stairs, London Road between its junction with Lower Parliament Street and Queens Road and between its junction with Canal Street and Plumptre Square, City Link, Trent Street, Pinder Street and Plough Lane.

The Licensing Committee also indicated an intention to designate High Pavement together with all adjoining car parks and other areas to which the public have access without payment in order to control street trading in this area. The type of designation was to be decided with advice from the City Secretary in conjunction with consultation with the Chair, Vice Chair and Opposition Member of the Licensing Committee. Following advice from the City Secretary it was decided to designate High Pavement together with all adjoining car parks and other areas to which the public have access without payment as consent streets.

The steps required by paragraph 2 (3) of schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982 have been complied with.

The Deputy Chief Executive and City Secretary advertised the Council's intentions, any objections received will be reported to the Committee.

### 3.1 Pennyfoot Street

The Director of Design and Property Services and the City Secretary are currently undertaking a consultative process associated with Pennyfoot Street and a further confirmatory report will be submitted on this matter to a future meeting of the Committee.

### 4. <u>CITY TREASURER'S OBSERVATIONS</u>

As there is currently no revenue generated from Street Trading in these streets, there is no financial impact on the City Council of prohibiting these activities.
