#### **19 CHAIR**

#### **20 APOLOGIES FOR ABSENCE**

An apology for absence was received from Councillor Cresswell.

#### **21 MINUTES**

##### **RESOLVED**

- (1) that the minutes of the meetings held on 10 and 20 June 2002, copies of which had been circulated, be confirmed and signed by the Chair presiding at the meeting.**
- (2) that it be noted that the minutes of the meeting held on 24 June 2002, had not been circulated due to unforeseen circumstances in the Committee Section and that they would be circulated to all Members at a later date.**

#### **22 SAFETY AT SPORTS GROUNDS ACT 1975 FIRE SAFETY AND SAFETY OF PLACE OF SPORTS 1987 - NOTTS COUNTY FOOTBALL CLUB, MEADOW LANE, NOTTINGHAM**

Consideration was given to a report of the Director of Development and Environmental Services, copies of which had been circulated. The applicant Mr G Davy, Managing Director, Notts County Football Club accepted the Committee's invitation to attend the meeting. The City Council was represented by Mr A Thompson, Service Manager (Health and Safety), accompanied by Miss M Nightingale, Team Leader (Health and Safety)

Development and Environmental Services Department. Mr R Birtwistio, Station Officer, Notts Fire and Rescue Service, attended the meeting in his capacity as a member of the Committee's Safety Advisory Group.

Mr Thompson presented the report and drew Members' attention to matters arising from the Committee's inspection of Notts County Football Ground, Meadow Lane, prior to its meeting.

Mr Thompson, Miss Nightingale and Mr Birtwistio together with Mr Davy made their submissions and were available for questioning.

## **RESOLVED**

- (1) that undertakings by Mr Davy regarding outstanding works to be completed at the Notts County Football ground as specified on the list of outstanding work provided to members during the tour of the football ground prior to this meeting, be accepted;**
- (2) that, subject to the undertakings given above, and to satisfactory final inspections, the Committee was content for the General Safety Certificate to remain in force with a maximum capacity of 19,588 spectators as detailed in Appendix 1 to the report;**
- (3) that the schedule of deviations from the recommendations in the Green Guide Sports edition contained within the certificate as listed in Appendix 2 to the report, be accepted.**

## **23 LATE NIGHT REFRESHMENT HOUSE LICENCE - ANTALYA, 54 UPPER PARLIAMENT STREET**

Consideration was given to a report of the Director of Development and Environmental Services, copies of which had been circulated. The applicant Mr M Kolcak accepted the Committee's invitation to attend the meeting and was accompanied by Mr Pearce of Young and Pearce Solicitors who presented the case on his behalf. The Director of Development and Environmental Services was represented by Mr T Coulson (Food and Licensing) Environmental Services Department, who presented the report.

Ms J Hudson, Bluebell Inn and Ms M Constable, Turf Tavern attended as objectors to the application.

During the course of the submission, Mr Pearce, on behalf of Mr Kolcak, amended the application to the effect that the closing hour be 4.00 am. Mr Pearce, Mr Kolcak, Mr Coulson, Ms Hudson and Ms Constable having made their submissions and been available for questioning, withdrew.

In reaching its decision, the Committee had regard to the following:-

- (a) submissions by Mr Kolcak regarding the application;
- (b) objections to the application by Ms Constable and Ms Hudson;

- (c) submissions by the Director of Development and Environmental Services regarding the application;
- (d) Mr Kolcak's undertaking to continue the half hourly litter pick-ups outside his premises and neighbouring premises.

**RESOLVED that the late night refreshment house licence be granted, subject to the condition that the premises be prohibited from opening after 4.00 am.**

**23 STREET TRADING - LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1982 - PENNYFOOT STREET DESIGNATION**

Consideration was given to a joint report of the Deputy Chief Executive and City Secretary and Chief Officer for Design and Property Services. The Director was represented by Mr M Turner (Markets and Fairs).

**RESOLVED**

- (1) that pursuant to paragraph 2 of schedule 4 of the Local Government (Miscellaneous Provisions) Act 1992 Pennyfoot Street together with all adjoining car parks and other areas to which the public have access without payment be designated as prohibited streets for the purposes of street trading with effect from 14 August 2002;**
- (2) that the Deputy Chief Executive and City Secretary be authorised to advertise the above resolution in accordance with paragraph 2 of schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982.**
