17 PROVISIONAL ENTERTAINMENTS LICENCE - TIGER TIGER, UNIT B3, CHAPEL QUARTER

Further to minutes 72, 82 and 14 dated 6 March, 8 and 11 April and 10 June 2002 respectively, consideration was given to a report of the Director of Development and Environmental Services, copies of which had been circulated.

The Committee met to determine a fresh application for a Provisional Entertainments Licence in respect of premises to be known as Tiger, Tiger, Unit B3, Chapel Quarter to provide music and dancing on levels two and three of the premises (ground and first floors) at the following times:-

Mondays to Saturdays:	11.00 am to 2.00 am the following day
Sundays:	noon to 12.30 am the following day
Sundays preceding Bank Holidays (excluding Easter Day):	noon to 2.00 am the following day

The applicant, Mr N Tamblyn, Chief Executive Officer of Chorion plc, accepted the Committee's invitation to attend the meeting and was accompanied by Ms A Anderson, Development Director, Chorion plc, Mr A Abel, Design and Build Partnership, Architects and was represented by Miss L Stephenson, Solicitor, Messrs Berwin Leighton Paisner, Solicitors, London.

Mr M Knight, Chairman, Pub and Club Watch attended as an objector to the application and was represented by Mr J Pearce of Messrs Young and Pearce, Solicitors, who also represented the objections of the Noble Organisation, operating as Ocean Night Club, to the application. The objections of the Chief Constable, Nottinghamshire Police, to the application were presented by Mrs J Swain.

The Director of Development and Environmental Services was represented by Mrs J Swain, Team Leader (Licensing). In presenting the report, Mrs Swain requested that, if approved, grant of the Licence should be subject to final inspections by the Environmental Health Division and Chief Fire Officer.

Miss Stephenson, Mr Tamblyn, Mr Pearce, Mr Knight and Mrs Swain having made their submissions and been available for questioning, all parties withdrew.

In reaching its decision, the Committee had regard to the following:-

- (a) the legislative framework for the granting of Public Entertainments Licences and the City Council Standard Conditions to be attached to such licences;
- (b) duties imposed on the Council by section 17 of the Crime and Disorder Act 1998 and the Human Rights Act 1998;
- (c) provisions of the Disability Discrimination Act, 1995;
- (d) submissions by Mr Tamblyn and Miss Stephenson regarding the application;
- (e) submissions by the Director of Development and Environmental Services regarding the application;
- (f) objections to the application by Mr Pearce, Mr Knight, and the Chief Constable, Nottingham Police.

RESOLVED

- (1) a Provisional Entertainments Licence in respect of premises to be known as Tiger, Tiger, Unit B3, Chapel Quarter to provide music and dancing on levels two and three of the premises (ground and first floors) at the following times:-

Mondays to Saturdays:	11.00 am to 2.00 am the following day
Sundays:	noon to 12.30 am the following day
Sundays preceding Bank Holidays (excluding Easter Day):	noon to 2.00 am the following day

- (2) that grant of the licence be subject to the following special conditions: -
- (a) "A CCTV system must be installed and maintained to the satisfaction of the Police. All video tapes must be retained for a minimum of 31 days and made available for inspection by the Police or authorised officer of the Council."
 - (b) the licensee is required to employ a reasonable number of registered door persons at the premises at all times that licence is in operation;
 - (c) this licence shall have no effect until such time as it is confirmed by the Licensing Authority following satisfactory final inspections by the Chief Fire Officer and the Director of Development and Environmental Services;

- (3) that the Director of Development and Environmental Services be requested to submit a report to a future meeting of the Committee reviewing the current administrative procedures concerned with the submission to and consideration by the City Council of plans and drawings relating to applications for Licences granted by the authority, with particular reference to the Disability Discrimination Act, 1995, at which time the Committee would wish to consider whether to review and/or amend it's current policies and/or Standard Conditions attached to Licences.
