1 MINUTES

RESOLVED that the minutes of the meeting held on 14 April 2003, copies of which had been circulated, be confirmed and signed by the Chair.

2 EXCLUSION OF PUBLIC

RESOLVED that, pursuant to Section 100A(4) of the Local Government Act 1972, the public be excluded from the meeting during consideration of item 3 as it involved the likely disclosure of exempt information as defined in paragraph 1 of Part 1 of schedule 12(A) to the Act.

3 APPEAL AGAINST REFUSAL TO VARY PUBLIC ENTERTAINMENTS LICENCE - ISIS, REDFIELD WAY, LENTON - CREATION OF THE CROCODILE CLUB

Further to minute 64 dated 17 March 2003, consideration was given to a report of the Acting City Secretary, copies of which had been circulated.

RESOLVED

- (1) that the report be noted and that the appeal be defended on all of the original grounds of refusal;**
- (2) that, should the Council lose the appeal, officers request that the Court impose the conditions circulated at committee and seek restrictions to be attached to the licence relating to reduced operational hours, the removal of the booths shown on the application plan and prohibition of full nudity.**

The public were readmitted to the meeting at this point.

4 TEMPLARS BAR, GOLDSMITH STREET - APPLICATION TO RENEW PUBLIC ENTERTAINMENTS LICENCE.

Further to minute 70 dated 14 April 2003, consideration was given to a report of the Director of Development and Environmental Services, copies of which had been circulated.

The applicant, Ms D Mason, accepted the Committee's invitation to attend the meeting, was accompanied by Mr A Azad, the business owner and was represented by Mr P Crier, Solicitor. Mr T Coulson, Service Manager (Food and Licensing), and Ms J Amoah, Pollution Control Division, Development and Environmental Services Department were also present.

Mr Crier requested that consideration of the application be deferred for fourteen days to allow further remedial work, requested by this committee on 14 April 2003, to be completed.

Mr Azad gave an undertaking to the Committee that he would submit the original copy of the NICEIC electrical reports to the Director of Development and Environmental Services forthwith.

RESOLVED that, subject to receipt of the original NICEIC electrical reports, to the completion of the further remedial works detailed in minute 70 dated 14 April 2003 and to receipt of sound attenuation measurements for the property to the satisfaction of the Director of Development and Environmental Services, the Director be authorised to grant a renewal of the entertainments licence in respect of Templars Bar, Goldsmith Street, subject to the Councils Standard Conditions attached to such licences and to continuation of the existing special conditions attached to the license and that, in the event of the Director having any reservations about any of these matters, the application be brought back to this Committee for determination.

5 EXCHANGE BAR, CASTLE BRIDGE ROAD - APPLICATION FOR NEW ANNUAL ENTERTAINMENT LICENCE

Consideration was given to a report of the Director of Development and Environmental Services, copies of which had been circulated.

The applicant, Mr S Nindarkin, accepted the Committee's invitation to attend the meeting and was represented by Mr Parrott, Solicitor, who presented the case on his behalf. Mr T Coulson, Service Manager (Food and Licensing), Development and Environmental Services Department, presented the report.

Mr Coulson, Mr Nindarkin and Mr Parrott made their submissions and, having been available for questioning, withdrew from the meeting during the committee's deliberations.

In reaching its decision, the Committee had regard to the following:-

- (a) the legislative framework for the granting of Public Entertainments Licences and the City Council standard conditions to be attached to such licences;
- (b) duties imposed on the Council by section 17 of the Crime and Disorder Act 1998 and the Human Rights Act 1998;
- (c) submissions by Mr Parrott and Mr Nindarkin regarding the application;

- (d) submissions by the Director of Development and Environmental Services regarding the application.

RESOLVED

- (1) that, subject to satisfactory final inspections, the application for a Public Entertainments Licence for the premises known as Exchange Bar, Castle Bridge Road, be granted and music and dancing be provided on the ground floor at the premises on the following basis:

Mondays to Saturdays	-	11.00 am to midnight
Sundays	-	noon to 10.30 pm

- (2) that grant of the licence shall be subject to the Councils standard conditions attached to entertainments licences and to the following additional special conditions:-

- (i) there shall be no collection of commercial refuse containers at a time that will cause disturbance to any local residents;
- (ii) a CCTV system must be installed and maintained to the satisfaction of the Police. All video tapes/recorded images must be retained for a minimum period of 31 days and made available for inspection by the police or authorised officers of the City Council on request;
- (iii) for the purposes of good order and customer safety within the premises on Friday and Saturday evenings there shall be a minimum of 2 persons who have been registered under the City Council Door Supervisor Registration Scheme employed at the premises from 8.00 pm to the terminal hour;
