# 15 MINUTES

# 16 MONITORING UPDATES PERIOD 5 - ENDING 31 AUGUST 2007

#### (a) Budget

Consideration was given to a report of the Chief Fire Officer, copies of which had been circulated, detailing the financial performance of the service and highlighting areas of concern.
