#### 3. FINANCIAL IMPLICATIONS

- 3.1 The City Council provides the Clerk and Monitoring Officer for all meetings of the Fire and Rescue Authority, Policy and Strategy Committee, Standards Committee and Personnel Committee. Nottingham City Council makes provision for a Committee Administrator to be present for all committee meetings identified in 2.3 above, for which agendas and minutes will be circulated by the Clerk. For 2008/09 the cost to Nottinghamshire and City of Nottingham Fire and Rescue Authority for these services will be £31,000. Any additional services will be recharged separately.
- 3.2 An independent remuneration committee established the allowances to be paid to Fire and Rescue Authority Members and this also provided for these to be up rated annually in accordance with Local Government pay awards. The latest member's allowances scheme was approved by the Authority at its meeting on 22 February 2008.
