1. BACKGROUND

Fire and Rescue 2009 is the biggest fire event of the year and has become the focal point of the fire professionals' annual activities. It is the three days when all concerned with fire prevention and protection come together to exchange ideas, expand their knowledge and discover the latest innovation products and services available.

2. REPORT

- 2.1 The annual Fire and Rescue Conference is to be held in Birmingham at the National Exhibition Centre from Tuesday 12 May to Thursday 14 May 2009. The conference is once again organised by Fire Conferences and Exhibitions Ltd (FCEL) and is hosted by the Chief Fire Officers Association (CFOA), the Fire Protection Association (FPA) and the Institution of Fire Engineers (IFE)
- 2.2 The conference programme is still to be finalised, but will cover the latest issues affecting the fire fighting and fire prevention industries. As well as the traditional Chief Fire Officers Association President and Ministerial exchange, there will be a number of professional development sessions at this year's event, as well as several workshops.

3. FINANCIAL IMPLICATIONS

The anticipated cost of attending the conference, including accommodation for two nights, travel and subsistence is yet to be confirmed, but will be approximately £850 per delegate. This can be contained within the budgetary provision for Member Conference Expenses.
