1. BACKGROUND

The Local Government Association organises an annual conference for Fire and Rescue Authorities. This event has now become a major event in the 'fire' calendar. Previous themes for the conference have included "Making Connections – Solutions for our Communities", "Forward Together", "Fire and Rescue in 2017: Rising to the Challenge" and "Building Resilience: Responding to Environmental Change."

2. REPORT

- 2.1 The Local Government Association Fire and Rescue Conference 2009 will take place from Tuesday 10 March Wednesday 11 March 2009 and will be held at the Bristol Marriott Hotel, Bristol.
- 2.2 Whilst planning for next year's conference is still underway, the theme of the conference is "Improving outcomes for communities through partnership working the role of fire and rescue". The programme for the two days will cover a range of topics of interest to the fire community with particular focus on current and future issues in the fire and rescue service, meeting future challenges, and what Comprehensive Area Assessment and Local Area Agreements mean for the fire and rescue service.
- 2.3 Speakers are being drawn from both within and outside the fire community and a number of workshops will be offered, covering:
 - Implementing the new Regional Control Centres practical issues;
 - Future of operational leadership in the fire and rescue service;
 - Role of Elected Members in partnership working.
- 2.4 There will be a mix of satellite sessions and plenary sessions with opportunities to question the speakers.
- 2.5 In addition to the opportunity to receive information on current fire and rescue service issues, and networking with Members from other Authorities, attendance at such events contributes to the learning and development opportunities for Members.

3. FINANCIAL IMPLICATIONS

The Conference Fee is £423.00 (inc. VAT) per delegate for Member Authorities, excluding travel, accommodation and subsistence, which will take the final cost to approximately £650 per delegate. This will be met from the budget for Members' conference expenses.
