1. BACKGROUND

- 1.1 The Local Government Association organises an annual conference for Fire and Rescue Authorities. This event has now become a major event in the 'fire' calendar. Previous themes for the conference have included "Making Connections Solutions for our Communities", "Forward Together", "Fire and Rescue in 2017: Rising to the Challenge" and "Building Resilience: Responding to Environmental Change."
- 1.2 At its meeting of 19 December 2008 the FA approved attendance of this conference for two members from the majority group, one from the head opposition group and one further member.

2. REPORT

- 2.1 The Local Government Association Fire and Rescue Conference 2009 took place from Tuesday 10 March Wednesday 11 March 2009 and was held at the Bristol Marriott Hotel, Bristol.
- 2.2 The theme of the conference was "Improving outcomes for communities through partnership working the role of fire and rescue". The programme for the two days covered a range of topics of interest to the fire community with particular focus on current and future issues in the fire and rescue service, meeting future challenges, and what Comprehensive Area Assessment and Local Area Agreements mean for the fire and rescue service.
- 2.3 Speakers were drawn from both within and outside the fire community and a number of workshops were offered, covering:
 - Implementing the new Regional Control Centres practical issues;
 - Future of operational leadership in the fire and rescue service;
 - Role of Elected Members in partnership working;
 - Equality and diversity.
- 2.4 There was also a mix of satellite sessions and plenary sessions with opportunities to question the speakers. This also included a specific session for Fire & Rescue Authorities. There was also an address from the minister for Fire & Rescue Services, Sadiq Khan, who focused on future challenges and in particular Equality and Diversity.
- 2.5 In addition to the opportunity to receive information on current fire and rescue service issues, and networking with Members from other Authorities, attendance at the event contributed to the learning and development opportunities for Members and has been recorded within the development portfolio of those Members who attended.

3. FINANCIAL IMPLICATIONS

The Conference Fee was £423.00 (inc. VAT) per delegate for Member Authorities, excluding travel, accommodation and subsistence, which took the final cost to approximately £650 per delegate. This was met from the budget for Members' conference expenses.

4. HUMAN RESOURCES AND LEARNING AND DEVELOPMENT IMPLICATIONS

The LGA Fire Conference offers an excellent learning opportunity for Members associated with the Fire and Rescue Service. The opportunities of networking with their peers from other areas of the country, as well as being updated on national issues, supports the ongoing awareness required within the role.
