#### 1. BACKGROUND

As part of the revised Governance arrangements the Authority has delegated key responsibilities for Finance and Resources to the Finance and Resources Committee. As part of those delegated responsibilities, the Chair of the Finance and Resources Committee and the Management lead report to the Authority on its business and actions as agreed at Fire and Rescue Authority meeting on 1 June 2007.

#### 2. REPORT

- 2.1 The minutes of the Finance and Resources Committee held on Friday 10 July 2009 are attached to this report at Appendix A. The following summarises the main points of the papers discussed at the meeting.
- 2.2 The Committee were firstly in receipt of a report which brought to the attention of Members the annual report prepared by the Authority's Internal Auditors and additionally informed Members of the review of Internal Audit which was conducted by the Head of Finance and Resources. The report was noted.
- 2.3 A further report for consideration was a Medium Term Financial Strategy 2009/10 to 2011/12, which in addition to providing detail around financial management, the context and objectives of the strategy, it also outlined funding priorities and service improvements; impact of UK economic downturn; medium term risks, components of the medium term strategy, partnership working and the regional dimension. The report was noted.
- 2.4 The Committee were also in receipt of two reports detailing prudential code monitoring the first for the period up to 31 March 2009 and the second up to 31 May 2009. Both reports considered detail relating to the prudential indicators for capital accounting and treasury management. Both reports were noted.
- 2.5 Two monitoring reports were also subject to the Committee's consideration at this meeting. They were in relation to:
  - 2.5.1 Capital Budget Monitoring Report to 31 May 2009 updating on capital programme progress in the year 2009/10 to the end of May 2009 and analysing significant variances against the original programme. The report was noted.
  - 2.5.2 Revenue Monitoring Report to 31 May 2009 updating on financial performance of the Service in the year 2009/10 to the end of May 2009, and analysing significant variances against the original budget. The report was noted.
- 2.6 For the remaining two items the Committee were asked to consider excluding the public from the meeting in accordance with Section 100A(4) of the Local Government Act 1972. The exclusion was endorsed and the Committee went on to consider reports on Cardiff checks and internal audit reports issues during 2008/09. The recommendations in both reports were endorsed.

#### 3. FINANCIAL IMPLICATIONS

All of the reports considered by Finance and Resources Committee on 09 January 2009 were finance related. However, there were no significant financial implications arising from those reports.

#### 1 APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillor Pettengell and from Councillor Rostance (on County Council business).

#### 2 DECLARATIONS OF INTERESTS
