1. BACKGROUND

The CIPFA conference is the largest event in the area of local government and public sector finance. It presents an opportunity for delegates to hear some of the leading experts in the field of finance speaking on a range of current issues for the public sector.

2.1 The theme of this year's conference is "The Turning Point" specifically looking to address the economic downturn and the anticipated reductions in public spending. Speakers include:

- Matthew Elliott – taxpayers alliance;
- Ben Lucas – 2020 Public Services Trust;
- Goran Perrson – ex Prime Minister of Sweden.

2.2 The usual format of the conference is that there are a number of plenary sessions which will include:

- Making the Cut : Lessons from Sweden;
- The UK Public Spending Challenge;
- Rebuilding confidence in public finance and governance;
- Leadership in Public Services;
- New Models for Delivery;

As well as a number of specific workshops led by experts in the field.

2.3 As well as being a busy conference in terms of attendance at sessions it also presents a useful networking opportunity.

2.4 The Authority's Treasurer will accompany the Chair of Finance and Resources Committee at this conference.
