REPORT OF CORPORATE DIRECTOR OF COMMUNITY AND CULTURE**STREET TRADING – BRIDLESMITH GATE****1. SUMMARY**

This report considers a potentially contentious application for a street trading position.

2. RECOMMENDATIONS

It is recommended that the Committee approve the grant of a street trading consent for the sale of fruit juices and smoothies for the daytime street trading position on Bridlesmith Gate.

3. BACKGROUND

3.1 At the Regulatory Committee meeting on 20 March 2006 delegated authority was granted to the Director of Corporate Services to grant street trading consents under the Local Government (Miscellaneous Provisions) Act 1982 (in the case of food stalls following consultation with the Corporate Director of City Development) and determine the conditions to which they will be subject.

3.2 The Committee however did ask that reports should be submitted for consideration by this Committee should officers consider that the application may be contentious.

3.3 An application has been received for the vacant street trading position on Bridlesmith Gate close to its junction with Pepper Street. The application is to sell fruit juices and smoothies.

3.4 Officers consider that this application may be contentious because the applicant will:-

- be investing up to £20,000 on the unit and equipment and a consent to trade, if granted, will not confer any security of tenure for the position;
- it is rare that the goods sold on a position have been changed from non-catering to catering;
- the visual aspect of the unit needs to be considered.

4. PROPOSALS

4.1 An application has been received to operate a "JuiceBar" on the vacant street trading position on Bridlesmith Gate. The unit would be 8' in length and be purpose

built for this position. The hours of operation would be 7.30 a.m. to 6.00 p.m. Monday to Saturday and 10.00 a.m. to 4.00 p.m. on Sunday.

- 4.2 A composite picture of the trailer in position on the pitch is shown below to give an impression of the impact of the application on the street.



5. **FINANCIAL IMPLICATIONS**

This is an established position that has been vacant for some time and the income from letting it would be £3,028 per annum.
