1 APPOINTMENT OF VICE-CHAIR

4 MINUTES

RESOLVED that the minutes of the last meeting held on 24 March 2010, copies of which had been circulated, be confirmed and signed by the Chair.

5 REVIEW OF STREET TRADING

Consideration was given to a report of the Director for Sports, Culture and Parks, copies of which had been circulated.

Mr Ehrhart presented the report which provided the Committee with the representations received following the advertisement of the resolution passed on 24 March 2010 indicating the Council's intention to pass a resolution changing the status of certain streets designated for the purpose of Street Trading.

RESOLVED

- (1) that pursuant to paragraph 2 of Schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982, the following streets be designated as prohibited streets for the purposes of street trading with effect from 1 August 2010:**

**Albert Street
Angel Row
Bridlesmith Gate
Fletcher Gate
Hounds Gate
King Street
Maid Marian Way
Mount Street
Park Row
Smithy Row
Weekday Cross, and
Wollaton Street**

- (2) that, the Director for Sports, Culture and Parks be authorised to advertise the above resolutions in accordance with paragraph 2 of schedule 4 of the Local Government (Miscellaneous Provisions) Act 1982;**
- (3) that all previous resolutions of the City Council relating to the designation of the streets listed in resolution 1 above be rescinded with effect from 1 August 2010;**
- (4) that following consideration of the representations received in relation to Long Row and Melville Street, those streets remain as consent streets rather than be the subject of re-designation.**

6 CREATION OF STREET TRADING POSITION IN CITY CENTRE

Following the resolution of the previous report considered at agenda item 4 (minute 5), that Long Row remain a consent street, this item was withdrawn.
