46 PUPIL GROWTH CONTINGENCY FUND (PGCF): UPDATE AND CRITERIA

The forum considered a report of the Interim Corporate Director of Children's Services, updating it on changes required to the PGCF criteria as a result of a national review by central government.

Jennifer Shadbolt, Project Manager, School Improvement, informed members that following approval by this Forum in September 2012 of a £500,000 contingency fund, a government review has made it necessary to revise the allocation criteria. As such, proposed new criteria (detailed in appendix 1) require approval prior to the 2013/14 academic year.

RESOLVED to approve the process for application and new funding allocation criteria for the Public Growth Contingency Fund as set out in appendix 1 to the report for allocations during the 2013/14 academic year and to note that a termly report, detailing any allocations, will be submitted to this meeting.

47 WESTBURY SPECIAL SCHOOL - INCREASED CAPACITY

The forum considered a joint report of the Interim Corporate Director of Children's Services and the Director of Family Community Teams, requesting funding for a modular building on the Westbury Special School site to accommodate 16 additional learners.

Janine Walker, Service Manager, Special Educational Needs, presented the report and stated that due to increased demand for provision for pupils with social, emotional or behavioural difficulties, which cannot be met in mainstream schools, the local authority will need to commission independent specialist day provision if the capacity at Westbury Special School is not increased.

RESOLVED to approve funding of £94,000, from the Statutory School Reserve, for the capital cost of a modular building at the Westbury Special School.
