APPOINTMENT OF CHAIR AND VICE-CHAIR 1

Martin Parker reported that the recent death of Councillor Parton meant that pending the outcome of a by-election, no one political group currently has a majority on the Area Committee.

To enable this meeting to proceed and take decisions, Ward Councillors discussed applying an interim arrangement for the current meeting to appoint Councillor Eileen Morley as Chair of the Area Committee until the outcome of the by-election on 6 June 2013 was known. Depending on the outcome, the Conservative and/or Labour Group Whip could then notify the Deputy Chief Executive/Corporate Director for Resources of the appointment for the rest of the 2013/14 Municipal Year (Solution 1).

The suggested temporary arrangement was not agreed by Councillor Georgina Culley, who proposed an alternative, ie that Councillor Eileen Morley should be re-appointed as Chair of the Committee until 16 September 2013. The outcome of the by-election would be known by then and an appointment or adjustment could then be made (Solution 2).

2 COUNCILLOR STEVE PARTON

Councillors and Community Representatives at the meeting recalled their involvement with former Councillor Steve Parton who died suddenly on 3 April 2013. He was a Ward Councillor for Wollaton West ward from May 2011 and a local resident for over 60 years.

The Area Committee stood in tribute to the memory of former Councillor Steve Parton and expressed their condolences to Mrs Parton and their children.

5 <u>MINUTES</u>

The Area Committee confirmed the minutes of the meeting held on 18 February 2013 as a correct record and they were signed by the Chair. The following reports on items appearing in the minutes, but not considered as part of the current agenda, were noted:

(a) Minute 39(a) – Withdrawal of Mobile Library Service

Lysle-Ann Renwick confirmed that the cost of a replacement vehicle (c£100,000) was too expensive to consider and that, regrettably it had been decided to close the service in its current form. Colleagues noted the popularity of the service amongst some people. Residents were asked to contact Wollaton Library directly to arrange community visits if still needed.

(b) Minute 39(c) – Wollaton FC Football Pitch Moves

The meeting noted that the club has outgrown the facilities at Wollaton Hall. In addition, English Heritage has requested that the Club be transferred to a different venue (Highfields Park).

6 <u>ITEMS IDENTIFIED BY AREA COMMITTEE COMMUNITY</u> <u>REPRESENTATIVES</u>

(a) Financial Assistance – Coffee Morning Bluecoat School

Trina Marshall thanked the Area Committee for its support of £400 from Ward Councillor budgets towards the costs the inter-generational coffee morning at Bluecoat School.

(b) <u>Arrangements for Awarding Area Based Grants to the Voluntary</u> <u>and Community Sector</u>

Trina Marshall also referred to minute 38 of the February meeting and to the further progress report on the agenda for the current meeting. She felt that the tone of the previous minute and supporting reports were too bureaucratic and made it more, not less difficult, for groups and local community groups in particular, to understand the 'why and how' of what the City Council hoped to achieve by altering its funding regime. Taking such an approach could discourage local groups from participating in the scheme.

(b) Local Development Plan and Options

David Allen asked what progress had been made on this. Lysle-Ann Renwick confirmed that the consultation phase on proposals is due to end in late June and that there will be a further report after that date.

8 <u>STREAMLINING INVESTMENT TO THE VOLUNTARY AND</u> <u>COMMUNITY SECTOR – AREA 7 PROPOSAL</u>

Irene Andrews introduced the report of the Joint Interim Director, Quality and Commissioning / Head of Early Intervention and Market Development summarising the progress on Phase One of Streamlining Investment to the Voluntary and Community Sector and outlining the grant award process. Because no organisation has agreed to be the area Lead Organisation to administer the available voluntary sector funding, the Wollaton Park Community Association will be managed using a Service Level Agreement with Nottingham City Council. In addition, the Positive Activities for Young People (PAYP) Youth Element of the budget is ring-fenced and administered by this Area Committee, in accordance with the specification for Area Based Grants.

The £3,818 to be administered by the Area Committee in 2013-14 will be split 66% for responding to identified issues and 33% for diversionary activities for young people.

It was explained that these are annual allocations and any unused amounts at 31 March will be returned to central budgets. The arrangement for this Area Committee is intended as an interim solution only for 2013-14, whilst support and development work is put in place to enable an area-based organisation to take the role of Lead Organisation to administer arrangements from 2014-15 onwards.

Comments regarding the need for understanding of procedures had been made in other meetings and were appreciated. Regarding support for youth activities, past experience indicated that if these were to be successful, any successful applicant(s) would need to provide a fully staffed and reliable service during the period(s) concerned.

There is the possibility of attracting additional funding in future years. For contractual reasons it is not possible to disclose the amount which the City has received for use of Wollaton Hall during filming of the recent Batman film.

RESOLVED to authorise the Locality Manager (Central Area) to approve applications for financial assistance from PAYP budgets, which meet the criteria specification for Area Based Grants, after consulting the Chair of the Area Committee and relevant Ward Councillors.

10 WARD PERFORMANCE REPORTS

John Marsh, Lysle-Ann Renwick and Pauline Dorey introduced and commented on two reports of the Director of Neighbourhood Services which detailed the performance of the Wollaton West and Wollaton East and Lenton Abbey wards against a range of performance measures contained in The Nottingham Plan during the final quarter of 2012-13 as follows:

Cleanliness Index: Wollaton West at 97% is the cleanest ward in the City. Wollaton East and Lenton Abbey, though lower at 87%, is still above the target of 86%.

Graffiti Reports: totalled 222 for the year, an average of around nine incidents per ward, per month.

Fly Tipping: 87 incidences during the year out of a City-wide total of 7,680 is considered low.

Crime: Inspector Robert Wilson reported a significant reduction of 95 fewer victims of crime compared to 2011-12. Although some categories of crime had increased in April 2013, figures for May 2013 have improved and other increases have been amongst the less serious types of crime. The Committee asked that in future reports crime statistics for Wollaton East and Lenton Abbey are produced in a table format and that data provided by the Nottingham Crime and Drugs Partnership is presented in a standardised format by month over a 12 month rolling period.

Traffic Issues: the findings of a consultation exercise that all but two residents are not in favour of double yellow lines on Wollaton Vale will be discussed with colleagues in due course. Lining proposals for the area around Wollaton Vale and Parkside Rise will probably proceed. The issue of car speeds on Wollaton Vale is due to be discussed again on 12 June and a report will be considered at the Area Committee meeting on 16 September. Lining around Woodside Road near the University is not planned for the near future and although the introduction of no parking on verges will be considered, it will also be necessary to take into account the needs and wishes of local residents.

Recommendation(s):

1 Area Committee note and comment on the Ward Performance reports for quarter 4 2012/13

- 1.1 Neighbourhood working has been important for a number of years in Nottingham as a means of engaging better with citizens and to drive forward service improvement
- 1.2 The Nottingham Plan has a goal that 'public service delivery will be better integrated and appropriately devolved, ensuring more accessible and responsive services for all and giving residents more control over what happens in their neighbourhoods. The Ward performance reports help to support this.
- 1.3 The Ward Performance reports capture work at a local level to support the Nottingham Plan; it is a short summary of key updates on priorities and issues in the ward. More detailed implementation plans sit behind the report such as Neighbourhood Action Team's Action Log, Crime and Drugs Partnership (CDP) plans and partners implementation plans
- 1.4 The Ward Performance reports are co-ordinated by Neighbourhood Development Officers every quarter, with the data analysis undertaken by the CDP.
- 1.5 The following brief summary by the respective Ward NDO (Neighbourhood Development Officer) highlights the key issues. The more detailed Ward reports are attached as Appendix A.

Ward: Wollaton West NDO: Lylse-Anne Renwick

Crime:

Wollaton West statistics: For period 1st June to 31st July 2013.

NB: This is the actual Police beats breakdown given to the Neighbourhood Action Team by the Safer Neighbourhood Team on 8th August 2013.

Cleanliness Index: The neighbourhood as clean as the city centre benchmark target on cleanliness is to achieve a score of 86% in every ward. Wollaton West Cleanliness index score is 94%. The index score is above the average of the city centre which is excellent. **Graffiti Reports:** 2 incidents reported a decrease of 10.

Fly Tipping: 3 incidents reported, last quarter there was 6 incidents reported a reduction of 3.

Unemployment Rate: The ward is ranked 18 out of the 20 wards for unemployment in the city. Last quarter Wollaton West Ward unemployment was 266 this quarter is 207 a reduction of 57 which is very good news for the ward.

Community Protection: July 2013 there were three court orders issues. All three of these were Statutory Notices for environment.

Fire: In June 2013 there were no fires in the Wollaton West Ward. The Ward has seen a 100% increase in fires (1fire) for the year to date compared to the same period last year.

Key Successes:

Arleston Drive Parking Scheme

Consultation has been completed for the Arleston Drive Parking Scheme and work has begun. The long awaited project had been held up at the consultation stage for some years previously but has now been given the go ahead. Councillors and businesses are now pleased to see the scheme achievement. The scheme will provide 12 new parking spaces together with reconstructed footpaths and kerbstones as well as an improved street environment, which will enhance the shopping and school area.

The scheme has begun with a view to being completed before the start of the new school term due to the proximity to Fernwood Primary School.

Martins Pond LNR

Martin's Pond has been awarded the Green Flag again this year. The Friends Group raised the flag at their task day on Saturday 10th August, 11am. The Friends of Wollaton Local Nature Reserves hold monthly task days on Martins Pond and the neighbouring Harrisons Plantation carrying out great works so that the sites can be enjoyed by all.

Issues: The outstanding issue of Traffic and noise nuisances around the area of Radford Bridge Road due to the location of Muslim Community Centre continues. At the Local Area Group meeting (LAG) 8th August 2013 members reported that a large number of vehicles are parked inappropriately in the area every Friday at approximately 2:00pm, which is related to a regular prayer time at the centre. Concerns from local residents are:

- Parking issues at prayer times generally
- Meeting are occurring at the centre outside of the agreed times contained within planning permission, particularly meeting taking place at 3:00am 5:00am
- Resident's driveways are continually being blocked by vehicles of the attendees of the centre, photographic evidence was provided.
- Queues of vehicles of those leaving the centre along Radford Bridge Road onto Crown Island, the only exit route which is causing serious traffic problems for both incoming and outgoing traffic.

A meeting with the LAG members, Ward Councillors and Traffic Management officers together with the Imam of the Muslim Community Centre is sought.

Events: A range of meeting and events have taken place this quarter including Wollaton West Community Meetings, Neighbourhood Watch, Friends of Wollaton Park and a very successful range of planned youth activities at Wollaton Park Community Centre, Torvill Park and Rushford Park to provide activities over the summer holidays for both children and young

people of the Wollaton West Ward. The contemporary art event on 7th August was a great success where lots of young people attended some from as far as Mansfield.

NATs (Neighbourhood Action Team): – working together on agreed ward priorities set by residents as well as the day to day issues that arise in the ward. The NAT team are at present jointly working to resolve issues across the ward. Issues are traffic and noise nuisance on Radford Bridge Road, increase of fires being set on the ground of Wollaton Park.

Wollaton East and Lenton Abbey Ward: NDO: Pauline Dorey

Crime: In June 2013 (compared with June 2012) all crime in the Wollaton East and Lenton Abbey Ward increased by 41% (11 crimes) in auto crime, burglary, drugs, and threats and violence, despite a downward trend. In April-June 2013 Crime increased by 7% (8 crimes) compared with the same period in the previous year. The rate for all crime per 1,000 of population in the WELA ward is better than the average for the 20 wards.

ASB: In June 2013 there was a total of 10 ASB calls with a reduction of 3 calls as compared to the previous year. With 45 calls April-June 2013, the Ward has the 2nd lowest volume of calls out of the 20 wards across Nottingham.

May 2013 comparison to previous year has seen an increase of 1 crime in **crimes with a domestic flag.**

Cleanliness of the Ward has increased to 91% which is well above the 'neighbourhood as clean as the city centre' benchmark target of 86%. This is excellent. In June 2013 across the year to date the Ward average was the 4thcleanest in Nottingham. There has been a decrease

in **Graffiti** across the Ward with 2 incidents in June 2013. **Fly Tipping** across the Ward in June 2013 has seen an increase of 3 incidents to 8.

Unemployment: The Wollaton East and Lenton Abbey Ward is ranked 20th lowest out of 20 for all Wards with 136 people that are unemployed and claiming Job Seekers Allowance. There is no room for complacency however and Hope Nottingham are delivering an Employment Pathway for their volunteers. With NDO support there has been successful ongoing volunteer recruitment, development, training and capacity building at Sheila Roper Community Centre. This is highlighted in the Ward Report under the Ward Priorities for Work.

Housing: The ward has a 3 star rating. Letting voids have increased from 1 in 2010/11 to 3 in 2012/2013 with an increase in void to re-let time below current targets. There is only 1 empty property awaiting de-commissioning in the Ward. 100.4% of rent charged has been collected which is excellent.

Community Protection: There were no orders issued in the Ward for June 2013 and no Fixed Penalty Notice (FPN) data available.

Fire: Even though incidents of Fire are low in the ward with only 3 fires April - June 2013. With the Ward in 2012-13 ranking the lowest for All Fires (property and secondary) out of 20 wards across Nottingham. Events and Home Fire Safety Checks targeting vulnerable residents and groups and school children continue to take place in the Wollaton East and Lenton Abbey ward.

Health: Health data is not currently available for the ward. Gentle exercise sessions have started in May following a successful funding bid to Decade of Better Health by Wollaton Park estate Over 50's Coffee Morning group supported by WELA NDO. These have attracted old and new members to the group and are already having a positive impact on citizens' health.

Key Successes:

Lenton Abbey Fun Day – an extremely successful event attended by over 500 people of all ages and communities organised by Lenton Abbey residents including a wide range of performers from belly dancers and cheerleaders to brass bands. Despite the sweltering sun young people and adults took part in the football and tennis coaching, climbing wall and other sports and fun activities and with many new community stalls including Neighbourhood Watch, University of Nottingham, Changemakers etc and local crafts sole traders. The graffiti art and digital media workshops were extremely popular with long queues of children and young people. **Councillors led consultation on future ideas and developments on Lenton Abbey Park**.

There has been a very well attended Councillor led Consultation meeting with residents from **Hawton Spinney and the surrounding area** to review current maintenance and discuss new Plans to further develop the wildlife habitat of the Conservation site with advice from Notts Wildlife Trust and Natural England. This gave a wider more representative group of citizens an opportunity to raise their issues and concerns and reach a very positive outcome.

Fun Day on Farndon Green – as a result of the successful first city pilot of the one-off large and small household WEEE Waste Electricals and Electronic item doorstep collection in Lenton Abbey with items being recycled for re-use by a new partnership with British Heart Foundation and other items recycled. On 23rd August this has been repeated in the remainder of the ward (Wollaton Park estate). As fuel poverty is high in the ward Energy conservation, Switch and Save advice and recycling and environmental issues as well as community consultation on Neighbourhood Transformation issues and projects and community involvement are key themes for this event. This event also gives local groups the opportunity to recruit new members, fundraise and share the valuable work they do.

Sheila Roper Community Centre Refurbishment – Following the painting of the meeting room by University of Nottingham student volunteers the Management Committee have been inspired and plans are progressing with the Management Committee finalising details for the refurbishment of their kitchen and lobby space through NCH partners. With support from the Family and Community Team and NDO, new and existing volunteers have finished their Safeguarding, First Aid and Playworks training, reviewed Policies and set up systems and are running a summer playscheme for Lenton Abbey children and families with several trips. Following this positive experience they will start a weekly Afterschool Club in Lenton Abbey when the school term starts in September.

Sutton Passeys Crescent Play Area- community engagement and consultation on the use and future development of the park started with a 'Young People and Family BBQ' on the play area on Wollaton Park on 1st August

Visit to Arkwright Meadows Community Garden – for inspiration and learning for the Wensor Avenue Project residents from Lenton Abbey enjoyed a visit to this flourishing resident led community garden in the Meadows who have just opened their new Visitor and Training Centre.

Neighbourhood Transformation Plans - are currently being developed with partners and Councillors.

Area Capital and Public Realm Funds works have been completed with extended linings across the Ward, new signage and replacement and new tree planting are currently being planned.

Issues:

Ongoing issues with parking both in Lenton Abbey and Wollaton Park estate due to street design and damage to grass verges on Woodside Road mainly by the University of Nottingham staff and students. Further detailed development work and problem solving has been undertaken with Traffic Management and Highway Services consulting with NCH and other partners to formulate proposals for an Experimental Traffic Restriction Order (TRO) in Lenton Abbey which is currently under community consultation. This being the first of its kind. Working with Traffic Management a Traffic Survey has been undertaken in the Wollaton Park estate at the beginning of the summer to clarify issues and identify possible solutions. The results and possible proposals will be fed back for community dialogue and consultation at the Farndon Green event in August and at other community meetings.

Events:

During this quarter a range of events and meetings have and are due to take place including TRA and Local Action Group (LAG) meetings, NCH Area 7 Panel meeting, Sheila Roper Community Centre Management Committee, Community Meetings, Wollaton Park Resident Association AGM and Autumn event. Working in partnership with Notts Clubs for Young People, SEND Project and resident led voluntary schemes and Family and Community Teams a new diverse summer programme has been delivered to children and young people across the ward to increase engagement and opportunities for families. This has proved popular and successful.

The NAT (Neighbourhoo Action Team) which has representation of various key service providers across the Ward are currently delivering on the revised and refreshed Ward priorities. There has been strong partnership working with NCH, Community Protection and

City Services on patch operations on cleansing and enforcements which have proved very effective. There are still ongoing cleansing challenges with student HMO's at the end of term. Working with Equation (previously Nottingham Domestic Violence Forum) valuable Domestic Violence Awareness and Referral training was delivered in July to statutory and VCS partners staff and resident volunteers in the ward at Sheila Roper Community Centre including Hope Nottingham, Changemakers and Tum Tum Housing Association.














Introduction

- The WELA ward has a growing diverse community in Lenton Abbey with 74% white British and 6% other white some of whom have English as another language and others of mixed heritage, Black British and Caribbean and Asian origin. The 2012 Insight and 2010 ONS statistics are slightly skewed by the transient student population mainly studying at University of Nottingham.
- Wollaton Park estate has a hidden community of disabled children, young people and older adults and due to caring responsibilities have pockets of fuel poverty.
- In the top 10% nationally of SOA's for Crime and Disorder and Income Deprivation affecting children. However reported crime figures have generally fallen across the ward compared to the previous year.
- Wollaton Park estate have seen a growing number of HMO's and are experiencing increasing problems with their landlords.
- Ongoing car parking and traffic issues across the Ward











Cleanliness Index

This graph shows the position of your ward compared to other Wards



The "neighbourhood as clean as the city centre" benchmark target on cleanliness is to achieve a score of 86% in every ward. The 86% target is shown in red in the above graph.

To calculate the Cleanliness Index (CI) an agreed number of transects are surveyed across an area covering a range of land types. Each site surveyed is awarded a cleanliness grade based on a 7 point scale from A to D where Grade A: – no litter, and Grade D: - heavily littered. The maximum possible score of 100 is achieved when all sites achieve Grade A.

The Code of Practice for Litter and Refuse (COPLAR) requires councils to strive to reach an 'acceptable' standard of cleanliness (grade B or better) across the Council area. Grade A is the ultimate goal and is how a site should be immediately after sweeping but is almost impossible to maintain for any length of time. For example, a grade A site is completely free of litter – one cigarette butt takes it down to B+.

To achieve the manifesto commitment of Neighbourhoods as clean as the City Centre a target of 86 is required as that was the CI for the City Centre in May 2011. To give some context if all areas surveyed achieved a grade 'B' standard, this would equate to a cleanliness index of 67.












Methodology

Where a ward boundary overlaps with the City Centre, crime data and ASB calls relating to the City Centre have been removed.

Where possible the most recent data is used, although for some areas this may be a month further in arrears.

Discussions continue with other agencies regarding what further data can be included.

1. BACKGROUND

- 1.1 A sum of £16,053.50 for the Wollaton East and Lenton Abbey Ward has been allocated for 2013-4. A sum of £17,454.52 has been allocated for the Wollaton West ward. Both sums include the carry over figures from 2012-13.
- 1.2 The proposed schemes must fit at least one of the following criteria:
 - Improvement of Security for Tenants and Leaseholders (e.g. door entry, lighting, fencing, garage sites).
 - Improvement of the environment for Tenants and Leaseholders (e.g. dealing with graffiti reducing anti-social behaviour, parking issues, drying areas resurfacing).
 - Improvement of spaces for Tenants and Leaseholders (e.g. installation of community facilities or areas on land under NCH management).

2. <u>REASONS FOR RECOMMENDATIONS (INCLUDING OUTCOMES OF</u> <u>CONSULTATION)</u>

Suggestions for schemes may be from a number of sources including tenants & leaseholders, tenants and residents groups, Elected Members, Local Area Group meetings, Ward Walks, Area 7 Panel, Housing Patch Managers and Neighbourhood Development Officers.

1. BACKGROUND

1.1 The Area Capital Programme was established to improve the environment of the neighbourhoods and to create a sense of place for residents in order to improve the quality of life of local people. Since it was established in 2006 to meet the then corporate priority of "Transforming Neighbourhoods", the Area Capital Fund has included a total programme expenditure portfolio of £40 million. The improvements that have been carried out to date using this programme have included footpath, fences, visual enhancements to public realm, refurbishment of parks and improvements to public buildings.

- 1.2 Resources are allocated from the Nottingham City Council general fund, the Local Transport Plan (LTP) and from the Housing Revenue Account. To achieve a joint approach to environmental improvements in neighbourhoods, a greater degree of flexibility has been established to prioritise and deliver improvements so that there is a synergy in local solutions for local issues across neighbourhoods.
- 1.3 The programme of works is a rolling programme. There have been instances where schemes are started, with strong community involvement and interest, only to be altered at a later stage due to changing circumstances, such as economic conditions and changes in land values. The most up to date position regarding the attached appendices will be reported at the meeting.

2. REASONS FOR RECOMMENDATIONS (INCLUDING OUTCOMES OF CONSULTATION)

- 2.1 The Nottingham LTP 2011-2026 maintains a commitment to deliver local transport improvements across Nottingham's Neighbourhoods and prioritises small scale transport improvements of importance to local communities
- 2.2 As part of the budget approved in March 2011, Nottingham City Council approved an LTP capital allocation of £2.5 million Citywide between 2011 -2013. As part of the budget approved at Full Council on 4th March 2013 Nottingham City Council approved an LTP capital allocation of £2.5 million Citywide between 2013 -2015. In addition for 2013-2014 a Public Realm General Fund has been approved of £750,000 Citywide.
