#### 33 <u>DECLARATIONS OF INTERESTS</u>

#### 34 MINUTES

The Area Committee confirmed the minutes of the meeting held on 11 November 2013 as a correct record and they were signed by the Chair.

#### **Progress Reports**

#### (a) Wollaton Park Play Area

A further meeting indicates that the proposal to move the site of the playing area means that the matter will need to be reconsidered divide development colleagues and English Heritage. This should take 2-3 weeks and, if approved, would enable work to begin.

#### (b) Middleton Boulevard Conservation Area - Title

The matter has been raised with Development colleagues, before taking the matter further, an indication costs will be needed and Development colleagues are able to work with local residents on documentation to be prepared for the consultation process.

#### (c) Harmonisation of Vehicle Speed Limits

The issue is being progressed and responses from colleagues to queries regarding costs, et cetera, are awaited.

#### 35 COMMUNITY REPRESENTATIVE UPDATE

Councillor Steve Battlemuch welcomed Rob Kirkwood to his first meeting of the Area Committee as the Community Representative for the newly formed Friends of Wollaton Park Organisation. Those present introduced themselves and Mr Kirkwood provided a brief overview of the organisation's work to date.

### 36 SCHOOL TRAFFIC ENFORCEMENT PROGRAMME AND RESIDENTS' PARKING SCHEME UPDATE

The Chair introduced Susan Thorpe, Senior Traffic and Safety Officer, Development Department, who outlined progress on the following matters of local interest:

#### (a) School Traffic Enforcement Programme

The issue is the cause of many complaints to the City Council by residents and other road users, regarding congestion and nuisance being caused by inconsiderate driving and vehicle parking in the vicinity of local school premises at the beginning and end of each day.

To help manage and eliminate problems being caused, a week of action - style event has been developed in conjunction with police and enforcement division colleagues. Using Area Committee boundaries, from February 2014, each area will be targeted by police and enforcement division colleagues during the roman times a day during identified week to monitor and, where necessary, issue fixed penalty charge notices to errant road users to mitigate situation. The current intention is to revisit each area on a rolling basis every 5/6 weeks.

Locally, this Committee's first week of action will begin on 24 March 2014. All schools will be advised in advance of the proposed timing of the intervention and issued with toolkits to assist in identifying measures which may be taken to ensure that any adverse effects by/on local drivers are minimised.

In the meantime, the opportunity has also been taken to engage with vehicles/drivers outside local schools around the Harrow Road area on a three-day period during a recent week of action to test the reactions to proposals including installation and enforcement of zig - zag parking restrictions outside schools on either both or just the non-school side of the road, or using an alternative off-site parking venue, such as Wollaton Community Centre and then encouraging children to walk into the score (four minutes away).

The exercise demonstrated the benefits to young people and residents on making areas, car-free zones, but measures to achieve this - such as yellow line parking restrictions -may not be popular with all the local residents. It is also important to engage with the young people who attend the school. Comments expressing a wide spectrum of views have been received to the proposal.

#### (b) Residents' Parking Scheme

Sue Thorpe also drew attention to the processes associated with the possible introduction of a residents parking scheme once the current temporary traffic regulation order attached to the refurbishment of the Bluecoat School expired in April 2014. Other alternatives, such as moving single yellow lines on bus routes to the opposite side of the road, and protecting junctions by the

introduction of double yellow parking restrictions will also be consulted upon, although local residents seem currently in favour of the parking scheme

#### RESOLVED to note the current position.

#### 37 BRAMCOTE LANE TRAFFIC CALMING SCHEME

The Area Committee had previously discussed the issue of replacing existing elements of the, now dilapidated, traffic calming measures on Bramcote Lane at its meetings on 16 September (minute 18) and 11 November 2013 (minute 26), when the Chair, Councillor Battlemuch, reported that current proposals, then costed at £123,000, exceed the budget available and further consultations would be required to determine a way forward.

Lylse-Anne Renwick introduced a report of the Director of Neighbourhood Services which summarised the latest position and showed a revised cost for the proposals of £100,000 to be funded by contributions of £60,000 from the Local Transport Plan provision and £40,000 from the Wollaton West Area Capital Fund. The following range of replacement measures proposed to improve the vehicle driver experience along Bramcote Lane were explained by Scott Harrison and Navid Arif of the Traffic and Safety Division:

- Replacement of the existing 1.9m² speed cushion arrangement by 70 millimetre high round topped road humps extending across the width of the carriageway which, due to their bituminous construction, would give a smoother ride for all vehicles;
- Removal of the existing raised plateau close to the Bramcote
   Lane/Wollaton Road junction and installation of a zebra crossing to
   enable residents to cross safely and improve their accessibility to bus
   stops, library, community centre, nursery and other local amenities;
- Installing other traffic calming measures such as give-way build outs to slow traffic speeds, situated close to bus stops to improve accessibility to public transport, featuring dropped curbs with tactile paving to create shorter crossing distances;
- Installing double yellow lines at all minor junctions along the route, to provide junction protection and improve visibility for all road users;
- Working with Wollaton Historical and Conservation Society to tidy up the area around the water pump and consider using primrose yellow 50 mm lining in the Bramcote Lane area, so as to be more in keeping with the nature of the environment;
- subject to funding, installing two, vehicle activated signs (VAS) along its length, to remind motorists that Bramcote Lane is a 20 mph speed zone.

Councillor Culley, by way of an amendment, proposed that:

- (1) the existing speed cushions should be removed and, instead of replacing them with round - topped road humps, undertake a thorough consultation exercise seeking residents and road users views on all possible options;
- (2) the removal of the existing raised plateau close to the Bramcote Lane/Wollaton Road junction and the remaining aspects, excluding (1), above should be proposals for consultation only at this stage.

Honorary Alderman Hamilton circulated the observations of the Wollaton Historical and Conservation Society on the proposals contained in the report, which broadly supported Councillor Culley's amendment.

They also drew attention to:

- the extension of a 20 mph speed zone into the area, but without the benefit of other traffic calming measures currently included on Bramcote Lane, making it an apparent anomaly. The 20 mph speed zone could be extended eastwards of the Admiral Rodney Public House up to Russell Drive;
- proposed installation of a zebra crossing close to the Bramcote
   Lane/Wollaton Road junction, remaining speed bumps, proposed 'Build
   outs' and tactile paving and placing double yellow lines on every corner
   were unnecessary. However, one set of speed bumps could be placed on
   each of the approach roads to the square to reduce speed and potential
   conflict between pedestrians and vehicles;
- the proposal to install two vehicle activated signs on Bramcote Lane is supported and a further sign should be installed on the approach to the dangerous bend at the bottom of Church Hill, opposite Rectory Gardens;
- The proposals as submitted do not represent value for money or address the problem of the speed bumps or the inconvenience which they cause to residents and damage to their vehicles;
- The majority of people attending meetings of the Historical and Conservation Society consider, when asked, that the proposed scheme is a waste of money and that speed bumps should be removed entirely. The Council should therefore consider withdrawing the scheme and submit a comprehensive plan for the whole of the Wollaton area which will better address the problems;
- The proposal to consult local residents and road users, suggesting that any consultation material should seek views on:
  - Whether the proposals set out above are supported?; Whether the speed bumps should remain as they are, or should be removed, except for those closest to the Square?

#### **Discussion**

Community Representatives noted the proposal that "built out" measures will be illuminated by solar panel bollards, but also expressed the view that these features should, nonetheless, be properly lit to make oncoming traffic aware of them and avoid potential accidents.

Several attendees reiterated the view that the Area Committee should take local views into account and that genuine consultation should include the widest range of residents and users, should be meaningful and should include a range of alternatives where possible.

The view that the City Council will be most reluctant to endorse formally alternative proposals which will see the removal of traffic calming features without recommendations for alternative measures also being included, due to the need for the authority to be seen to be actively promoting vehicle and personal safety and to avoid potential legal liability claims in the event of accidents in the future was appreciated by the Committee, but did not appear to move the matter further forward in a positive way.

The intention of Nottinghamshire Police to establish a vehicle speed group to monitor vehicle speed in the area, passing information from local residents to them to inform targeted enforcement action to reduce the problem is supported.

The interpretation that any formal vote on the proposals and/or alternative solutions was capable of being taken only by Councillors due to the inclusion of information about the source of financing, was not readily understood as, currently, the proposals are to be approved for public consultation purposes, before being finalised at a future meeting of the Area Committee.

#### **RESOLVED** by a majority of three votes to two:

- (1) to reject Councillor Culley's proposed amendment outlined above;
- (2) to approve the proposals as set out above for public consultation purposes with local residents and road users, before being considered again at a future meeting of the Area Committee;
- (3) to note the revised cost and funding arrangements.

#### (b) Police and Neighbourhood Development Updates

Sgt Hallsworth reported recent personnel changes within the area and, to the detail in the report, referred to the following:

**Burglaries:** appropriate measures have been put in place to stem the recent rise in burglaries on domestic properties. A similar approach will also be taken to reduce the levels of car crime.

Violent crime, etc: Police colleagues are working with representatives of the University to reduce cycle thefts, where four arrests have been made so far and violence at the Queens medical Centre. Comments that some localities did not currently have an allocated beat officer will be followed up and the emergence of racist graffiti in Lenton Abbey will be investigated.

Jon Marsh commented on neighbourhood environmental matters including the levels of cleanliness in the wards, that attempts will continue to be made to improve the current 48-hour collection service for large domestic waste items and the refurbishment of the Sheila Roper Community Centre has been completed successfully.





## Perceptions of ASB in the City Centre by year (very or fairly big problem) (%)




#### Perceptions of Anti-Social Behaviour in Local Neighbourhood by Year (very or fairly big problem) - (%)



# Change in ASB over time (Composite Score)





#### 1. REASONS FOR RECOMMENDATIONS

- 1.1 To support participation in the East Midlands in Bloom competition
- 1.2 To encourage community involvement in Nottingham in Bloom and Parks initiatives

#### 2. BACKGROUND (INCLUDING OUTCOMES OF CONSULTATION)

2.1 Nottingham in Bloom is a corporate initiative linking local communities, businesses and individuals through sustainable partnerships, working together to produce horticultural excellence and enhance the local landscape, environment and character of Nottingham.

#### Participation in Bloom and Parks initiatives

- 2.2 The East Midlands in Bloom campaign is run by the Royal Horticultural Society and is the regional arm of Britain in Bloom, which is celebrating its 50<sup>th</sup> anniversary this year. The aim of the competition is to improve the environment, with marks awarded for Horticultural Achievement, Environmental Responsibility and Community Participation. Nottingham has won the title of 'Best Large City' 20 times, most recently in 2013 when the city achieved a prestigious Gold Award.
- 2.3 Two judges from East Midlands in Bloom will visit Nottingham on 10<sup>th</sup> July 2014. It is proposed to showcase some of the excellent environmental work underway in the Wollaton and Lenton Abbey area. The judges will potentially meet local volunteers at Wollaton Park, Martin's Pond, Wollaton Library garden and Wollaton Dovecote garden. The tour will also include a number of residential streets such as Lambourne Drive and Torvill Drive, and will pass several sponsored traffic islands such as Hemlock Stone and Broadgate, as well as Lenton Abbey Park.
- 2.4 Thirty five Nottingham groups participated in the Royal Horticultural Society Britain in Bloom 'It's Your Neighbourhood' awards 2013, including five groups from the Wollaton and Lenton Abbey area: LAFFDA, Aspinall Court, Wollaton Library, Wollaton Park Community Centre and Wollaton Park Residents' Association. The awards recognise and reward gardening achievement, environmental responsibility and, most of all, community participation. A similar campaign is being run this year.
- 2.5 Martin's Pond has held a Green Flag award since 2006 and Wollaton Park Community Centre garden a Green Flag Community Award since 2009; both hope to retain the awards again this year. In addition, for the first time Harrison's Plantation will also be seeking Green Flag accreditation this year.

#### 1. REASONS FOR RECOMMENDATIONS

1.1 Section 21 of the National Parks and Access to the Countryside Act 1949 gives local authorities the power to acquire, declare and manage nature reserves. These sites are commonly known as Local Nature Reserves (LNR's) and are statutory protected sites which are of a high value for nature conservation and provide opportunities for people to enjoy Paid and recreation. From Natural England's

perspective LNR's have an important part to play in biodiversity conservation, the protection and interpretation of features and in helping to reach priority targets. Local Authorities can benefit from declaring Local Nature Reserves through the contribution that the sites make to the quality of the environment for local people, the part that they play in community development and their value in education.

- 1.2 Natural England recommends that Local Nature Reserves be provided at 1 hectare per 1000 population; Nottingham currently has 13 LNR's and LNR provision stands at 0.53 Ha per 1000 population.
- 1.3 Provision for further LNR's has been discussed at the Open and Green Spaces Champions Group and is an action in the 2011 Breathing Space strategy and the Biodiversity Position Statement (BPS). The target within the BPS is for an additional 10 LNRs by 2020. A list of proposed LNRs has been produced in agreement with the Champions group.
- 1.4 Wollaton Park within Area 7 has been selected for designation as an LNR due to its ecological importance and position within the community. Not all of the site is proposed (see Appendix 1) in order to retain the multifunctional nature of the site. If the designation proceeds the site will exceed the City Council's target of providing 1ha LNR per 1,000 population to 1.08ha LNR per 1,000 population.

The site largely comprises historic parkland, mixed deciduous woodland, acid grassland and open water. Woodlands are diverse and include oak, beech, sweet chestnut and lime with an understorey of rhododendron, yew, hawthorn, hazel and other regenerating tree species. Lime Tree Avenue to the east is as the name states, two rows of mature lime trees parallel to a main pedestrian route into the site and vehicular access to the golf course. The golf course is a typical mosaic of well maintained amenity grassland; rough grassland, individual trees and bare sand.

The two deer herds comprise of 150 fallow deer and 80 red deer. They are free to roam across the whole site and have fenced off areas where they can seek refuge during rutting and calving seasons as well as when the park is busy.

Surfaced paths run throughout the site and are easily accessible for all abilities. Pedestrian entrances exist off Wollaton Road, Middleton Avenue and Parkside. Vehicular access is via Wollaton Road and there are two pay and display car parks available which serve the entire site.

#### 2. BACKGROUND (INCLUDING OUTCOMES OF CONSULTATION)

2.1 Between November 2013 and February 2014 a public consultation was held on the proposals to designate part of Wollaton Park as an LNR.

The consultation involved the following:

- Displaying a sign on the site entrances
- Posters within the Hall
- Letters to adjacent residential properties (212)
- Letters to internal and external consultees (38)
- Attendance at the Friends of Wollaton Park meeting
- Posters in community notice boards
- Meeting with Wollaton Park Golf Course
- Site visit with Natural England

- Online consultation promoted on website and Parks and Open Spaces Facebook page
- 2.2 11 email responses were received from members of the public. 12 online responses were submitted through the on-line consultation. Internal emails were received from colleagues Arts and Events, Rights of Way and Drainage. Letters of support were received from the Wollaton Park Golf Course and the Nottinghamshire Wildlife Trust. No support letter has been received from Natural England to date, as they have requested a final boundary following the consultation. This will be sent in May 2014. A summary of responses is detailed below:

#### External responses

Severn Trent have enquired as to the implications of the designation. They have been advised that they will still be granted access for necessary works. We have asked that they contact us in advance of any planned work.

The National Grid has asked to be made aware of our decision to proceed with the designation.

#### Online responses

Of the 12 responses submitted, 10 people said they were in support of the proposals and 2 said there was not enough information about any restrictions or limitations that may be put in place. There was no way of responding to these queries as they did not leave contact details. One consultee commented that they were in support if necessary measures were in place to protect boundaries properly and prevent badgers from escaping the park.

#### Internal responses

The Senior Drainage Engineer responded regarding Wollaton Park lake (classified as a dam) and the associated its associated control features and the watercourses downstream of the dam. The dam is Category A (highest risk category) and is subject to the Reservoirs Act 1975. Concerns were raised about an LNR designation preventing the Council from complying with the associated legislation. The dam area has high botanical value. Advice from colleagues in the Legal department is that the statutory responsibilities with regard to the dam aren't considered a bar to declaring a nature reserve. The declaration would enable the lands to be managed for a recreational purpose which would include preserving wildlife. They advised that the management plan includes ways to establish a working relationship with colleagues to ensure no harm to the area during statutory works.

The Public Rights of Way Officer is in full support of the proposal

The Markets and Events Service Manager submitted the following comments:

#### • Lime Tree Avenue

This is the main vehicular access point during large scale events so there is a significant amount of traffic on the avenue on these days. In the past some vehicles have been parked on the verges of the avenue.

#### • Middleton Paddock

The former cricket pitch and Pilkington's Paddock are used for event car parking and exhibitor's caravan parking. As long as the option remains to continue to use

these areas for these requirements then the proposal should not impact the events programme.

#### Various Footpaths

The site is used for cross country and orienteering events. Local Nature Reserve which would link up to form a route for this type of activity. We discussed that a small scale event would not have an impact on the reserve, but there is ambition to host national and international events that could become a much larger scale event. The proposal should be flexible enough to allow such events to be staged.

The Local Nature Reserve designation handbook advises that Schedule 11 (12) of the Natural Environment and Rural Communities Act 2006, which replaced Section 15 of the National Parks and Access to the Countryside Act 1949, describes a 'nature reserve' as:

- o land managed solely for a conservation purpose, or
- land managed not only for a conservation purpose but also for a recreational purpose, if the management of the land for the recreational purpose does not compromise its management for the conservation purpose.

Some of the current recreational activities that take place would not appear to be an appropriate use of a LNR, and the management of the site for the recreational purposes could be seen to compromise its management for the conservation purpose. The boundaries have been drawn up to reflect this. Occasional use of parking would have to be controlled to ensure no damage to ground flora. Consultation with Arts and Events team prior to event planning is recommended.

#### Email responses

## MPLICATIONS (INCLUDING VALUE FOR MONEY/VAT)

4.1 In declaring the site as a Local Nature Reserve there is a duty to maintain safe access and manage it for the protection of wildlife and biodiversity, however as the site is already owned by Nottingham City Council and maintained as accessible, this duty already exists.

## 5. RISK MANAGEMENT ISSUES (INCLUDING LEGAL IMPLICATIONS AND CRIME AND DISORDER ACT IMPLICATIONS)

#### 5.1 <u>Legal Implications</u>

The declaration of the site as an LNR is within the Council's powers subject to the relevant processes being followed.

All sites are free to access and aim to be accessible to all. Any capital works and improvements identified will consider the requirements under the Disability Discrimination Act and will seek to identify and remove physical and emotional barriers to access. Designating the site will ensure that it remains as natural open space, which is accessible to all communities and will therefore play a part in improving the quality of life of the local residents and citizens from the wider community now, and into the future.

#### **Crime and Disorder Act Implication**

The project will help to attract additional visitors to the park and reduce the fear of crime and disorder.

#### **Health and Wellbeing Implications**

The project will help to improve the wildlife based education and interpretation on the site. These improvements will encourage more people to participate in casual recreational activities such as walking and wildlife watching, contributing to improvements to physical and mental health.



Summary of issues (including benefits to citizens/service users):					

Further to receiving a Stage One Heritage and Big Lottery Parks For People Fund (HBLPPF) approval in July 2013, the Project Team have now worked up the detailed designs and have carried out additional consultation / consensus checks with park users and project partners such as the University of Nottingham, the Environment Agency ("the EA") and the Highfields Park User Group.

This report presents the final Highfields Park Landscape Restoration Project and seeks the Committee's endorsement to submit a detailed Stage Two project application to the HBLPPF in August 2014.

#### Recommendation(s):

1 That the Committee approves and endorses the Highfields Park Landscape Restoration Project and the Stage Two HBLPPF bid as detailed in sections 2.2 – 2.8 of this report.

#### 1. REASONS FOR RECOMMENDATIONS

The recommendations are being sought in order to ensure that the restoration project can continue with full support of the Area Committee before the Stage Two bid is presented to Executive Board for final approval prior to submitting the bid to the Lottery in August this year.

#### 2. BACKGROUND (INCLUDING OUTCOMES OF CONSULTATION)

- 2.1 Highfields Park was laid out in the early 1920s as a public park on the initiative of Sir Jesse Boot, it opened partly in 1923 and the public was given its full use in 1926. The ownership was transferred to the City Council in 1923. It is one of the first man-made, large-scale public parks of the 20<sup>th</sup> century. By virtue of its value Highfields Park was included in English Heritage's Register of Parks and Gardens of Special Historic Interest and was given a Grade II listing (Ref GD 2771). Recognising the importance of this historic urban park, English Heritage has recently uplifted its status to Grade II\*.
- 2.2 In the last two years a number of reports (as detailed in section 8) have already recognised the need and provided justification for this greatly needed restoration project. In July 2013 our first round project application received a Stage One pass from the HBLPPF. Included with this pass was a development grant of over £280,000 which represented 93% of the total £300,542 development costs. This funding represented a pivotal turning point in the park's restoration journey and as a result the funding has been used to assemble a project team, commission detailed architectural and landscape design works, and to drive forward more detailed condition and topographical surveys including the lake restoration, tree works and the restoration of listed / historic buildings and features within the park. Included within the development funding was an allocation for a new dedicated Park Ranger. This new post was successfully filled in January 2014 and since this time the new Ranger has started to work with the project partners and has already significantly improved the day to day engagement with park user and project partners.
- **2.3** As part of our stage one pass the HBLPPF placed a number of special conditions on the project as follows
  - The stage two bid needs to provide a sustainable solution to the lake and Tottle Brook silting problem.
  - NCC to fully engage the Environment Agency to seek their full support for the lake / Tottle Brook silt proposals.
  - To investigate opportunities to develop and support a social enterprise within the park.
  - NCC to secure the commitment from Nottingham University to deliver their annual events programme funding contributions to the project.

The project team and our partners have managed to fully resolve all these special conditions and have identified a sustainable method of de-silting the Lake. The EA have been active project board members since day one. We have already identified and have trialled a social enterprise partnership with the Colwick Park Lifeguards to manage the boating concession and possibly the most significant change has been that the University of Nottingham are no longer just a partner, but will be cosignatories of our Stage Two bid. This is major step forward and now recognises the University's full support for the project. As a result we are now in a confident position and ready to drive forward with our final preparation of the bid ready to submit later this summer.

The project consists of a comprehensive programme of restoration works designed to fully restore the park, build upon its heritage and create a range of community facilities fit for the 21<sup>st</sup> century. The Stage Two bid includes key features that closely align with the strategic priorities of the HBLPPF - **Appendix 1 includes plans of the key restoration projects and the revised master plan.** 

#### 2.5 Public Consultation and Project Consensus Checks

During the 2014 Easter holidays, an extensive consultation exercise was undertaken at Highfields Park and online to ensure that the park restoration proposals meet people's expectations following the earlier consultation in 2012. A static display was present on the park during the Easter holidays and colleagues were present for several hours each day to explain the proposals to park users and encourage them to complete questionnaires. An Easter bunny hunt was also provided to engage young children and their parents.

150 questionnaires were completed in person and 70 more received online; at the current time, the results of this feedback is being evaluated and this will form a consensus check report and also feed heavily into the Activity Plan – one of the key questions in the consultation was about the sort of events and activities people would like to see on the park.

#### 2.6 10 Year Maintenance and Management Plan (MMP) and Activity Plan

The MMP and are two of the suite of documents that will be submitted to the Lottery alongside the restoration plans. It will assess who the current park users are, why they use it and what they do at the park. The MMP will discuss how the site will be maintained to a consistent Green Flag standard on both the Trust land and land directly managed by the University. The Activity plan will investigate who doesn't use the park already, why not and what can be done to attract new audiences to the park. The action plan will include an ambitious list of potential events, activities and audience engagement techniques for the park, from which a select list will be funded by the Lottery bid and led by the Park Ranger, in partnership with the University of Nottingham and the Lakeside gallery and theatre.

#### 2.7 Training and Volunteer Plan

In addition to the MMP and Activity Plan the Highfields Park project, will through a partnership with the Nottingham City Council Employment Hub and the LEP, generate opportunities for local small and large businesses, as well as individual employment opportunities during the construction stages, a range of new vacancies, apprenticeship, entrance trainee opportunities and work experience placements will be created .

#### 3. OTHER OPTIONS CONSIDERED IN MAKING RECOMMENDATIONS

Without full endorsement and approval the project will not be able to proceed to the Stage Two bid and the park restoration and improvement will not take place.

The total cost of the proposed scheme is estimated to be £3,894,533. Proposed funding sources are;

The City council contribution will be funded from the existing Parks & Open Space revenue budget over a 5 year period. The WREN (Waste Recycling Environmental Ltd) and the Veolia grants have yet to be confirmed.

#### 5.2 Risk and Opportunity Management

The main risk at this point is if the Heritage Lottery Bid is not successful. In order to reduce this risk a realistic project proposal has been designed and all fees and charges accounted for. In addition £400,000 of the match funding has already been secured and the remaining funding bids are both realistic and achievable.

#### 5.3 Performance Management

If the Stage Two submission is successful, workload planning will ensure that the preparation of the Stage Two bid is delivered by a cross departmental project team and therefore will not impact negatively on the rest of the Parks & Open Spaces Service.

#### 5.4 Communications

There will be several key stages through the project to link to a communications plan:

- Ongoing public consultation on the project make-up and to demonstrate support and need for the project - following the Stage Two bid.
- Result of the Stage Two bid.
- Construction on site will include a detailed communication plan to cover all the key stages of the build phase and help to inform park users re localised closures during press the build phase e.g. the lake de-silting.

#### 5.5 Crime and Disorder Act Implication

The project will help to improve the security of buildings and to improve the visual appearance of the park. In addition the increased site based staff presence and increased park user will all help to provide a friendly reassurance and remove any low level fear of crime and disorder.

#### 5.6 Health and Wellbeing Implications

The project will help to improve the general facilities within the park, including paths and seating along with general aesthetic improvements. These improvements will encourage more people to participate in low level physical activity. The project with the support of the Park Ranger will target current non users and encourage people who are not currently active to participate in activities such as a walk around the park or a wide range of out door healthy lifestyle activities and events.

Summary of issues (including benefits to citizens/service users):						

This report is to update the Area Committee of the progression with the proposed traffic calming review scheme along Bramcote Lane (between Wollaton Vale and Wollaton Road).

To date we have had 118 responses either through email, letter, 'phone calls or attendees to the four events.

75% of citizens support or partially support the scheme. However, this figure is dependant on removing the chicane/give-way features in replacement for the pedestrian refuges - which we will do. And any firm objections to the scheme were linked to the chicane/give-way features, which are not going ahead. The chicane/give-way features were removed due to concerns over congestion and tail-backs.

12% of citizens who responded would like to see all traffic calming features removed entirely.

Overall, the humps replacing the speed cushions, the new zebra and the pedestrian refuges were popular features with the citizens. A small group of citizens have concerns that the zebra may still cause congestion at the new location and will not be in-keeping within the village, due to the flashing beacons. Citizens were also concerned over pedestrian safety around the junction of Wollaton Road close to the Admiral Rodney public house therefore the footway layout has been reviewed and the changes proposed.

The funding split is £60,000 from the Local Transport Plan with a contribution of £40,000 from the Wollaton West Area Capital Fund.

#### Recommendation(s):

- Replace the existing seven pairs of speed cushions with six round top road humps; similar to the humps on Parkside. One pair of speed cushions will be removed to allow one of three pedestrian refuges to be built. This will also reduce the number of raised traffic calming features.
- Remove the existing raised plateau near the Community Centre and Library to further reduce the number of raised traffic calming features.
- Remove the three proposed chicane/ give-way features due to possible congestion issues and instead install three pedestrian refuges to improve pedestrian safety.
- 4 Relocate the proposed zebra crossing closer to the Library and Community Centre to be closer to the pedestrian desire line and to lessen the possibility of congestion onto Wollaton Road.
- 5 Slightly relocate bus stops (WO18 –Community Centre) and (WO07 Library) to accommodate the proposed zebra crossing.
- 6 Create new and safer crossing points for pedestrians by extending the paving (Riven Yorkstone) around the Village Pump to Wollaton Road.
- 7 Create a new footway by building out from the northern side of Bramcote Lane with Wollaton Road and to accommodate three parking spaces adjacent to the cottages.
- 8 Create a new safer crossing point for pedestrians by building out the footway on the southern side of Bramcote Lane with Wollaton Road. This will also create potentially four new parking spaces adjacent to the cottages on the south side of Bramcote Lane.
- Remove the proposed two Vehicle Activated Signs ("too expensive" & "not in-keeping with the area") and instead replace with 20mph roundels on the carriageway, at appropriate locations, to remind motorists to travel at 20mph.
- Relocate the existing internally illuminated "keep left" bollards away from the Village Pump and put in recessed up-lighters to highlight the Village Pump.
- In partnership with Nottingham in Bloom relocate and upgrade the existing planters and put in additional planters where appropriate.
- 12 Remove unnecessary pedestrian guard railing around the Village Pump area.
- Relocate the triangle warning "bend ahead" sign adjacent to St Leonard's Church to a more appropriate location.

#### 1. REASONS FOR RECOMMENDATIONS

- 1.1 Ward Councillors have prioritised a scheme for the existing traffic calming along Bramcote Lane between Wollaton Vale and Wollaton Road. The existing traffic calming features are approximately 13 years old and in poor condition giving a poor ride quality to users.
- 1.2 The formal consultation is programmed to begin in June 2014. Two Community Events will also be held during the formal consultation process to enable citizens to comment on the proposed scheme. All changes are subject to consultation. The plan showing the proposals detailing the above alterations is currently against and is not yet available.

1.3 All statutory consultees will be contacted to ensure there are no objections prior to the commencement of any actual works.

#### 2. BACKGROUND (INCLUDING OUTCOMES OF CONSULTATION)

2.1 The proposed features of this scheme are subject to consultation. The plan showing the proposals detailing the alterations is currently being designed and will be available before the start of the consultation.

#### 3. OTHER OPTIONS CONSIDERED IN MAKING RECOMMENDATIONS

3.1 Other options regarding elements of the design may arise through the Engagement and Consultation process. All changes are subject to consultation.

#### 4. FINANCIAL IMPLICATIONS (INCLUDING VALUE FOR MONEY/VAT)

4.1 The estimated cost of this proposal is £100,000. This will be funded as follows: £60,000 from the Local Transport Plan (LTP) provision; £40,000 from the Wollaton West Area Capital Fund.

#### Summary of issues (including benefits to citizens/service users):

The ward performance reports provide updates on key issues and themes which link back to local priorities and strategic themes in the Nottingham Plan 2020. The reports provide summary updates on the following key themes:

The Central Locality (through the Central Locality Board) has targets to reduce burglary dwelling, shop theft and violence. The Neighbourhood Development Officers in the Wollaton West and Wollaton East & Lenton Abbey together with partners are working towards the reduction.

#### Recommendation(s):

1 To note the key information from the Ward Performance Reports for December 2013.

#### 1. REASONS FOR RECOMMENDATIONS

- 1.1 Ward performance reports provide a descriptive and statistical picture of what is happening at a ward level and invite community representatives to comment, debate, challenge and identify how they can add value to improve their neighbourhoods.
- 1.2 Ward performance reports will also monitor progress in the wards and act as a catalyst for debate about the key performance issues impacting upon the ward on a quarterly basis.

#### 2. BACKGROUND (INCLUDING OUTCOMES OF CONSULTATION)

- 2.1 Neighbourhood Working has been important for a number of years in Nottingham as a means of engaging better with citizens and to drive forward service improvement.
- 2.2 The Nottingham Plan has a goal that 'public service delivery will be better integrated and appropriately devolved, ensuring more accessible and responsive services for all and giving residents more control over what happens in their neighbourhoods'; Ward Performance report will help to support this.
- 2.3 The Ward Performance report captures work at a local level to support the Nottingham Plan; it is a short summary of key updates on priorities and issues in the ward. More detailed implementation plans sit behind the report such as the Ward Action Plan, Neighbourhood Action Team's (NAT) action log, Crime and Drug Partnership (CDP) plans and other partners' implementation plans.
- 2.4 The Ward Performance reports are co-ordinated by Neighbourhood Development Officers, with data analysis undertaken by the CDP.
- 2.5 The following is a brief summary by the respective Ward Neighbourhood Development Officers (NDO) which highlights the key issues: The more detailed Ward reports are attached as Appendix A.

#### Wollaton West Ward: NDO – Lylse-Anne Renwick

#### Crime:

Wollaton West statistic:For the period January 2014 – March 2014 Wollaton West has seen a decrease in burglary dwelling from the period of October 2013 – December 2013, but and increase in burglary other 9/19 and criminal damage 14/20.

**Cleanliness Index:** The neighbourhood as clean as the City Centre is the benchmark target on cleanliness is to achieve 86%. Wollaton West Ward Cleanliness index score is 97% which is above the average of the City Centre.

**Graffiti:** 12 incidents reported an increase of 4.

Fly Tipping: Fly tipping has decreased again in the last three months.

**Dog Fouling:** Dog fouling continues to be a problem for the ward, 30 incidents reported and increase of 24.

Unemployment Rate:

Community Protection: In March 2014 there were no orders issued.

**Fire:** There have been no deliberated fires in the Wollaton West Ward in January – March 2014.

**Key Successes:**Work has begun on the construction of Wollaton Park Play Area on Friday 11<sup>th</sup> April, we estimate that the build time will be approximately 6 weeks; the comments from citizens are "we cannot wait to see the completion of the park and are very pleased that the park is going to be ready for the community for summer".

The Wollaton West Ward Youth in the Park events on Torvill Drive and Rushford Park were great successes with over 40 young people and family's attended. The Ward Councillors provided funding for BBQ and other activities so that the young people in the Ward had access to activities over the Easter holiday. Families came from as far as Beeston, Aspley and Basford to partake in the events and the overwhelming response was that they thoroughly enjoyed the events and hope to see more over the summer.

April 2014 also saw the launch of the Youth Café at Kingswood Church Hall and St Leonard's Community Centre. The First event took place at Kingswood Church Hall on Saturday 26<sup>th</sup> April 2014; we had 35 young people of Wollaton West Ward at our first launch. Young people from Fernwood Senior School, Girls High School and Bluecoat School the overwhelming response from the young people were, it is great to have somewhere to hang out on a Saturday night. Again the Ward Councillors funded the café and the money bought a tennis table, indoor badminton equipment and other sport materials, not only do the young people have somewhere to hand out but they are able to keep fit and play sport together.

**Issues:**Issues are the volume and inappropriate parking along St Leonard's Drive, Rectory Gardens, Tranby Gardens and Parkside Rise. These parking issues are apparently linked to citizens visiting Wollaton Park. Councillor Battlemuch and officers are looking into the issue with the view of a resolution.

**Events:** A range of meetings and events have taken place this quarter including, Wollaton West Community Meetings, Friends of Wollaton Park Group Meeting and Local Area Group meetings.

**NAT's** (Neighbourhood Action Team): - working together on agreed ward priorities set by residents as well as the day to day issues that arise in the ward. The NAT team are at present jointly working to resolve issues across the ward. Issues are parking St Leonard's Drive, Rectory Gardens, Tranby Gardens and Parkside Rise. These parking issues are apparently linked to citizens visiting Wollaton Park.

#### Wollaton East and Lenton Abbey Ward: NDO: Pauline Dorey

#### For The Period January - March 2014

**Crime:** During January - March 2014 (compared with January - March 2013) all crime in the Wollaton East and Lenton Abbey Ward increased by 27% (33 crimes) in criminal damage, thefts with the majority being of bikes from the University and ASB. Dwelling burglary remained the same at 21 incidents during January - March 2014for

the same period in 2013. Please see detailed breakdown. The rate for all crime per 1,000 of population in the WELA ward is 2<sup>nd</sup> lowest across the 20 wards. There is a reduction in violence for the ward Year to Date.

**ASB**: During January - March 2014 (compared with January - March 2013) ASB increased by 43\*% by 12 incidents. The Ward has the 2<sup>nd</sup>lowest rate per 1,000 of population of the 20 wards across Nottingham.

**Domestic Violence Crimes:** 33incidences for 2013-2014 with an increase of 6 (22%) from previous year to date.

**Fire:** Even though incidents of Fire are low in the ward with 1 Primary or Secondary fires in the quarter. With the Ward Year to Date ranking the 2<sup>nd</sup> for All Fires with 6 (property and secondary) out of 20 wards across Nottingham. Events and Home Fire

Safety Checks targeting vulnerable residents and groups and school children continue to take place in the Wollaton East and Lenton Abbey ward.

**Community Protection:** There were Works in Default for the Environment and no Fixed Penalty Notice (FPN) data available.

Cleanliness of the Ward has increased slightly from the previous quarter for January- March 2014 and still well above the 'neighbourhood as clean as the city centre' benchmark target of 86%. There has been a marked increase of **Graffiti** across the Ward with 30 incidents in January and February 2014. **Fly Tipping** across the Ward in January and February is falling from the previous quarter levelling out with 9 incidents.

**Unemployment:**Is increasingly falling for the WELA Ward. Hope Nottingham are developing an Employment Pathway for their volunteers. With NDO support there has been successful ongoing volunteer recruitment, development, training and capacity building Sheila Roper Community Centre. This is highlighted in the Ward Report under the Ward Priorities for Work.

**Housing:** The ward has a 3 star rating. There are currently 2 letting voids in 2013/2014 with a decrease to 13 days in void to re-let time well above current targets. There are no empty properties awaiting de-commissioning in the Ward. 99% of rent charged has been collected which is excellent. 96% of repairs have been completed on target with tenant satisfaction of 8.8. 0.71% of tenancies had to be ended by eviction

**Health:** Health data is not currently available for the ward. Gentle exercise sessions continue to be successful following funding secured from Decade of Better Health by Wollaton Park estate Over 50's Coffee Morning group supported by WELA NDO. These have attracted old and new members to the group and are already having a positive impact on citizens' health. Sheila Roper Community Centre are currently exploring the possibility of offering gentle exercise and a variety of dance classes.

#### For The Year April 2013 - March 2014

**Crime:** During April 2013 - March 2014 (compared withApril 2012 - March 2013) all crime in the Wollaton East and Lenton Abbey Ward increased by 12% (53 crimes) in criminal damage, dwelling burglary, thefts with the majority being of bikes from the University and ASB. Please see detailed breakdown. The rate for all crime per 1,000 of population in the WELA ward is the 2<sup>nd</sup> lowest across the 20 wards. There is a slight reduction in violence for the ward for the Year.

**ASB**: ASB increased by 14% by 19 incidents. The Ward has the 2<sup>nd</sup> lowest rate per 1,000 of population of the 20 wards across Nottingham.

**Domestic Violence Crimes:** 33incidences for 2013-2014 with an increase of 6 (22%) from previous year to date.

**Fire:** Incidents of Fire are low in the ward, ranking the 2<sup>nd</sup> lowest for All Fires with 8 (property and secondary) out of 20 wards across Nottingham.

**Community Protection:** There are no Fixed Penalty Notice (FPN) data available.

**Cleanliness** of the Ward has shown a steady increase over the year with the highest score being at 96 and well above the 'neighbourhood as clean as the city centre' benchmark target of 86%. There has been a steady decrease across the first 3 quarters of **Graffiticompared** to last year's figures for the same period but a recent spike in the last quarter across the Ward.

**Fly Tipping** across the Ward has increased slightly in each quarter across the year in comparison to the same period last year.

The ward is currently experiencing a spike in **Dog Fouling** reporting but this may be due to the recent 'See It Report It' targeted door to door Campaign by Community Protection covering the worst roads in Wollaton Park estate.

**Unemployment:**Is decreasing steadily across the ward during the year in comparison to the same period last year. The ward has the lowest unemployment rate in the City.

#### **Key Successes:**

Lenton Abbey Park Bowling Green Development Community Consultation – xxresidents both children, young people and adults completed the questionnaires during January to March as outlined in the Ward Performance tables giving valuable insight into additional suggestions and improvements to the development of the park. These will be analysed and discussed by Ward Councillors, NDO and LARA with Parks and Open Spaces to plan a way forward. The Park has continued to win Green Flag status again this year.

Alleyways Day Of Action in Lenton Abbey to address some of the longstanding issues with shared ownership alleyways.—This was a very successful partnership with Locality Management, NCH, City Services and Community Protection working to clear 10 alleyways before and on 17<sup>th</sup> March. NDO, NCHand Ward Councillors had a stall outside the Shops on Woodside Road, Lenton Abbey engaging with residents on Lenton Abbey Residents Association, local issues and Tenants Academy and consulting with citizens on Lenton Abbey Park proposals.

**Wollaton Park Residents Association Open Meeting** with speaker Paddy Tipping, Police and Crime Commissioner was well attended on 16<sup>th</sup> April by Wollaton Park estate residents asking questions regarding local policing and PCC priorities. Valuable community consultation work was undertaken by the HMO Team and Sustrans at the meeting.

**Sheila Roper Community Centre** – The Community Association with NDO support has been successful in securing external funding for a cooker and cooking equipment for use in the newly refurbished kitchen. The Youth Club are revitalising their programme and space and with other groups are looking forward to starting

new cooking activities at the centre. The Association are hoping to start other new health activities to help reduce obesity, CVD etc. University of Nottingham student volunteers have been invaluable in supporting the Caretaker in refurbishing the store room to create improved storage and a quiet space for young people. They are currently developing a homework corner.

**Highfields Park Development Plan Community Consultation** –for the next round of their Lottery bid is underway. Plans are now available to view and comment online and at a variety of community consultation events which are plannedthroughout Lenton Abbey, Highfields and Dunkirk during April- June 2014.

**Neighbourhood Transformation Plans** –detailed Action Plans on alleyways and old allotment sites in Lenton Abbey are currently being developed and implemented with Ward Councillors, NCH, CPO's, CP Enforcement, City Services and Allotments Service and Community Payback partners. These Action Plans and Gateway To Nottingham Plans have also been drawn up andwill be monitored through the Neighbourhood Action Team meetings.

Hawton Spinney Maintenance and Development Plan and Community Planting events- are well underway to being fully realised with 2 planting events on Hawton Spinney and community planting events on Orston Spinney and Orston Green on 3rd April and 1<sup>st</sup> May with pupils from Bluecoat Academy and Wollaton Park citizens/residents supported by City Services and Park and Open Spaces. Planting of woodland flowers, berries, nuts and flora are supporting the 'BEE Friendly Nottingham' Campaign. Plants, trees and shrubs were funded by WELA Ward Councillor budgets.

**Area Capital and Public Realm Funds** – Fencing and gating agreed at the last Area 7 Committee in February are now installed. New signage, fencing/ gating and new tree planting are currently being planned.

#### Issues:

Ongoing issues with parking both in Lenton Abbey and Wollaton Park estate due to street design. The first Phase of the Experimental Traffic Restriction Order (TRO) in Lenton Abbey is having an impact with effective enforcement which has stopped people from parking on the grass verges in the restricted zone on Woodside Road. This will stop further damage to the grass verges. Further detailed development work, review and problem solving will be ongoing with Traffic Management and Highway Services consulting with NCH and other partners to formulate proposals for possible further Phases of the TRO in Lenton Abbey.

Detailed proposals for a Residential Parking Scheme in Wollaton Park estate are currently in the formal community consultation phase.

Burglary and cycle theft have increased over the last 6 months but the Neighbourhood Police Beat Team have responded with swift action and successful local operations resulting in arrests and suspects being charged.

#### **Events:**

During this quarter a range of events and meetings have and are due to take place including TRA's and Local Action Group (LAG) meetings, Sheila Roper Community Centre Management Committee, LAFFDA (planning for Lenton Abbey Fun Day),

Community Meetings, Wollaton Park Resident Association local issues meetings. Working in partnership with TRA's and NCH there will be some development work to increase resident and tenant involvement in local groups to enable continued participation and representation following the change in Tenant Panels.

The NAT (Neighbourhoo Action Team) which has representation of various key service providers across the Ward are currently delivering on the revised and refreshed Ward priorities. There has been strong partnership working with Neighbourhood Services, NCH, Community Protection and City Services on patch operations on cleansing, alleyways and enforcements which have proved very effective especially problem solving the shared ownership alleyways issues and implementing Days of Action. There are still ongoing cleansing challenges with student HMO's at the end of term but the additional HMO registration in Wollaton Park estate should improve contact with HMO landlords. Recently have had a variety of speakers from Sustrans and Student Strategy.





- The WELA ward has a growing diverse community in Lenton Abbey with 74% white British and 6% other white some of whom have English as another language and others of mixed heritage, Black British and Caribbean and Asian origin. The 2012 Insight and 2010 ONS statistics are slightly skewed by the transient student population mainly studying at University of Nottingham.
- Wollaton Park estate has a hidden community of disabled children, young people and older adults and due to caring responsibilities have pockets of fuel poverty.
- In the top 10% nationally of SOA's for Crime and Disorder and Income Deprivation affecting children. However reported crime figures have generally fallen across the ward compared to the previous year.
- Wollaton Park estate have seen a growing number of HMO's and are experiencing increasing problems with their landlords.
- Ongoing car parking and traffic issues across the Ward

#### 1. REASONS FOR RECOMMENDATIONS

- 1.1 The Nottingham LTP 2011-2026 maintains a commitment to deliver local transport improvements across Nottingham's Neighbourhoods and prioritises small scale transport improvements of importance to local communities
- 1.2 As part of the budget approved in March 2011, Nottingham City Council approved an LTP capital allocation of £2.5 million Citywide between 2011 -2013. As part of the budget approved at Full Council on 4<sup>th</sup> March 2013 Nottingham City Council approved an LTP capital allocation of £2.5 million Citywide between 2013 -2015. In addition for 2013-2014 and 2014-2015 a Public Realm General Fund has been approved of £750,000 Citywide.
- 1.3 To give opportunity for the Area Committee to make comment on suggested schemes and their progress.

#### 2. BACKGROUND (INCLUDING OUTCOMES OF CONSULTATION)

- 2.1 The Area Capital Programme was established to improve the environment of the neighbourhoods and to create a sense of place for residents in order to improve the quality of life of local people. Since it was established in 2006 to meet the then corporate priority of "Transforming Neighbourhoods" the Area Capital Fund has included a total programme expenditure portfolio of £40 million. The improvements that have been carried out to date using this programmed have included footpath, fence, visual enhancements to public realm, refurbishment of parks and improvements to public buildings.
- 2.2 Resources are allocated from the Nottingham City Council general fund, the Local Transport Plan (LTP) and from the Housing Revenue Account. To achieve a joint approach to environmental improvements in neighbourhoods, a greater degree of flexibility has been established to prioritise and deliver improvements so that there is a synergy in local solutions for local issues across neighbourhoods.
- 2.3 The programme of works is a rolling programme. There have been instances where schemes are started, with strong community involvement and interest, only to be altered at a later stage due to changing circumstances such as economic conditions and changes in land values.
- 2.4 The Area Committee, particularly community representatives, are invited to comment specifically on those schemes identified in the proposals column and also to consider whether certain schemes can be linked to other programme of work in order to generate best value and create a greater impact on the local area.
