21 <u>FLIRTZ, 26A FRIARY CHAMBERS, FRIAR LANE, NG1 6DQ -</u> APPLICATION FOR RENEWAL OF SEX ESTABLISHMENT LICENCE

The Committee considered a report of the Corporate Director of Communities regarding an application for the renewal of a Sex Establishment licence for the premises known as Flirtz.

Philip Thompson and Amanda Town, Alljay Leisure Limited, attended the meeting.
